Report on Race Meeting held at Mount Gambier Racecourse

TRACK: **Soft 7** (Rain affect track that will chop out)
Heavy 8 (Downgraded at 10.51 am) (Rain affected track that horses will get into)
Heavy 9 (Downgraded at 12.24 pm retrospective to Race 1) (Wet track getting into a squelchy area)
Heavy 10 (Downgraded at 3.04 pm retrospective to Race 6) (Heaviest category track, very wet towards saturation)

RAIL: Out 4 metres 1000 metres to 500 metres, 3 metres 500 metres to winning post, True remainder

WEATHER: Overcast

RACE 1: FINN'S FINE FOODS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

NERO TO HERO (C. Puls) - laid in from the 500 metres. In the vicinity of the 50 metres was inconvenienced by NIGHT RHYTHM, which shifted out.

RUNNING THE RITZ (S. Fawke) - slow into stride.

RACE 1: FINN'S FINE FOODS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres (Cont'd)

I WON'T DO THAT (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

GOLDKIND (J. Potter) - a post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer Ms J. Baker was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

MAGIC WISHES (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

NIGHT RHYTHM (K. Bishop) - laid in from the entrance to the straight. In the vicinity of the 50 metres shifted out and inconvenienced NERO TO HERO.

RACE 2: SCOTT GROUP OF COMPANIES BENCHMARK 72 HANDICAP - 1200 metres

SOUL FIRE (J. Chau) - raced keenly in the early and middle stages of the event. In the vicinity of the 900 metres shifted in and inconvenienced SAVE ME NED. Rider was reprimanded and advised to take greater care to ensure he was sufficiently clear when shifting ground in future.

SAVE ME NED (R. Clark) - in the vicinity of the 900 metres whilst being restrained, shifted in and away from the heels of SOUL FIRE, which shifted in.

CANNY MOVE (K. Crowther) - in the vicinity of the 900 metres was obliged to be steadied away from the heels of SAVE ME NED, which shifted in while being restrained. Laid in, in the straight.

MONTRE (S. Logan) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: TAB / SABOIS MAIDEN PLATE - 900 metres

The start of this event was delayed approximately three minutes.

I WAG SCHOOL (K. Bishop) - laid out from the entrance to the straight.

PLEASE RISE (J. Maund) - rider pleaded guilty to a charge under AR131(b) in that he failed to ride his mount out to the finish and was fined \$500. In determining penalty, Stewards could not be entirely satisfied that his actions affected the placings.

IBANEZ (S. Logan) - underwent a pre-race veterinary examination as the mare had not raced in over 12 months and passed fit to race.

NOVEMBER GALE (R. Clark) - bumped on jumping away.

VON SAGA (J. Chau) - jumped away awkwardly, shifted in bumping NOVEMBER GALE. Raced greenly throughout the event. In the vicinity of the 300 metres shifted in in the vicinity of the 100 metres shifted in onto the heels of I WAG SCHOOL, which was obliged to be straightened. Trainer advised a warning had been placed on the mare. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: DISTRICT COUNCIL OF GRANT / SABOIS MAIDEN PLATE - 1200 metres

GALAXY GLEN (J. Potter) - jumped away awkwardly and shifted out.

JOHN THE RODENT (D. Tourneur) - Stewards acceded to a late gear request from Trainer Mr J Frew to have a cross over band nose fitted and was fined \$200 under AR206(2) for the late gear change.

RACE 4: DISTRICT COUNCIL OF GRANT / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

SCALLYWAG (R. Clark) - on jumping away shifted out and away from GALAXY GLEN and as a result was slow into stride. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

NJORD (J. Maund) - jumped away slowly. Raced keenly in the middle stages of the event.

DISCO INFERNO (S. Logan) - A post-race veterinary examination revealed no visible abnormalities.

RACE 5: CITY OF MOUNT GAMBIER / SABOIS MAIDEN PLATE - 1400 metres

KENYA LION (K. Bishop) - acting on confirmed advice from Trainer Mr J McArthur that the gelding had an elevated temperature and would be unfit to race. Stewards declared KENYA LION to be a late scratching at 9.02 am.

MILEY'S MAN (K. Crowther) - in the vicinity of the 100 metres was inconvenienced by GOZZO, which shifted in.

BROTHER NED (J. Chau) - laid in, in the straight.

GOZZO (D. Tourneur) - laid in, in the straight. In the vicinity of the 100 metres shifted in and away from BROTHER NED despite the efforts of its rider and inconvenienced MILEY'S MAN.

HASTA LA WAR (S. Fawke) - jumped away slowly. Rider reported the gelding raced greenly throughout the event.

COMMANDING STYLE (R. Clark) - jumped away awkwardly and shifted out. In the vicinity of the 600 metres commenced to give ground. A post-race veterinary examination revealed no visible abnormalities.

MIDORI ROCKS (C. Puls) - from the entrance to the straight became awkwardly placed on the heels of COMMANDING STYLE for a short distance.

RED MONEY (NZ) (S. Logan) - approaching the 400 metres was obliged to be steadied when improved onto the heels of ELMO RULZ.

BEAR ARMS (E. Boyd) - approaching the 600 metres until the 500 metres became awkwardly placed on the heels of COMMANDING STYLE, which commenced to weaken.

GOOD TO DREAM (R. Hurdle) - jumped away awkwardly and as a result was slow to begin.

ELMO RULZ (A. Lindsay)- from the vicinity of the 600 metres until the 400 metres became held up when awkwardly placed on the heels of NEEKZ, which commenced to give ground.

RACE 6: THE PRODUCE STORE BENCHMARK 56 HANDICAP - 1200 metres

MASHAHEER (A. Lindsay) - laid in, in the straight.

TOORAK ROAD (S. Fawke) - jumped away awkwardly. Laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MISS RITZIANO (K. Crowther) - rider explained from the vicinity of the 300 metres, the mare did not feel comfortable in its action and for that reason did not ride MISS RITZIANO out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

KALEB WILL DO (L. Neindorf) - slow into stride.

RACE 7: CARLTON DRAUGHT BENCHMARK 60 HANDICAP - 1800 metres

LOCAL MISTRESS (K. Crowther) - commenced to give ground from the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

TZAREVNA (S. Logan) - inside the 700 metres shifted in tightening the running of FREE THE WIND. Rider severely reprimanded and advised to only shift ground when entitled to do so.

FREE THE WIND (J. Chau) - inside the 700 metres obliged to be steadied and altered course when tightened for room between TSAREVNA, which shifted in and LOCAL MISTRESS.

RACE 8: - FESTIVAL HIRE BENCHMARK 60 HANDICAP - 1400 metres

PEWTER (C. Puls) - inside the 900 metres shifted in tightening the running of HALCYON. Rider reprimanded and advised to make a greater effort to straighten her mounts when the commence to shift in, in future.

TIMOR GOLD (J. Potter) - A post-race veterinary examination revealed no visible abnormalities.

BOOGIE WOOGIE (J. Huxtable) - Trainer Mr P. Ryan was advised a warning was placed on the gelding. When questioned regarding the tactics, rider explained he was instructed by his trainer to be positive on the gelding in the early stages and maintain a moderate pace throughout the race, as in his opinion, BOOGIE WOOGIE did not have the ability to sit and sprint. He added that after beginning well was able to take up a position in the lead and was unaware of the gap he had placed on the remainder of the field. He further added that from the vicinity of the 600 metres his mount began to weaken in the heavy track conditions. Stewards noted his explanation but reminded him to have greater awareness on where his mounts are placed in relation to the field to give his mounts the best chance of finishing off. Rider was also advised to ride his mounts out to the finish. A post-race veterinary examination revealed no visible abnormalities.

DIAMOND ARROW (S. Fawke) - jumped away awkwardly and as a result was slow into stride. Rider was found guilty of a charge under AR132(6)(c) for using his whip when out of contention and was reprimanded.

HE'S THE BOMB (R. Clark) - rider reported the horse was making respiratory noise on pulling up. A post-race veterinary examination revealed no visible abnormalities.

ZEZE ULATER (K. Crowther) - inside the 900 metres was obliged to be steadied and shifted out and away from the heels of HALCYON, which was taken in.

HALCYON (J. Maund) - raced keenly in the early and middle stages of the event. Inside the 900 metres tightened onto ZEZE ULATER by PEWTER.

TILLRAIDER (A. Lindsay) - underwent a pre-race veterinary examination as it had not raced in the past 12 months and passed fit to race.

SIR CHATALOT (L. Neindorf) - jumped away awkwardly and shifted in. Laid out in the straight.
