### CONDITIONS GOVERNING OFFICIAL S.A.J.C., O.R.C. AND PROVINCIAL BARRIER TRIALS

- Trials to be conducted under the supervision of Stipendiary Stewards.
- No horse shall take part under any but the correct registered name and a stable return must be lodged prior to the closing time of entries.
- Only Jockeys and Apprentices will be permitted to ride in Trials.
- Every rider shall wear the colours as stated on the Horse's Stable Return.
- Flat Trials in the Metropolitan area commence at 9:00 AM (unless otherwise advised) irrespective of whether there is a Hurdle Trial. Approximately 15 minutes between trials. Trials in the Provincial Area to commence at 9.00 AM (unless otherwise advised).
- Trainers **MUST** confirm riders at Acceptance or Secretary's Office before the running of the previous Trial or half an hour before the first Trial or horse may be withdrawn by Stewards.
- Nominations for all Trials close with the Trainers Service Centre (TSC) on 1800 138 704 or online via StableAssist at [www.risa.com.au](http://www.risa.com.au)
- No horse may be substituted for one originally nominated.
- Fields will not be altered following their finalisation without the Stewards permission.
- Any S.A.J.C. Trial may be abandoned if less than five nominations are received excluding two-year-old and hurdle trials wherein four nominations will be required to ensure the trial is conducted.
