RACE 1: TAYLORS WINES / SABOIS PLUS MAIDEN/CLASS ONE PLATE - 2200 metres

DESERT MINTY (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

LORD GREYSON (C. Lions) - raced keenly in the early and middle stages of the event. In the vicinity of the 2000 metres was obliged to be steadied to avoid the heels of GOLDIE GURU, which shifted in.

IKNOW WHERE YOULIV (L. Neindorf) - approaching the 400 metres inconvenienced by STEELCAPSTILETTOS, which shifted out. In the vicinity of the 300 metres was inconvenienced by STEELCAPSTILETTOS, which shifted out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

STEELCAPSTILETTOS (S. Logan) - laid out from the 600 metres and approaching the 400 metres shifted out and inconvenienced IKNOW WHERE YOULIV. In the vicinity of the 300 metres rolled out and inconvenienced IKNOW WHERE YOULIV. Rider reminded of her obligations and to straighten her mounts sooner when they commence to shift ground. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

GOLDIE GURU (J. Holder) - in the vicinity of the 2000 metres shifted in and inconvenienced LORD GREYSON and DESERT MINTY. Rider was reprimanded and to only shift ground when entitled to do so.

RACE 2: 'THE JOCKS PLATE' / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE
- 1200 metres

APPLIED (K. Crowther) - at the entrance to the straight was taken wider by TRUE ILLUSION. Laid in, in the straight. From in the vicinity of the 200 metres hung in placing the rider at a disadvantage for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

STREETS AFTER DARK (C. Lions) - raced keenly in the middle stages of the event. Laid out from the 900 metres taking SPECIAL BOOM wider and becoming unbalanced for a short distance thereafter when racing in restricted room. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr T. Montgomerie, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

TRUE ILLUSION (S. Fawke) - jumped away awkwardly and as a result was slow to begin. Held up from the 600 metres until in the entrance the straight.

SPECIAL BOOM (J. Toeroek) - laid in, in the straight. Approaching the 200 metres shifted in and away from APPLIED. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: WAYNE HENSON CLASS ONE HANDICAP - 1200 metres

The start of this event was delayed approximately three minutes due to ICE HUNT having to be resaddled in the mounting yard.

WITH PLEASURE (A. Jordsjo) - race three wide without cover throughout the event. Rider reported the mare did not finish the race off as well as expected. A post-race veterinary examination revealed no visible abnormalities.

JOHN THE RODENT (S. Logan) - rider reported the gelding never travelled. A post-race veterinary examination revealed no visible abnormalities.

ICE HUNT (L. Neindorf) - jumped away awkwardly and got its head up for a short distance shortly after. Laid in, in the straight. Rider explained that his instructions were to settle better than mid-field but after jumping away awkwardly, which resulted in losing touch with the field in the early stages of the event, he was then able to encourage the gelding to join the back of the field and from the 800 metres, he stayed close to the rail and rode for luck. He added that at the entrance to the straight, he opted to take a run to the outside of AUGUSTA ROCK as he believed he was not travelling well enough to attempt a run to its inside. He further added in the vicinity of the 300 metres he attempted a run to the outside of JOHN THE RODENT and was unable to do so as ICE HUNT laid in across the heels of that gelding.

HEART LIKE MINE (G. Lo) - jumped away awkwardly.

RACE 4: HAROLD LANE / SABOIS MAIDEN HANDICAP - 1600 metres

KING SLIM (J. Toeroek) - raced three wide throughout. Laid in from the entrance of the straight until the 200 metres. Laid out over the final 100 metres.

PLYMPTON (D. Tourneur) - accidentally dropped his whip in the vicinity of the 200 metres.

STAYING STRONG (J. Chau) - shortly after the start lost its position when tightened for room between TICKET TO TEXAS, which was taken in and PAY THE MAN.

SUCCEEDANDCONQUER (S. Logan) - difficulty obtaining clear ground from the 500 metres until the 400 metres. Approaching the 200 metres raced in restricted room for a short distance to the inside of SMILING ASSASSIN, which rolled in.

RACE 4: HAROLD LANE / SABOIS MAIDEN HANDICAP - 1600 metres (Cont'd)

TICKET TO TEXAS (M. Collett) - bumped on jumping away by KRUPTONITE and taken in. Raced with its head up for a short distance thereafter. Laid out from the 600 metres until the 400 metres and laid in thereafter. Approaching the 50 metres shifted in and across the heels of KRUPTONITE and was obliged to take hold to avoid that filly's heels.

KRUPTONITE (K. Zechner) - jumped away awkwardly, shifted in bumping TICKET TO TEXAS. In the vicinity of the 800 metres became awkwardly placed on the heels of PLYMPTON and was obliged to shift out. Rolled around in the straight and approaching the 50 metres shifted out and away from KING SLIM.

WHIRLWIND ROMANCE (K. Crowther) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: COOPERS ADELAIDE PLAINS CUP / SABOIS FILLIES & MARES RATING 0-58 HANDICAP - 1200 metres

SETTLE THEN LIFT (R. Hurdle) - hung out until the 400 metres. Inside the 1000 metres shifted out taking FAY'S JOY wider on the track until in the vicinity of the 400 metres. Laid in, in the straight. Trainer Mr B. Holtham advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed abrasions outside the near hind cannon.

FAY'S JOY (J. Holder) - inside the 1000 metres taken wider on the track by SETTLE THEN LIFT and was obliged to race wide thereafter.

WICKED SCANDAL (K. Bishop) - slow into stride. Laid in, in the straight.

TILBURY (C. Lions) - rider reported the mare travelled well until inside the 200 metres where the mare changes stride and lost its action. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: MY BUTCHER BENCHMARK 54 HANDICAP - 1050 metres

RITORNO (L. Neindorf) - jumped away awkwardly and as a result was slow into stride. Laid in, in the straight.

VALLIANO (G. Lo) - laid in, in the straight. Rider reported the gelding was inclined to lay out until the entrance to the straight and laid in until the finish.

CAN STAR (J. Chau) - jumped away awkwardly, shifted out and from the 700 metres laid out. Rider explained the mare travelled well in the early and middle stages, however hung out rounding the home turn and did not finish the race off as expected. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: KELLY HENSON BENCHMARK 54 HANDICAP - 1400 metres

AUSTIN RAIDER (D. Tourneur) - raced keenly in the early and middle stages of the event.

HEROES QUEST (K. Zechner) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

TURFONIC (J. Holder) - jumped away awkwardly and shifted out and approaching the 800 metres laid out until the 700 metres.

TYCOON FLUTTER (NZ) (C. Lions) - underwent a pre-race veterinary examination and passed fit to race. Laid out from in the vicinity of the 800 metres until the 700 metres.

RACE 7: KELLY HENSON BENCHMARK 54 HANDICAP - 1400 metres (Cont'd)

HE'S GOT SKILLS (E. Finnegan) - jumped away awkwardly and as a result was slow into stride.

OUR FREEBIE (M. Henderson) - slow to begin.
