STIPENDIARY STEWARDS' REPORTReport on Race Meeting held at Morphettville Parks Racecourse

TRACK: Good 4

(Track with some give in it)

RAIL: Out 8 metres from 1000 metres to winning post, out 5 metres remainder. Sectional 610 metres.

WEATHER: Fine

RACE 1: ADELAIDE GALVANISING HANDICAP - 1000 Metres

STATE OF CLASS (D. Caboche) - a post-race veterinary examination revealed the gelding to be lame in both forelegs. Trainer Mr P. Rocke was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

KORUTO (K. Crowther) - jumped away awkwardly. Raced greenly during the event. Inclined to lay out over the concluding 600 metres. A post-race veterinary examination revealed no visible abnormalities.

MARCHENA (L. Neindorf) - raced keenly in the middle stages of the event.

DISTILLATE (T. Pannell) - Stewards permitted T. Pannell to ride the filly 0.5 kg over its declared weight of 54.5 kg. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 250 metres. Laid out under pressure for the remainder of the event.

RACE 2: FURPHY HANDICAP - 1000 Metres

RUBY'S REWARD (J. Chau) - shifted out on jumping away onto GOOD LUCK CHUCK. Inclined to lay out under pressure in the straight.

YANKEE LOU (K. Crowther) - jumped away awkwardly.

SUNRISE DANCER (J. Toeroek) - raced keenly in the early and middle stages of the event.

POYSED TO REIN (P. Gatt) - jumped away awkwardly. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres. Laid out over the concluding stages.

FABULOUS FLIPPER (J. Maund) - lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: FURPHY HANDICAP - 1000 Metres (Cont'd)

GOOD LUCK CHUCK (J. Holder) - inconvenienced on jumping away when taken wider by RUBY'S REWARD.

RACE 3: TAB HANDICAP - 1400 Metres

EXALTED DEE (J. Chau) - shortly after the start was hampered when A KNIGHT IN PARIS was taken out into its running line.

RIKIBOBBY (T. Voorham) - jumped away awkwardly and shifted out onto FLYING PIERRO.

FLYING PIERRO (L. Neindorf) - inconvenienced on jumping away.

A KNIGHT IN PARIS (A. Tomita) - slow to begin. Shortly after the start was hampered when REGAL CROWN was taken out into its running line.

GOUGERS (A. Jordsjo) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

LA RICHESSE (C. Jones) - jumped away awkwardly and shifted in bumping AUSTIN RAIDER. A post-race veterinary examination revealed the filly to be lame in the near hind leg. Trainer Mr W. Clarken was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

MOVANDI (S. Cahill) - contacted on jumping away by REGAL CROWN. Shortly after the start shifted back out onto that gelding.

SIR JOHNSON (E. Finnegan) - raced wide without cover throughout the event.

REGAL CROWN (S. Fawke) - jumped away awkwardly and shifted in onto AUSTIN RAIDER. Shortly after was taken back out by that gelding into the running line of A KNIGHT IN PARIS. Raced keenly in the early and middle stages of the event.

AUSTIN RAIDER (T. Pannell) - contacted on jumping away.

RACE 4: 36° SOUTH BEEF HANDICAP - 1250 Metres

SAND CAT (C. Lions) - shifted out on jumping away onto UNDESIRE. Raced keenly in the early and middle stages of the event. At the entrance to the straight became awkwardly placed on the heels of SOCIAL MEDIA for a short distance as that mare commenced to weaken. Inclined to lay out under pressure in the straight.

FERGIE (J. Maund) - raced wide without cover throughout the event.

UNDESIRE (L. Neindorf) - hampered on jumping away when tightened between AMBIBELLA, which shifted in at the same time as SAND CAT shifted out. A post-race veterinary examination revealed no visible abnormalities.

AMBIBELLA (C. Puls) - shifted in on jumping away onto UNDESIRE.

SHINING BRIGHTLY (D. Tourneur) - jumped away awkwardly. Laid out under pressure in the straight.

RACE 5: CHAD HANCOCK FOUNDATION HANDICAP - 2250 Metres

CLASSIC WEIWEI (T. Pannell) - rider explained the gelding travelled well in the early and middle stages of the event and when placed under pressure in the vicinity of the 500 metres, he felt that it was the winner. He added that over the concluding stages CLASSIC WEIWEI was disappointing and in his opinion, may not have run out the trip.

GREYCLIFFE (NZ) (E. Finnegan) - laid out under pressure over the concluding 200 metres.

TURF MAN (J. Holder) - contacted on jumping away.

CAUSE WE CAN (C. Puls) - shifted out on jumping away brushing TURF MAN.

COBBERS MATE (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

BLINKY O'REILLY (S. Logan) - raced fiercely in the early and middle stages of the event. Rider explained the gelding went too hard in the early and middle stages despite her efforts and had only settled in the vicinity of the 1200 metres, when it was provided cover as COBBERS MATE improved to take the lead. A post-race veterinary examination revealed a poor recovery.

RACE 6: AAMI HANDICAP - 1250 Metres

KINGSGROVE (S. Logan) -contacted in the vicinity of the 200 metres by OH MO.

OH MO (D. Tourneur) - shifted out on jumping away onto KONIGSBERG. Shifted out slightly to improve in the vicinity of the 200 metres and brushed KINGSGROVE. Rider was questioned in relation to returning to scale under the weight in which he had weighed out. Acting under AR53(3)(b) rider was allowed 0.5 kg by the Clerk of Scales and correct weight was declared. Rider could offer no firm explanation for the reason in which he returned to scale light, however, Steward issued a severe reprimand under AR209(2)(b) in relation to him failing to carry the correct weight.

HIGH MIST (T. Pannell) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

TRIPLE DEEZ (J. Holder) - rider reported the gelding did not respond when asked for an effort. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr D. Magro was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

BOLEK (S. Fawke) - raced keenly in the early and middle stages of the event.

KONIGSBERG (A. Jordsjo) - hampered on jumping away when tightened onto KINGSGROVE. Laid out under pressure in the straight. Rider reminded of her obligations under AR132(6)(c) when using her whip when her mounts are out of contention. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Ms K. Jackson was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

LIPPSY SHUFFLE (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: ADELAIDE FESTIVAL OF RACING 2-16 MAY HANDICAP - 1550 Metres

The start of this event was delayed approximately 10 minutes.

OUR DEEP AGENDA (T. Pannell) - contacted on jumping away. A post-race veterinary examination revealed no visible abnormalities.

PUISSANCE DUSOLEIL (P. Gatt) - shifted out on jumping away onto PARTY HACK.

RACE 7: ADELAIDE FESTIVAL OF RACING 2-16 MAY HANDICAP - 1550 Metres (Cont'd)

ROBE BAY (T. Voorham) - refused to load. A late scratching by order of Stewards at 4.40 pm. Trainer Mr P. Hardacre was advised the filly would be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

JACK'S A CRACKER (S. Logan) - lost its near fore plate en route to the barrier and required Farrier attention. Underwent a pre-race veterinary examination and passed fit to race.

PARTY HACK (J. Maund) - inconvenienced on jumping away.

PICCATRIC (A. Tomita) - rider explained that his instructions were to lead however, after SOWPODS improved to his outside, the filly over-raced and extended its lead on the field despite his efforts and commenced to weaken from the event in the vicinity of the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

SHEZA LITTLE POSH (J. Holder) - shifted out on jumping away and bumped OUR DEEP AGENDA. Rider reported he was concerned with the filly's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

SOWPODS (K. Crowther) - rider explained after pushing forward from a wide barrier, the gelding raced fiercely despite her efforts and had improved to a position outside PICCATRIC, which was far further forward than she had hoped. She added in her opinion, the gelding may have raced fiercely and had not responded due to it having blinkers back on again, for this event. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: FLEURIEU MILK COMPANY HANDICAP - 1300 Metres

HUSSYBAY (A. Jordsjo) - raced wide without cover throughout the event. Laid out over the concluding 600 metres.

ZALMONA (P. Gatt) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

NIPPERKIN (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

HANDSOME RETURN (NZ) (T. Pannell) - Stewards permitted T. Pannell to ride the filly 0.5 kg over its declared weight of 54.5 kg. contacted on jumping away.

ETHICAL SOLUTION (J. Toeroek) - raced keenly in the early and middle stages of the event.

LITTLE AKIE (J. Maund) - underwent a pre-race veterinary examination and passed fit to race.

EXCELTARA (E. Finnegan) - raced keenly in the early and middle stages of the event.

REALLY DISCREET (L. Neindorf) - shifted out on jumping away and bumped HANDSOME RETURN (NZ).

RACE 9: M&J CHICKENS HANDICAP - 1550 Metres

LIEDER (S. Cahill) - hampered on jumping away. Rider reported the gelding was awkward in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

SHROUDED IN MIST (L. Neindorf) - taken out on jumping away onto LIEDER. A post-race veterinary examination revealed no visible abnormalities.

FRANCE'S BOY (K. Crowther) - raced keenly in the early and middle stages of the event.

RACE 9: M&J CHICKENS HANDICAP - 1550 Metres (Cont'd)

WANTED BY ALL (D. Caboche) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

CAZABILLIE (T. Pannell) - Stewards permitted T. Pannell to ride the filly 0.5 kg over its declared weight of 54.5 kg. CAZABILLIE Returned to scale with blood in its mouth. A post-race veterinary examination revealed no visible abnormalities.

ICE GHOST (J. Holder) - shifted out on jumping away onto SHROUDED IN MIST.
