**RACE 1: FURPHY HANDICAP - 1250 Metres**

**FERUS** (D. Caboche) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Co-Trainer Mr C. Maher was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**JACOBITE PRINCE** (J. Holder) - raced keenly in the early stages of the event. Inclined to lay in, in the early part of the straight and thereafter, over the concluding stages raced greenly. Rider explained the gelding travelled well in the early part of the event however, was under pressure from near the entrance to the straight and was disappointing in the manner in which it finished the event off. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**HANKSTAR** (L. Neindorf) - awkward to begin, shifted out and contacted MAGIC DEE.

**KAARCHI** (T. Pannell) - rider reported the filly felt sore on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**LADY PAVLI CHENKO** (J. Potter) - had difficulty obtaining clear running from approaching the entrance to the straight until near the 200 metres.

**MAGIC DEE** (C. Lions) - contacted at the start. Raced wide without cover in the middle stages of the event.

**WICKED SCANDAL** (K. Crowther) - held up for a short distance approaching the entrance to the straight. Laid out in the straight.

### **RACE 2: METAL-LINK HANDICAP - 1550 Metres**

**WANTED BY ALL** (D. Caboche) - raced keenly in the early stages of the event.

**DESIDERO** (J. Holder) - inclined to lay out over the concluding stages.

**HEIR OF TAVISTOCK** (NZ) (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**MANZALA** (R. Hurdle) - underwent a pre-race veterinary examination as it had not raced since May 2019 and was passed fit to race.

**SKILLFUL STEPS** (L. Neindorf) - laid in, in the early part of the straight. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 3: TAB HANDICAP - 1000 Metres**

The start of this event was delayed approximately two minutes.

**DASH TO COURT** (K. Zechner) - raced greenly during the event. A post-race veterinary examination revealed no visible abnormalities.

**ECUMENICAL** (A. Jordsjo) - very awkward to begin, shifted out and contacted NALEIGH. From in the vicinity of the 700 metres raced greenly, was inclined to lay in for some distance and thereafter raced greenly in the straight. Rider reported the filly raced greenly during the event. A post-race veterinary examination revealed no visible abnormalities.

**ICHIBANSAN** (J. Holder) - raced keenly in the early stages of the event.

**KORUTO** (E. Finnegan) - a late scratching by order of Stewards at 7.35 am owing to Trainer Mr P. Stokes having difficulty making contact with the Trainers Service Centre to declare his scratching prior to 7.30 am.

**ENAAYA** (J. Toeroek) - raced greenly and shifted ground both ways in the straight. Rider reported the filly raced greenly in the straight.

**NALEIGH** (T. Pannell) - tightened at the start between ECUMENICAL and LADY DUNMORE, which both shifted ground. Held up for a short distance shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**NO FILTER** (D. Caboche) - contacted at the start. Approaching the 400 metres was obliged to race in restricted room between ICHIBANSAN and ENAAYA for a number of strides and was inconvenienced. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**STREETS OF PHILLY** (P. Gatt) - awkward to begin, shifted in and contacted NO FILTER. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Co-Trainer Mr C. Maher was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**LADY DUNMORE** (K. Crowther) - very awkward to begin, shifted in and contacted NALEIGH.

### **RACE 4: HOLDFAST INSURANCE MAIDEN PLATE - 1300 Metres**

**OUR JOURNEYMAN** (S. Logan) - laid out under pressure over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**PROVOCATIVE MAN** (J. Potter) - laid out under pressure over the concluding stages.

**RACE 4: HOLDFAST INSURANCE MAIDEN PLATE - 1300 Metres (Cont'd)**

**JIMMY WITHA DASH** (T. Pannell) - awkward to begin, shifted out and contacted DALAKARA. Shortly thereafter shifted back in onto KATE'S VALLEY, which was hampered.

**SKILLED WIZARD** (K. Zechner) - raced very ungenerously for some distance until in the vicinity of the 900 metres.

**KATE'S VALLEY** (K. Bishop) - hampered shortly after the start and was unable to maintain its position when tightened by JIMMY WITHA DASH.

**CHOKITA** (D. Tourneur) - approaching the entrance to the straight shifted out to improve and hampered DYNAMICE BELLE, which had to be steadied. Rider reprimanded and advised to take greater care when shifting ground in future.

**DALAKARA** (P. Gatt) - awkward to begin. Shifted in and contacted JIMMY WITHA DASH. Inclined to lay in, in the straight.

**DYNAMIC BELLE** (A. Jordsjo) - approaching the entrance to the straight was obliged to be steadied as CHOKITA shifted out to improve.

**RACE 5: ADELAIDE FESTIVAL OF RACING 2-16 MAY HANDICAP - 1000 Metres**

**MIHANY** (E. Finnegan) - held up for clear running from near the entrance to the straight until approaching the 200 metres.

**BRAY STREET BOSS** (C. Jones) - awkward to begin and shortly after the start was hampered by RUSTLE UP, which shifted out and as a consequence was taken wider. Rider reported her saddle slipped back on jumping away, placing her at a disadvantage and resulting in her being unable to fully assist her mount in running. Consequently, she was unable to ride the mount in a competitive manner during the event. A post-race veterinary examination revealed no visible abnormalities.

**HE IS GOLDEN** (J. Holder) - laid out from near the 600 metres until in the vicinity of the 400 metres and as a consequence, became awkward on the heels of runners for a short distance. Shortly after entering the straight was obliged to shift to the outside of the field to obtain clear running. A post-race veterinary examination revealed no visible abnormalities.

**HUSSLIN HUMPH** (P. Gatt) - held up for clear running from near the entrance to the straight until approaching the 200 metres. Thereafter inside the 200 metres was unable to improve into a run between MIHANY and WILANDER PRINCESS and was obliged to shift to the inside of MIHANY over the concluding stages to obtain clear running.

**RUSTLE UP** (L. Neindorf) - awkward to begin, shifted in and contacted PAM'S JOURNEY. Shifted out shortly thereafter and hampered BRAY STREET BOSS. A post-race veterinary examination revealed no visible abnormalities.

**DEVONTE** (A. Jordsjo) - obliged to race in restricted room from near the 700 metres when racing between HUSSLIN HUMPH, which maintained its line and RUSTYDUSTYSUNSHINE, which was inclined to lay in and shifted in. Thereafter was held up from in the vicinity of the 400 metres until near the 200 metres.

**PAM'S JOURNEY** (J. Potter) - contacted at the start and hampered. A post-race veterinary examination revealed no visible abnormalities.

**RUSTYDUSTYSUNSHINE** (D. Caboche) - awkward to begin, shifted out and contacted PAM'S JOURNEY. Raced in restricted room over the concluding stages to the inside of DEVONTE, which rolled in, resulting in D. Caboche being unable to ride his mount out fully to the finish.

**RACE 5: ADELAIDE FESTIVAL OF RACING 2-16 MAY HANDICAP - 1000 Metres (Cont'd)**

**SIDESTREET** (D. Tourneur) - proved very fractious after being loaded in its barrier stall. Underwent a pre-race veterinary examination and was passed fit to race. Awkward to begin and laid out in the early part of the straight.

**RACE 6: AAMI HANDICAP - 1950 Metres**

**MASTER CHUM** (D. Caboche) - raced wide without cover for a short distance near the 900 metres. Rider explained the gelding travelled well in the early stages and after shifting wider from inside the 900 metres to improve his position, whilst the gelding initially responded to his riding, approaching the entrance to the straight, the gelding had come to the end of its run and was disappointing and did not finish the race off in the manner he expected. Following the race rider was examined by the First Care Medical Personnel and was declared unfit to fulfil his remaining engagement. A post-race veterinary examination revealed no visible abnormalities.

**ROSELLI STING** (T. Pannell) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**WICKED RHYTHM** (K. Crowther) - raced very keenly in the early and middle stages of the event and at times raced in an ungenerous manner placing its rider at a disadvantage.

**MASTER OF ZERPRISE** (R. Hurdle) - awkward and slow to begin.

**CHILEAN WONDER** (K. Bishop) - raced keenly in the early and middle stages of the event.

**BUSKER'S BALLAD** (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 7: TERRY HOWE PRINTING HANDICAP - 1250 Metres**

**I AM IMPINGE (NZ)** (S. Logan) - awkward to begin, shifted in and contacted MIDNIGHT STORM. Raced keenly in the early stages of the event.

**MIDNIGHT STORM** (C. Jones) - contacted at the start.

**AMBIDAZZLE** (L. Neindorf) - awkward to begin.

**GAME KEEPER** (J. Toeroek) - Stewards granted permission on 27 March 2020 for this horse to race equipped with blinkers.

**AHMAD** (D. Tourneur) - after being loaded into its barrier stall had to have its noseband adjusted.

**HE WILL BOOM** (E. Finnegan) - after being loaded into its barrier stall had to be removed to have its noseband adjusted.

**QUIET CLASS** (T. Voorham) - raced keenly in the early stages of the event. Raced wide without cover in the early and middle stages of the event.

**MIRACLEOFMIRACLES** (K. Crowther) - held up for clear running from approaching the 400 metres until inside the 200 metres and was obliged to shift out to obtain clear running. A post-race veterinary examination revealed moderate degree of azoturia.

### **RACE 8: SCHWEPPE HANDICAP - 1000 Metres**

The start of this event was delayed approximately four minutes.

**SISSTAR** (L. Neindorf) - awkward to begin, got its head up shortly thereafter, raced very ungenerously for some distance and was inclined to lay out near the 700 metres. Rider reported the filly travelled well in the early stages however, commenced to lay out rounding the turn, was light in its mouth and appeared to resent any corrective action on his part. A post-race veterinary examination revealed no visible abnormalities.

**STAR OF MONSOON** (C. Jones) - held up from the entrance to the strait until inside the 200 metres. Rider explained that shortly after the entrance to the straight, she assessed her options when following TEQUILA TIME, however was held up behind this gelding and was unable to improve to its outside as a consequence of the position of SCHILLDORA to her outside. She added thereafter, as TEQUILA TIME shifted out to improve its position, she made an assessment and considered her options to also shift out, however, did not consider that option would benefit her horse in the run and for that reason initially maintained her line but shortly thereafter, when LI'L KONTRA rolled off the fence, shifted into that run as it presented and finished the race off from inside the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

**MISS JANE** (P. Gatt) - rider was examined by the First Care Medical Personnel and was passed fit to ride. Inclined to lay out in the straight.

**TINTAGEL ROCKER** (S. Logan) - laid out in the straight.

**TIARA STAR** (T. Pannell) - proved very fractious in its barrier stall and contacted the front gate. TIARA STAR had blood appearing from both nostrils after the event. A post-race veterinary examination revealed that the blood from both nostrils was due to external trauma. The mare also had a small laceration to its tongue. Trainer, Mr W. Clarken, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**LITTLE RICH BOY** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**GOODGEE** (A. Jordsjo) - resaddled at the start. Rider reported the mare felt short in its stride in the straight. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 9: ADELAIDE GALVANISING HANDICAP - 1400 Metres**

**SKY PUNCH (NZ)** (S. Cahill) - rolled in at the winning post, shifted in taking DIPLOMATIC MEASURE in onto JOURNICA resulting in both these horses being hampered. Rider reprimanded and advised to ensure he maintains a straight course at all times.

**RHYTHMATIC** (C. Jones) - inconvenienced shortly after the start when taken out and as a consequence shifted out onto EMMY AWARDS, which was hampered when tightened onto SKY PUNCH (NZ). Raced ungenerously for some distance thereafter. Held up for clear running from shortly after the entrance to the straight, was unable to improve its position and was obliged to shift out from in the vicinity of the 200 metres to attempt to obtain clear ground but was unable to obtain a full clear run to improve into and as a consequence was untested to the line. A post-race veterinary examination revealed no visible abnormalities.

**DIPLOMATIC MEASURE** (L. Neindorf) - raced in tight room from near the entrance to the straight between SKY PUNCH (NZ) and JOURNICA and contacted JOURNICA on several occasions.

**RIKIBOBBY** (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

**CLEARY ADONIS** (D. Tourneur) - laid in, in the straight.

**GRABBING GLORY** (K. Crowther) - awkward to begin and shifted out onto EMMY AWARDS.

**RACE 9: ADELAIDE GALVANISING HANDICAP - 1400 Metres (Cont'd)**

**JOURNICA** (J. Holder) - awkward to begin, shifted out and contacted UNSCOPEABLE. Raced in tight room from near the entrance to the straight between DIPLOMATIC MEASURE and RIKIBOBBY and contacted DIPLOMATIC MEASURE on several occasions.

**WILLIAM'S QUEST** (K. Bishop) - shortly after the start was taken out by JOURNICA, which shifted out and as a consequence shifted out onto RHYTHMATIC, which was inconvenienced.

**FEARLESS AL** (S. Logan) - laid in on a number of occasions in the straight.

**UNSCOPEABLE** (J. Toereok) - awkward to begin, shifted in and contacted JOURNICA.

**EMMY AWARDS** (S. Fawke) - hampered shortly after the start and over-raced in the early stages of the event.

Correct weight was delayed to allow L. Neindorf (DIPLOMATIC MEASURE), placed second and Mr J. Cornell representing Trainer Mr T. McEvoy and also J. Holder (JOURNICA), placed fourth and Trainer Mr G. Richards to view the vision in the straight.
