RACE 1: CARBINE CLUB HANDICAP - 2030 Metres

FAROOQ (B. Vorster) - shortly after the start, approaching the 1900 metres rolled out and hampered TURF MAN for several strides. Rider was reprimanded and advised to ensure he keeps his mounts on a straight course when they commence to shift ground. A post-race veterinary examination revealed no visible abnormalities.

WAR TIGER (USA) (J. Allen) - awkward to begin, shifted out and contacted BRAMFIELD. Inside the 100 metres shifted out to improve and hampered TURF MAN, which was taken wider. Rider reminded of his obligations when shifting ground.

BRAMFIELD (T. Pannell) - contacted at the start and taken out. Over-raced in the early and middle stages of the event. Inclined to lay in, in the early part of the straight. A post-race veterinary examination revealed no visible abnormalities.

MAHIS ANGEL (E. Finnegan) - raced wide without cover in the early stages of the event.

TURF MAN (J. Holder) - approaching the 1900 metres was hampered for several strides by FAROOQ, which rolled out. Inside the 100 metres was hampered by WAR TIGER (USA), which shifted out to improve.

DISCO REBEL (K. Bishop) - over-raced in the early stages of the event.

BUSKER'S BALLAD (D. Thornton) - held up for clear running for a short distance near the 500 metres.

RACE 2: M&J CHICKENS NATIONAL STAKES - 1200 Metres

YULE MY HERO (L. Neindorf) - raced wide without cover in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

EXTRA TIME (J. Holder) - rider explained his intention was to settle mid-field behind the speed if possible. He stated the while the gelding stepped away slowly, after encouraging his mount shortly after the start it responded very well and started to race keenly and as a consequence he allowed it to stride forward rather than restrain to settle midfield.

RICHED (C. Jones) - approaching the 1000 metres raced greenly, shifted in abruptly and brushed the running rail for several strides. Thereafter laid in throughout the event.

KAZUHIKO (Z. Spain) - raced greenly and was inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

CAPRICORN RIDGE - a late scratching by order of Stewards at 7.43 am acting on confirmed advice from Trainer Mr M. Seyers that the gelding had an elevated temperature.

DIALA (T. Pannell) - laid out in the straight.

ZOUSHINE (B. Vorster) - shortly after the start, when being restrained, got its head up and commenced to race ungenerously for some distance until near the 800 metres. Rider explained the filly raced keenly during the event. He added his instructions were to obtain cover if possible behind the speed, however as a consequence of his horse racing in the manner it did in the early stages, he settled further back than intended. A post-race veterinary examination revealed no visible abnormalities.

YES BABY YES (J. Allen) - laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

MISS GUGGENHEIM (J. Toeroek) - A post-race veterinary examination revealed no visible abnormalities.

RACE 3: HOLDFAST INSURANCE HANDICAP - 1050 Metres

PLEASANT (L. Neindorf) - laid out over the concluding stages.

MISS LABELLE (T. Voorham) - raced wide without cover throughout the event. Near the 300 metres was inconvenienced by **FREE THRILLS**, which rolled out. A post-race veterinary examination revealed no visible abnormalities.

QUIDDICK (J. Toeroek) - inside the 300 metres shifted in and hampered **SYMPHONETTE** for several strides. Taken wider over the concluding stages.

SYMPHONETTE (K. Crowther) - awkward to begin. Held up for several strides inside the 300 metres between the heels of **QUIDDICK**, which shifted in and **MISS LABELLE**, and as a consequence was obliged to shift to the inside of **MISS LABELLE** to obtain clear running. Thereafter, after improving its position for a short distance, had difficulty obtaining clear running for a short distance approaching the 100 metres before again being obliged to shift in to obtain clear running.

FORTUNE FOLLOWS (T. Pannell) - awkward to begin. Held up for clear running from near the entrance to the straight until approaching the 200 metres.

FREE THRILLS (J. Allen) - near the 300 metres rolled out and inconvenienced **MISS LABELLE**. Taken wider over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: HOLDFAST INSURANCE HANDICAP - 1050 Metres (Cont'd)

DEVONTE (S. Fawke) - shifted out and away from **FORTUNE FOLLOWS** over the concluding stages and as a consequence shifted out onto **FREE THRILLS**, which was taken wider, which in turn shifted out onto **QUIDDICK**, which was taken wider.

RACE 4: SCHWEPPE HANDICAP - 1200 Metres

BAR GEM (E. Boyd) - Trainer Mr. R. Wilkinson advised Stewards prior to the event of a change of tactics, that being that he would instruct his rider to attempt to obtain cover if possible. Re-saddled on arrival at the barriers. Near the 150 metres became awkward between the heels of **RIZSKI**, which rolled out and **I'M A LEGEND** and was obliged to be steadied for a number of strides. Thereafter had to shift out to obtain clear running.

EUGENE'S PICK (NZ) (T. Pannell) - awkward to begin, shifted out and contacted the hindquarters of **LUNAR LIGHT**. Inside the 200 metres became held up for a short distance when racing inside **SUNMATE** and behind **LUNAR LIGHT** and thereafter laid out over the concluding stages.

ELUSIVE NATURE (L. Neindorf) - near the 300 metres when attempting a run between **GRINZINGER EXPRESS (NZ)** and **EXETER** was contacted by **CALYPSO REIGN** as that horse attempted to improve into the same run. Thereafter was held up for clear running from near the 200 metres until near the 100 metres.

LUNAR LIGHT (E. Brown) - awkward to begin and had its hindquarters contacted at the start by **EUGENE'S PICK (NZ)**, which began awkwardly. Was unable to be fully tested over the concluding stages when racing behind **HEARTY LASS**.

HEARTY LASS (G. Cartwright) - raced keenly in the early and middle stages of the event.

RIZSKI (P. Gatt) - rolled out near the 150 metres and inconvenienced **BAR GEM**.

STRAGUN (T. Voorham) - was eased out of the event from near the 200 metres and inside the 100 metres, the gelding collapsed after its rider dismounted. A post-race veterinary examination revealed the gelding had suffered a rupture of a major blood vessel with severe associated internal haemorrhage resulting in collapse and death. Rider was examined by the First Care Medical Personnel and ruled fit to fulfil her remaining engagement. Rider explained that rounding the home turn the gelding commenced to feel awkward in its action and was uncompetitive after entering the straight and as a consequence she commenced to ease her mount out shortly thereafter.

CALYPSO REIGN (K. Crowther) - near the 300 metres when attempting a run between **GRINZINGER EXPRESS (NZ)** and **EXETER**, contacted **ELUSIVE NATURE** as that horse attempted the same run.

SUNMATE (J. Potter) - held for a number of strides near the entrance to the straight and was obliged to shift in to obtain clear running.

RACE 5: TAB SA FILLIES CLASSIC - 2500 Metres

LA FALAISE (G. Cartwright) - over-raced in the early stages of the event.

SILENT SOVEREIGN (B. Vorster) - rider explained that from an awkward barrier it was his intention to ride the filly quietly in the early stages and he was conscious not to be more aggressive in the early stages as the filly was likely to have over-raced when ridden in that manner.

REALM OF FLOWERS (D. Thornton) - held up for a short distance inside the 600 metres.

BELLX (J. Allen) - laid in, in the straight. Near the 150 metres shifted in and momentarily tightened **RAPTURES**, which was inconvenienced.

RACE 5: TAB SA FILLIES CLASSIC - 2500 Metres (Cont'd)

STICK 'EM UP (T. Pannell) - a post-race veterinary examination revealed lacerations to its off hind cannon over the superficial flexor tendon. First aid was administered.

RAPTURES (J. Holder) - near the 150 metres was momentarily inconvenienced by BELLX, which shifted in.

LINDELANI (D. Holland) - awkward to begin. Laid in, in the straight.

TWILIGHT MAGIC (NZ) (K. Crowther) - a post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer Mr A. Alexander was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

THE MOCKINGBIRD (E. Brown) - raced wide without cover from near the 900 metres.

LION'S SHARE (P. Gatt) - awkward to begin. Raced wide without cover from near the 1600 metres.

TRALEE ROSE (NZ) (R. Hurdle) - raced wide without cover for a short distance approaching the 1600 metres.

ANGEL ROCK (J. Toeroek) - Trainer Mr M. Seyers, acting on behalf of Co-Trainer's Mr Hayes & Dabernig advised Stewards prior to the event of a change in tactics, that being that he would instruct J. Toeroek to ride the filly patiently early and attempt to obtain cover.

RACE 6: AAMI CENTAUREA STAKES - 2030 Metres

GIRL TUESDAY (B. Vorster) - disappointed for clear running from shortly after the entrance to the straight until approaching the 250 metres.

NAIVASHA (J. Allen) - awkward and slow to begin. Disappointed for clear running from near the entrance to the straight until inside the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

LAMU (GB) (D. Holland) - awkward to begin. Eased out of the event near the 200 metres. Rider explained the mare was off the bridle from inside the 600 metres and thereafter in the straight, felt awkward in its action for a number of strides and for that reason, he eased the mare out of the event from near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

PIERROCITY (P. Gatt) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

LA BELLE JUDE (T. Pannell) - raced wide without cover from near the 1600 metres.

CONVERGING (Z. Spain) - inclined to lay out over the concluding stages.

OASIS GIRL (G. Cartwright) - laid out in the straight.

WINGS OF PASTRAMI (J. Toeroek) - Stewards permitted J. Toeroek to ride the filly 1 kg over its declared weight of 53kg. A post-race veterinary examination revealed no visible abnormalities.

CRYPTIC JEWEL (NZ) (J. Holder) - raced keenly for some distance inside the 1800 metres.

WALKING FLYING (NZ) (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: ROBERT & FAY GERARD R A LEE STAKES - 1600 Metres

MONGOLIAN MARSHAL (NZ) (E. Brown) - approaching the 1400 metres commenced to race a little keenly at the same time as HUSSYBAY rolled out slightly and as a consequence clipped the heels of HUSSYBAY and knuckled. As a result, ARISTOCRATIC MISS, which was following was hampered for several strides when awkward on the heels of MONGOLIAN MARSHAL (NZ). A post-race veterinary examination revealed no visible abnormalities.

VINLAND (T. Pannell) - raced keenly in the early stages of the event. Near the 700 metres got its head up and raced ungenerously for a number of strides when awkwardly placed on the heels of WAGING WAR. A post-race veterinary examination revealed no visible abnormalities.

HUSSYBAY (K. Crowther) - approaching the 1400 metres rolled out slightly. A post-race veterinary examination revealed no visible abnormalities.

WAGING WAR (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

ALL TOO HUIYING (P. Gatt) - inside the 100 metres was tightened for several strides and was taken out towards HARBOUR VIEWS (FR) by CHAPEL CITY, which shifted out to improve and as a consequence had to be steadied.

DEXTER YOU DEVIL (J. Toeroek) - rider reported the gelding travelled well in the early and middle stages of the event however, never let down in the straight, was very disappointing and was one paced. A post-race veterinary examination revealed no visible abnormalities.

CHAPEL CITY (G. Cartwright) - inside the 100 metres shifted out to improve and tightened ALL TOO HUIYING when taking this horse out for several strides. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

ARISTOCRATIC MISS (D. Thornton) - awkward and slow to begin. Over-raced in the early stages of the event. Near the 1400 metres was hampered when awkward on the heels of MONGOLIAN MARSHAL (NZ) as that horse clipped the heels of HUSSYBAY and knuckled. Held up for clear running from near the 400 metres until inside the 300 metres.

NIPPERKIN (E. Finnegan) - awkward to begin.

RACE 8: THE FURPHY GOODWOOD - 1200 Metres

SANTA ANA LANE (D. Thornton) - fractious in its barrier stall after being loaded and was removed. Underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

TREKKING (J. Allen) - in the vicinity of the 800 metres shifted in, into the running line of BOLD STAR resulting in that horse being tightened for several strides, having to be steadied and losing its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on 27 May and to conclude at midnight on 8 June 2020; a period of six meetings.

GYTRASH (J. Holder) - over-raced in the early stages of the event.

SUNLIGHT (B. Vorster) - rider reported in his opinion the mare did not appreciate the underfoot conditions and was disappointing in the event. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

JUNGLE EDGE (G. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

THE INEVITABLE (D. Holland) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: THE FURPHY GOODWOOD - 1200 Metres (Cont'd)

ORDER OF COMMAND (E. Brown) - kicked by another runner on arrival at the barriers. Underwent a pre-race veterinary examination and was passed fit to race. Near the entrance to the straight shifted out slightly to improve and momentarily tightened TREKKING, which improved into a tight run between ORDER OF COMMAND and SUNLIGHT. As a consequence SUNLIGHT was hampered when taken out onto the heels of JUNGLE EDGE, which had commenced to give ground. As a further consequence LI'L KONTRA, which was following, was hampered and had to be steadied when awkwardly placed on the heels of SUNLIGHT. Rider was reminded of his obligations when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

BEHEMOTH (T. Pannell) - laid in, in the straight.

BOLD STAR (K. Crowther) - in the vicinity of the 800 metres was tightened for several strides by TREKKING which shifted in and as a consequence had to be steadied and lost its position. Approaching the 100 metres when improving, was obliged to take hold to avoid the heels of XILONG, which was tiring, and was initially unable to shift out to improve owing to LYRE racing to its immediate outside, however, shortly thereafter was able to improve to the outside of XILONG.

LYRE (Z. Spain) - momentarily held up on the heels of LI'L KONTRA near the 400 metres and was obliged to improve to the inside of that horse on straightening.

LI'L KONTRA (K. Zechner) - near the entrance to the straight was hampered when awkward on the heels of SUNLIGHT which was taken out and hampered.

RACE 9: TAB PROUD MISS STAKES - 1200 Metres

ZARGOS (J. Allen) - contacted and tightened onto MISS MANDITO (NZ) at the start and was unable to maintain its position.

MYSTERY LOVE (J. Holder) - near the 100 metres shifted in and momentarily inconvenienced KENYAN WONDER. Rider reported the mare travelled well in the early and middle stages of the event however, when asked for an effort rounding the home turn, failed to respond to his riding and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

STREET ICON (D. Thornton) - near the 150 metres shifted in momentarily.

EQUAL LOVE (E. Finnegan) - awkward to begin, shifted out and contacted ZARGOS and taken out. Rider reported the mare felt awkward in its action and did not let down in the straight. A post-race veterinary examination revealed no visible abnormalities.

MAGNA BELLA (R. Hurdle) - near the 150 metres had to be momentarily steadied off the heels of KENYAN WONDER, which shifted in and away from STREET ICON, which shifted in momentarily. A post-race veterinary examination revealed no visible abnormalities.

KENYAN WONDER (B. Vorster) - raced wide without cover in the early stages of the event. Near the 100 metres was momentarily inconvenienced when racing between KABINI, which maintained its line and MYSTERY LOVE, which shifted in. Rider reported that he became concerned with the mare's action over the concluding stages. He added the mare laid in late and in his opinion may not have appreciated the track conditions. A post-race veterinary examination revealed no visible abnormalities.

BAYOU (L. Neindorf) - awkward to begin.

SIMPLY DREAMING (G. Cartwright) - slow to begin.

SCHILLDORA (C. Jones) - Stewards permitted C. Jones to ride the mare below her minimum riding weight of 56kg.

DALASAN (J. Holder) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.
