**RACE 1: KONGORONG - ZED CUP WINNER 100 YEARS AGO THREE & FOUR YEAR OLD CLASS ONE HANDICAP - 1100 Metres**

**OUR BOY BAILEY** (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

**ANNIKA** (S. Logan) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**OUTPOST** (R. Hurdle) - slow to begin. Had difficulty in obtaining clear ground from the entrance to the straight until in the vicinity of the 150 metres.

**BRIMARVI ROOBOY** (B. Vorster) - raced keenly in the early and middle stages of the event.

**SEGUIMIENTOS** (D. Tootell) - slow into stride.

**RACE 2: MR VINCENT A ZED / SABOIS MAIDEN PLATE - 1716 Metres**

**ARMAMENT** (A. Jordsjo) - shifted out on jumping away onto PLUNGER CHARLIE.

**GUNFIREINTHECITY** (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

**MELODY MAN** (D. Tourneur) - momentarily held up rounding the home turn. Inclined to shift about under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 2: MR VINCENT A ZED / SABOIS MAIDEN PLATE - 1716 Metres (Cont'd)**

**OUR JOURNEYMAN** (S. Logan) - raced keenly in the early and middle stages of the event.

**PLUNGER CHARLIE** (R. Hurdle) - Trainer Mr P. Hardacre advised Stewards prior to the event in a change of tactics that being that he would advise the rider to be more positive and attempt to settle in a more forward position in today's event. Settled back. Hampered and lost its position on jumping away when tightened onto GUNFIREINTHECITY by ARMAMENT. Raced keenly in the early and middle stages of the event.

**KING AND KING** (B. Vorster) - inclined to shift about under pressure in the straight. Rider reported the colt raced greenly in the straight.

**PRINCESS EVASIVE (NZ)** (J. Holder) - slow to begin.

**RACE 3: JOCKEY J.H (JACK) KEILY / SABOIS MAIDEN PLATE - 1200 Metres**

**EIGHT OVER EIGHT** (S. Logan) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres had to be steadied when ELECTRUM shifted in. In the vicinity of the 600 metres improved onto the heels of ELECTRUM and had to be steadied. Laid out under pressure in the straight.

**GENERAL MINT** (J. Toeroek) - rider reported that in his opinion, the gelding had chocked down during the event. A post-race veterinary examination revealed no visible abnormalities.

**THE HAITIAN POET** (J. Holder) - raced keenly in the early and middle stages of the event.

**ELECTRUM** (D. Tourneur) - shifted in onto OUR JOURNEYMAN in the vicinity of the 1000 metres. Rider reprimanded.

**RACE 4: COOPERS BREWERY BENCHMARK 62 HANDICAP - 1100 Metres**

**DYNASTIC** (J. Eaton) - inconvenienced on jumping away when tightened between RUSHWA, which shifted in at the same time as AUSTRALIAN DESIGN shifted out. Laid out under pressure in the straight.

**MASTERATI** (S. Logan) - inclined to lay out under pressure in the straight. In the vicinity of the 50 metres rolled out onto AADELAD.

**AADELAD** (J. Opperman) - in the vicinity of the 50 metres had to alter course when it shifted in slightly at the same time as MASTERATI rolled out.

**AUSTRALIAN DESIGN** (M. Collett) - shifted out on jumping away onto DYNASTIC. Rider reported the mare had not let down when placed under pressure at the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**HUSHIANO** (K. Crowther) - raced wide without cover throughout the event.

**RUSHWA** (D. Tourneur) - shifted in on jumping away onto DYNASTIC.

**TOFFEE BELL** (D. Caboche) - laid out under pressure in the straight.

**RACE 5: WOLF BLASS RASCALS CUP BENCHMARK 54 HANDICAP - 1516 Metres**

**FLORIANO** (M. Collett) - laid out under pressure over the concluding stages.

**MAORI MAGIC (NZ)** (S. Cahill) - slow to begin.

**NEWBAY FLYER (NZ)** (S. Logan) - raced keenly in the early and middle stages of the event.

**RACE 6: 2020 ZED CUP - 100 YEARS ON BENCHMARK 62 HANDICAP - 2121 Metres**

**PERSIAN EMPIRE (NZ)** (J. Opperman) - raced keenly in the middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 7: WOLF BLASS WINES RATING 0-58 HANDICAP - 1200 Metres**

**CARBONE** (R. Hurdle) - awkward and slow to begin.

**CRYPTO CURRENCY** (A. Jordsjo) - contacted on jumping away. In the vicinity of the 900 metres had to be steadied when PANZER PRINCESS shifted in.

**AMERIWIN** (T. Voorham) - slow to begin.

**AVORA SUN** (J. Toeroek) - raced keenly and wide without cover throughout the event. Laid out under pressure in the straight.

**RED DAZZLE** (D. Caboche) - slow to begin and shifted out on jumping away contacting CRYPTO CURRENCY.

**SPIRITED MATCH** (S. Logan) - raced wide without cover throughout the event.

**PANZER PRINCESS** (J. Potter) - shifted in, in the vicinity of the 900 metres when insufficiently clear of SEE ME ROLLIN', which was forced to take hold and then continued in when insufficiently clear of CRYPTO CURRENCY, which was forced to be steadied. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 12 August and to conclude at midnight on Saturday, 22 August 2020: a period of three meetings.

**SEE ME ROLLIN'** (J. Opperman) - in the vicinity of the 900 metres had to take hold to avoid the heels of PANZER PRINCESS, which shifted in.
