

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 22 August 2020

RACE 1: WINNING EDGE PRESENTATIONS HANDICAP - 1100 Metres

TAKEN OFF (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

DAWN SALUTE (T. Pannell) - inside the 300 metres shifted in momentarily.

OUTPOST (S. Logan) - momentarily held up inside the heels of DAWN SALUTE, inside the 300 metres, as that horse shifted in momentarily.

RACE 2: AAMI MAIDEN PLATE - 1200 Metres

APPLIED (S. Fawke) - near the 700 metres, when awkward on the heels of SIMPLY VEIN, shifted out taking NAKHEEL out onto MALVADO, which was taken wider. Had difficulty obtaining clear running for a number of strides near the entrance to the straight.

DR CHOCCY (D. Caboche) - laid out in the straight.

MALVADO (C. Jones) - taken wider near the 700 metres.

MONRAAJ (D. Tourneur) - had difficulty obtaining clear running for a number of strides near the entrance to the straight. Laid out in the straight.

JONQUEST (J. Holder) - was slow to begin.

NAKHEEL (T. Pannell) - taken a little wider near the 700 metres.

SARNIA (P. Gatt) - inconvenienced at the start.

SIMPLY VEIN (R. Hurdle) - rider reported he felt something amiss with the mare and for that reason eased it out of the event near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: AAMI MAIDEN PLATE - 1200 Metres (Cont'd)

SHOJIKI (K. Crowther) - awkward to begin, shifted out onto SARNIA, which was inconvenienced.

RACE 3: G.H. MUMM MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately two (2) minutes.

EIGHT OVER EIGHT (S. Fawke) - over-raced in the early stages of the event.

JIMMY WITHA DASH (T. Pannell) - near the entrance to the straight, was hampered for several strides by SCARLET RIVER, which shifted out to improve and was obliged to be steadied.

MEADOWS YOUNG BUCK (S. Logan) - proved fractious after being loaded into its barrier stall. Underwent a pre-race veterinary examination and was passed fit to race. Laid in, in the straight and shifted in, inside the 200 metres, tightening VICTORIA QUAY, which was obliged to be checked.

OSCILLATION (C. Jones) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer Mr R. Balfour was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race start.

NEEDA - underwent a pre-race veterinary examination, on arrival on course, and was found to be lame in the near hind leg. Acting on this advice Stewards withdrew NEEDA at 12 noon. Trainer Mr S. Adams was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race start.

SCARLET RIVER (D. Tourneur) - near the 900 metres was momentarily awkward inside the heels of EIGHT OVER EIGHT, which shifted in slightly. Near the entrance to the straight shifted out to improve and hampered JIMMY WITHA DASH for several strides, resulting in JIMMY WITHA DASH having to be steadied. Rider was severely reprimanded for shifting ground when insufficiently clear.

VICTORIA QUAY (B. Vorster) - inside the 200 metres when improving to the inside of MEADOWS YOUNG BUCK, which laid in and shifted in, was obliged to be checked when tightened for galloping room.

RACE 4: DON 'NOBBY' HALL MEMORIAL HANDICAP - 1600 Metres

MONGOLIAN MARSHAL (NZ) (J. Toeroek) - near the 1000 metres shifted in and momentarily tightened ARISTOCRATIC MISS, which was inconvenienced. Laid out in the straight. Near the 100 metres was taken out by ANALYTICA (NZ) onto MORE THAN EVER (NZ), which was momentarily tightened.

ARISTOCRATIC MISS (B. Vorster) - Trainer Mr T. McEvoy advised Stewards prior to the event of a change of tactics, that being that he would instruct his rider to be more positive in the early stages and attempt to obtain a more forward position. Raced keenly in the early stages of the event. Near the 1000 metres was inconvenienced when tightened by MONGOLIAN MARSHAL (NZ), which shifted in momentarily. Rider explained the mare settled in a position he had anticipated, travelled well in the early and middle stages and until near the entrance to the straight, but when asked for an effort in the straight, failed to respond in a manner he expected and thereafter commenced to feel short in its action and for that reason, he did not persevere with his riding for the remainder of the event, from near the 150 metres. A post-race veterinary examination revealed a lower than expected heart rate.

MORE THAN EVER (NZ) (P. Gatt) - near the 100 metres was momentarily tightened between FINAL HEARING, which shifted in and MONGOLIAN MARSHAL (NZ), which laid out and was taken out by ANALYTICA (NZ), which shifted out.

ANALYTICA (NZ) (J. Holder) - had to be re-saddled on arrival at the barriers. Near the 100 metres shifted out under pressure taking MONGOLAIN MARSHAL (NZ) wider.



RACE 4: DON 'NOBBY' HALL MEMORIAL HANDICAP - 1600 Metres (Cont'd)

FINAL HEARING (D. Tourneur) - near the 100 metres shifted in and momentarily tightened MORE THAN EVER (NZ).

Correct weight was delayed to allow P. Gatt (MORE THAN EVER (NZ)), placed fourth, to view the vision in the straight.

RACE 5: SCHWEPPES HANDICAP - 1519 Metres

ICE GHOST (K. Crowther) - raced keenly in the early and middle stages of the event.

SEBONNA (B. Vorster) - was a little fractious in its barrier stall as the gates were released and as a consequence, was two to three lengths slow to begin. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr P. Hardacre was advised a warning had been placed on the gelding in relation to its barrier manners.

STRYKE IN STYLE (J. Toeroek) - rider reported the gelding did not appear to appreciate the underfoot conditions at various stages during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: 36° SOUTH BEEF HANDICAP - 1200 Metres

FANCY RUMBLE (S. Logan) - was awkward to begin, shifted out and contacted VON SAGA.

RULER BY CHOICE (B. Vorster) - over-raced in the early stages. Rider explained whilst he intended to settle in a more forward position, he anticipated he may get cover behind EXALTED LAURETTA, however, owing to the manner in which the mare raced in the early stages, he was unable to restrain and take cover and was obliged to lead in the event.

LADY BETHANY (NZ) (A. Jordsjo) - rider reported the mare did not handle today's track conditions and raced flat.

VON SAGA (J. Eaton) - was awkward to begin, shifted in and contacted FANCY RUMBLE.

SONIC DEED (D. Tourneur) - which performed below expectations was examined by the veterinary surgeon who reported no visible abnormalities.

RACE 7: FURPHY HANDICAP - 1050 Metres

DOMINATION (S. Logan) - knuckled severely on jumping away, shifted in and hampered OUR DEEP AGENDA. A post-race veterinary examination revealed no visible abnormalities.

ROCK HARD (D. Caboche) - laid in, in the straight. Rider was spoken to with regard to using his whip forward of the horse's shoulder in the straight.

AADELAD (J. Eaton) - raced keenly in the early stages of the event. Near the 900 metres became awkward on the heels of ROCK HARD for a number of strides.

OUR DEEP AGENDA (B. Vorster) - awkward to begin. Inconvenienced shortly after the start by DOMINATION, which shifted in.

UNBOUNDED (K. Crowther) - awkward to begin. Laid out under pressure in the straight.

NICCONI PONI (T. Pannell) – rider could offer no explanation for the mare's performance. A post-race veterinary examination revealed no visible abnormalities.

CIBACHROME (T. Voorham) - raced wide without cover throughout the event. Trainer Mr D. Tootell was reprimanded under LR18.1 for not declaring his rider by the required time.



RACE 8: TAB HANDICAP - 1800 Metres

PAGHMAN (T. Pannell) - raced keenly in the early stages of the event.

FRANKED (GB) - was a late scratching at 8.30 am by order of Stewards acting on confirmed advice from Trainer Mr M. Hickmott that the gelding had exhibited a skin rash on inspection.

STAR STATUS (J. Holder) - near the 1200 metres commenced to race keenly and got its head up when awkwardly placed on the heels of HAILEYBURY MISS for a number of strides. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$400. In determining penalty Stewards had regard for the totality of J. Holder's whip use and noted that he only used his whip on two occasions inside the 100 metres however, having regard for his recent record, imposed a fine of \$400.

BUSKER'S BALLAD (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty Stewards had regard for the totality of D. Tourneur's whip use and noted that he only used his whip on three occasions inside the 100 metres however, having regard for his recent record, imposed a fine of \$200.

RESURGE (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

HAILEYBURY MISS (P. Gatt) - rider reported the mare felt awkward in its near foreleg on pulling up. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: FLEURIEU MILK COMPANY HANDICAP - 1600 Metres

KALAMON (C. Jones) - shifted ground slightly approaching the 100 metres.

FLORIANO (T. Pannell) - shifted ground slightly approaching the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

ALIRIS (J. Holder) – was awkward to begin. Inclined to lay out in the straight. A post-race veterinary examination revealed the gelding to be lame on the near foreleg. Co-Trainer, Mr L Macdonald, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

THE OLYMPIAN (B. Vorster) - over-raced in the early and middle stages of the event. Rider reported that as a consequence of the gelding over-racing in the early and middle stages, he was unable to obtain cover as intended.

LITTLEBITFUNNY (T. Voorham) - inside the 1200 metres, when improving to a positon closer to the rail, became awkward for several strides inside the heels of NEAR MAGIC.

AUSTIN RAIDER (A. Jordsjo) - was slow to begin losing two to three lengths. Raced keenly in the early stages of the event. Raced in restricted room approaching the 100 metres for a short distance between FLORIANO and KALAMON, which both shifted ground slightly.

RACE 10: BAROSSA FINE FOODS HANDICAP - 1200 Metres

THIS KID ROCKS (C. Jones) - rider reported that while it was not her intention to lead, owing to the early pace in the event, her position in running and her reluctance to restrain her mount on the basis that it would commence to over-race, she elected to allow the gelding to stride forward to take up the lead.

EXTREME THRILL (J. Eaton) - laid in, in the straight.



RACE 10: BAROSSA FINE FOODS HANDICAP - 1200 Metres (Cont'd)

JACOBITE PRINCE (J. Toeroek) - Mr T. Stokes, acting on behalf of Trainer Mr. P Stokes, advised Stewards prior to the event of a change of tactics, that being that he would instruct his rider not to lead and attempt to find cover where comfortable. Was awkward to begin.

CANFORD (D. Tourneur) - underwent a pre-race veterinary examination as it had not raced since August 2019 and was passed fit to race.

EXCELTARA (R. Hurdle) - was slow to begin.

KINGSON (K. Zechner) - raced keenly in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using is whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for K Zechner's good record.

SPIRITED MATCH (A. Jordsjo) - raced keenly in the early stages of the event.
