Report on Race Meeting held at Gawler Racecourse

RACE 1: HOLDFAST INSURANCE / SABOIS MAIDEN PLATE - 1500 Metres

BONIFACE (NZ) (J. Eaton) - raced fiercely in the early and middle stages of the event. Rider reported her mount over-raced and raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TURN TABLE (J. Opperman) - from its wide barrier shifted in, in an attempt to gain cover. Over-raced in the early and middle stages of the event. Inclined to lay out under pressure in the straight. Rider explained in relation to the gelding's performance that the pace in today's event, may not have suited the gelding and that the gelding was inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: TERRACE FUNCTION CENTRE / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1200 Metres

HARD BORDER (J. Toeroek) - rider explained in relation to the gelding's performance that it travelled okay during the event, however HARD BORDER failed to let down when asked to do so and was disappointing with its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

JIMMY WITHA DASH (T. Pannell) - shortly after the start shifted in, in an attempt to gain cover.

KING SLIM (P. Gatt) - in the vicinity of the 400 metres was taken out slightly by the HAITIAN POET.

LOMAX (J. Potter) - in the vicinity of the 400 metres shifted out and away from KING SLIM onto CANDY DUDE. Inclined to lay in under pressure in the straight.

MALVADO (D. Tourneur) - on jumping away bumped with WIFE FREE ZONE, which shifted out.

**RACE 2: TERRACE FUNCTION CENTRE / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN
PLATE - 1200 Metres (Cont'd)**

THE HAITIAN POET (J. Holder) - in the vicinity of the 400 metres shifted out onto KING SLIM, which was taken out onto LOMAX, which shifted out and away onto CANDY DUDE, which was obliged to be steadied. Rider was severely reprimanded under AR131(a) and advised to take greater care in future.

WIFE FREE ZONE (J. Eaton) - jumped away awkwardly, shifted out and bumped with MALVADO.

CANDY DUDE (J. Maund) - raced wide without cover throughout the event. In the vicinity of the 400 metres was obliged to be steadied when tightened onto JIMMY WITH A DASH as LOMAX shifted out and away from KING SLIM, which was taken out.

GOLD DERBY (M. Collett) - lost its off hind plate on arrival on course and was unable to be reshod therefore the near hind plate was removed and permission was granted for the gelding to race unshod behind. Underwent a pre-race veterinary examination and passed fit to race.

HENRY THE BRUCE (K. Crowther) - shortly after the start shifted in to obtain cover.

**RACE 3: ADELAIDE PLAINS BLOODSTOCK / SABOIS FILLIES AND MARES MAIDEN PLATE
- 1200 Metres**

ARCTIC FLORA (J. Holder) - shortly after the start, from its wide barrier, shifted in, in an attempt to gain cover.

CALL ME WENDALL (P. Gatt) - slightly awkward to begin. Near the 1000 metres was bumped by YEELANNA, which shifted out.

FEDE SEMPRE (S. Fawke) - over-raced in the early stages.

GIRLINTHEMIRROR (S. Logan) - shortly after the start rolled out.

JESSICA'S REWARD (D. Caboche) - became awkward in its action inside the 200 metres and was restrained by its rider to be pulled up. A post-race veterinary examination revealed the mare to have strained the near fore superficial digital flexor tendon. First aid administered. Trainer, Mr G. Lesnikowski, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

MUG'S GAME (A. Jordsjo) - raced wide without cover throughout the event. Rider reported the mare was inclined to lay out and raced greenly throughout the event.

SCARLET RIVER (D. Tourneur) - Trainer Mr R. Balfour reported following the event, that he would recommend to the owners that the mare now be spelled.

YEELANNA (C. Lions) - raced fiercely when being restrained in the early stages and near the 1000 metres shifted out and bumped CALL ME WENDALL. Held up for clear running from rounding the home turn until near the 400 metres.

BRIABELLA (J. Eaton) - shortly after the start was inconvenienced as GIRLINTHEMIRROR rolled out. A post-race veterinary examination revealed no visible abnormalities.

LADY DUNMORE (K. Crowther) - held up for clear running from approaching the 400 metres until in the vicinity of the 200 metres and shifted out to obtain clear running.

RACE 4: CORNERSTONE STUD BENCHMARK 54 HANDICAP - 1100 Metres

EXTRA MILE (J. Opperman) - jumped away awkwardly. Over-raced in the early and middle stages of the event. Held up for clear running from the entrance to the straight until inside the 200 metres, from that point on shifted out under riding and as a result **TURF TAPPER**, which was inclined to lay in, had to be severely checked approaching the finish. Rider was severely reprimanded under AR131(a) and advised to take a much greater effort when his mounts shift ground under pressure over the concluding stages.

OUTPOST (S. Logan) - on jumping away bumped by **MISS HARMONIUM**, which shifted out. A post-race veterinary examination revealed mild thumps.

SAND CAT (C. Lions) - had difficulty obtaining clear ground from approaching the 200 metres until the finish.

HOT SIZZLE (J. Holder) - laid in under pressure in the straight.

MISS HARMONIUM (S. Fawke) - jumped away awkwardly, shifted out and bumped **OUTPOST**.

AVORA SUN (P. Gatt) - on arrival at the barriers had its tongue-tie readjusted.

TURF TAPPER (J. Potter) - slow to begin. Approaching the finish line was inclined to lay in slightly and was obliged to be severely checked as **EXTRA MILE** shifted out.

Correct weight was delayed to allow J. Potter (**TURF TAPPER**) placed second to view the vision in the straight.

RACE 5: GBJC LIFE MEMBERS CUP BENCHMARK 56 HANDICAP - 1700 Metres

The start of this event was delayed approximately two minutes.

STYKE IN STYLE (S. Logan) - laid in, in the early part of the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fine \$100.

BARRYMORE - underwent a pre-race veterinary examination in the mounting yard and ruled unfit to start as it was lame in the off hind leg. Acting on this advice Stewards withdrew **BARRYMORE** at 3.38 pm. Trainer, Mr L. O'Connor, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

KING RED (T. Pannell) - laid in under pressure in the straight.

WAIKATO EXPRESS (E. Boyd) - inside the 200 metres bumped with **AZZUREOUS**. Over the final 100 metres raced in restricted room between **KING RED** and **AZZUREOUS**.

KNAVESMIRE (T. Voorham) - over-raced throughout the event. Rider reported, in relation to the gelding's performance, that it may not have handled today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

AZZUREOUS (D. Tourneur) - inside the 200 metres bumped with **WAIKATO EXPRESS**. Raced in restricted room between **WAIKATO EXPRESS** and **BACK POCKET** and as a result, was obliged to be steadied when awkwardly placed on the heels of **FRANKEL STAR**.

FRANKEL STAR (J. Opperman) - over-raced in the early and middle stages of the event.

GUEST LIST (M. Collett) - slow into stride.

SAMSTAG (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: OCTOBER 23RD - 2020 GAWLER CUP BENCHMARK 54 HANDICAP - 1200 Metres

BOOMER BEACH (J. Opperman) - Trainer Mr J. Stephens made a submission to Stewards that the gelding be declared a late scratching on the basis he considered the track to be biased and suiting front runners and also due to the underfoot conditions and this, in his opinion, would not suit the gelding. Stewards considered the matter and declined Mr Stephen's request. Shortly after the start shifted in to obtain cover. Had difficulty obtaining clear ground from inside the 200 metres until in the vicinity of the 100 metres and from that point on was held up until approaching the finish line.

CARBONE (S. Logan) - jumped away awkwardly, shifted in and bumped REGINA DEL DRAMMA. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

JACK'S SISTER (C. Lions) - raced wide without cover in the early and middle stages of the event.

REGINA DEL DRAMMA (D. Tourneur) - on jumping away bumped with CARBONE. Laid in under pressure in the straight.

SHEERAN (S. Fawke) - weakened from in the vicinity of the 500 metres. Rider could offer no explanation in relation to the gelding's performance. A post-race veterinary examination revealed no visible abnormalities.

HILUMIERE (K. Crowther) - raced wide without cover in the early and middle stages of the event.

RACE 7: COOPERS BREWERY RATING 0-58 HANDICAP - 1500 Metres

CAN'T BLUFF ME (J. Opperman) - slow into stride. Inclined to lay in under pressure in the straight.

CALYPSO STORM (J. Holder) - rider reported the mare travelled well during the event, however when asked to improve in the vicinity of the 150 metres failed to respond to his riding and didn't finish the race off. He added that CALYPSO STORM may be better suited to racing over shorter distances. A post-race veterinary examination revealed no visible abnormalities.

NEWBAY FLYER (NZ) (D. Tourneur) - jumped away awkwardly. Near the 1100 metres became awkward on the heels of SYLVAN CREST for a short distance as the pace was eased by that gelding. Had difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 200 metres. Held up for clear running from inside the 100 metres until the finish when awkwardly placed between MIHANY and SYLVAN CREST.

ANNAMAN (T. Pannell) - raced wide without cover throughout the event.

CITY BEATS - underwent a pre-race veterinary examination on course and ruled to be lame in the near foreleg. Acting on this advice Stewards withdrew CITY BEATS at 3.51 pm. Trainer, Mr D. Moyle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

SYLVAN CREST (J. Eaton) - laid out under pressure in the straight. Rider was questioned in relation to the tactics adopted in today's event. She stated that her instructions were to attempt to be forward in today's event. She added the gelding jumped well and was able to find the lead with ease. Co-Trainer Mr G. Kent confirmed the instructions provided and added that those instructions have been consistent with what has been provided at the gelding's most recent starts.

RED DAZZLE (J. Potter) - slow to begin and shortly after, from its wide barrier, shifted in, in an attempt to gain cover.
