RACE 1 : WOLF BLASS GREY LABEL / SABOIS FOUR-YEARS-OLD & OVER MAIDEN PLATE - 1109 metres

GUN ROOSTER (S. Carr) jumped away awkwardly and was slow to begin.

FAN THE BREEZE (J. Maund) was inclined to lay out under pressure in the straight and approaching the 100 metres shifted out onto OAKBANK REIGN (J. Frew), which was taken out onto MIXOLOGIST (M. Neilson), which became awkwardly placed on that gelding's heels as it was inclined to lay in.

- J. Toeroek, the rider of MOSTA CHARM, reported the mare had raced greenly throughout the event.
- M. Neilson, the rider of MIXOLOGIST, reported the gelding felt short in its action in the straight and had a tendency to lay in. MIXOLOGIST was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ARRANGER TEST, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SLIPPERY DIP, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: COOPERS PALE ALE MAIDEN / CLASS 1 PLATE - 2120 metres

DANZA MOMENT (D. Tourneur), DIELLO ROSE (C. Lindop) and TANE MAHOUTA (K. Bishop) over-raced in the early and middle stages of the event.

In the vicinity of the 1500 metres ISLE OF TWEED (M. Neilson) attempted to restrain his mount to allow VANDALAY (S. Price) to obtain the lead, resulting in DANZA MOMENT (D. Tourneur) becoming awkwardly placed on the heels of ISLE OF TWEED (M. Neilson) and having to take hold. As a consequence LADY CHORA (J. Potter), which was racing behind DANZA MOMENT, had to be steadied and DIELLO ROSE (C. Lindop), which was racing behind LADY CHORA having to be checked off that mare's heels and shifted out. DIELLO ROSE was forced to race wide without cover for the remainder of the event. M. Neilson, the rider of ISLE OF TWEED was advised of his obligations under AR137(d) in relation to reducing the speed of his horse.

From the vicinity of the 800 metres until the entrance to the straight LYDIARD (S. Carr) became held up and had difficulty obtaining clear ground.

DANZA MOMENT (D. Tourneur) was unable to obtain clear ground from the vicinity of the 600 metres until near the 400 metres.

DIELLO ROSE (C. Lindop) laid out under pressure in the straight. DIELLO ROSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Neilson, the rider of ISLE OF TWEED, which performed poorly, explained the gelding had travelled well in the early stages of the event, however, when placed under pressure in the vicinity of the 800 metres, failed to respond to his riding and from the vicinity of the 400 metres commenced to weaken from the event of its own accord. ISLE OF TWEED was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LADY CHORA lost its near fore plate during the event.

RACE 3 : GAWLER SOUTH BAKERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1209 metres

The start of this event was delayed approximately one minute owing to PILLAR OF GOLD (T. Zanker) proving difficult to load. Trainer Mrs S. Ratsch was advised a warning had been placed on the filly in relation it its barrier manners.

SOARING HIGH (C. Lindop) was slow to begin.

In the vicinity of the 400 metres K. Bishop, the rider of THE ENGINEER, permitted her mount to shift out when insufficiently clear of GRAN SABANA (A. Doyle), which was forced to check to avoid that gelding's heels. K. Bishop was charged with Careless Riding under AR137(a) in relation to this incident. K. Bishop requested the inquiry be adjourned to allow her Master, Mr J. Dunn, to be present. Stewards acceded to this request and advised the inquiry would be held at the Morphettville offices at 10.30 am on Monday, 24 August 2015

In the vicinity of the 200 metres GRAN SABANA (A. Doyle) shifted out and brushed PRINCE OF PAGODA (NZ) (M. Neilson) and shortly after had to be steadied as THE ENGINEER (K. Bishop) rolled out.

PLATINUM SET lost its near fore plate during the event.

DELARUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: GOLDIN FARMS, AKEED MOFEED / SABOIS MAIDEN PLATE - 1509 metres

NATIVE AZTEC (J. Toeroek) was slow to begin.

EXCITE A SHANTY (J. Holder) shifted in on jumping away onto BEDAVALUE (L. Stojakovic), which was taken in, inconveniencing EXONERATION (P. Denton).

BEDAVALUE (L. Stojakovic) rolled out slightly onto NATIVE AZTEC (J. Toeroek), which was inconvenienced when tightened onto RAGONESI ROAD (T. Pannell) taking that gelding out onto STEALTH MODE (D. Tootell), which held its line.

FINNTUITION (P. Gatt) and SNAKE FARLEY (S. Price) raced keenly in the early and middle stages of the event.

CELESTIAL STORY (D. Tourneur) laid in under pressure in the straight.

Approaching the 100 metres SNAKE FARLEY (S. Price) shifted in abruptly onto BEDAVALUE (L. Stojakovic), which had to be steadied momentarily.

P. Gatt, the rider of FINNTUITION, which performed poorly explained the mare had over raced in the early and middle stages of the event and he had become concerned with its action after entering the straight and for this reason had not ridden out in his normal manner. FINNTUITION was examined by the Club's Veterinary Surgeon who reported the mare to have excess upper respiratory noise. Co-Trainers Mr W. Frances and Mr G. Kent were advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RICCONE lost its near fore plate during the event.

RACE 5 : SPORTSBET CASH CARD RATING 0-68 HANDICAP - 1109 metres

The start of this event was delayed approximately two minutes owing to SET ON STONE losing an off fore plate en route to the barrier and requiring Farrier attention.

SHA LA LA (J. Holder) was slow to begin.

MEADOW'S JOURNEY (S. Carr) jumped away awkwardly.

ZANDERCAN (A. Doyle) laid out making the turn in the vicinity of the 900 metres and again rounding the home turn. ZANDERCAN was examined by the Club's Veterinary Surgeon who reported minor abrasions to the near hind pastern.

RACE 6: NATIONAL JOCKEYS TRUST SERIES CLASS ONE HANDICAP - 1209 metres

CHAMPAGNE KRIS (A. Doyle) shifted out on jumping away contacting KINGSGROVE (J. Potter).

SHOW SET (T. Zanker) jumped away awkwardly and shifted out inconveniencing COURTSIDE (D. Caboche).

FRANK HEAVENS (S. Carr) raced keenly in the early stages of the event.

Stewards questioned D. Caboche, the rider of COURTSIDE, into his action approaching the finish. After considering his explanation D. Caboche pleaded guilty to a charge under AR137(c) in that he made a celebratory gesture prior to his mount passing the winning post and was fined \$200.

RACE 6: NATIONAL JOCKEYS TRUST SERIES CLASS ONE HANDICAP - 1209 metres (Cont'd)

J. Potter, the rider of KINGSGROVE reported the gelding had hung out throughout the event and had not led down as he had anticipated and in his opinion was not comfortable in its action over the concluding stages. KINGSGROVE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

A. Doyle was questioned in relation to being unable to claim down to his minimum riding weight. As there were no available apprentices on course to claim down to that weight, A. Doyle was permitted to ride CHAMPAGNE KRIS above the weight, however, was fined \$200 under AR120(b) for declaring overweight.

RACE 7: SANDERS FODDER / MITAVITE RATING 0-62 HANDICAP - 1709 metres

JUST A SPARK (S. Carr) and JUST A BOB (D. Caboche) were slow to begin.

WARRASIDE (A. Doyle) raced fiercely in the early and middle stages whilst being restrained.

BIG BOY BLEV (M. Neilson) laid out under pressure in the straight.

S. Price, the rider of IMPRESSIVE YIELD, which performed below expectations, explained the gelding had travelled well in the early and middle stages of the event, however, had failed to respond to his riding when placed under pressure and had finished the event off poorly. IMPRESSIVE YIELD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lindop, the rider of CLANDARBHEN, which performed below expectations, explained that she was happy with the position obtained in running, however, when placed under pressure the gelding had failed to respond to her riding and she was disappointed in how CLANDARBHEN had finished off the event. CLANDARBHEN was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.

EKAMAI PHOM, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

JUST A SPARK lost its near hind plate during the event.

RACE 8 : SCHWEPPES WELCOME ABROAD / SABOIS FILLIES & MARES RATING - 1509 metres

BAIKAL (D. Caboche) raced wide without cover throughout the event.

At the entrance to the straight POLLYWAGON (J. Bowditch) rolled out slightly inconveniencing LONCAY (E. Boyd), which had to be steadied momentarily.

DOWN THE AISLE was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.

POLLYWAGON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CHANTILLY FLYER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
