Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 22 August 2015

RACE 1 : ZEBEDEE AT CORNERSTONE HANDICAP - 1950 metres

Inside the 700 metres HALAYR JET (E. Finnegan) laid in and shifted in onto the hindquarters of UP THE CREEK (P. Gatt), which shifted out shortly thereafter and brushed with HALAYR JET.

In the vicinity of the 300 metres BOOGIELICIOUS (C. Lindop), which was inclined to lay in, shifted in and momentarily inconvenienced MAJESTIC MOMENT (C. Jones).

MAJESTIC MOMENT (C. Jones) laid out in the straight.

FLYING CASINO was examined by the Club's Veterinary Surgeon who reported the gelding had shifted its off fore plate during the event and had bruising to the toe. First Aid was administered.

RACE 2: GUARDIAN INSURANCE BROKERS HANDICAP - 1000 metres

SVENDITA (T. Pannell) jumped away awkwardly.

J. Holder, the rider of BURST AWAY, explained the gelding travelled well throughout the event, responded to his riding in the straight, finished the race off well and had every opportunity. BURST AWAY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: SAROA HANDICAP - 1400 metres

MR LAMBORGHINI (E. Boyd) jumped away awkwardly and shifted out, tightening HAVE PLENTY (J. Holder) onto PATCH HERO (Z. Spain). As a consequence HAVE PLENTY was inconvenienced and unable to maintain its position.

BOLD JAZZ (T. Pannell) over-raced in the early stages of the event.

RACE 3: SAROA HANDICAP - 1400 metres (Cont'd)

PATCH HERO (Z. Spain) over-raced in the early stages and in the vicinity of the 600 metres got its head up and raced ungenerously for a short distance.

MR LAMBORGHINI (E. Boyd) and COME FOLLOW ME (J. Kah) made the turn near the 1000 metres awkwardly.

HAVE PLENTY (J. Holder), which raced greenly, shifted in abruptly approaching the 300 metres.

COME FOLLOW ME (J. Kah) laid in, in the straight. COME FOLLOW ME was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

In the vicinity of the 100 metres BOMBER BROWN (J. Bowditch) shifted in under riding and tightened JACKTHEGIANTSLAYER (S. Cahill) for a short distance, resulting in that gelding racing in restricted room over the concluding stages.

J. Holder, the rider of HAVE PLENTY, reported the gelding raced greenly in the straight.

JACKTHEGIANTSLAYER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: RYAN BALFOUR RACING HANDICAP - 1250 metres

LOQUETEUX (C. Jones) jumped away awkwardly and was slow to begin.

CARO KANN (E. Finnegan) jumped away awkwardly and shifted out, contacting SCRATCHY LASS (J. Holder).

GET PRONTO (K. Bishop) raced wide without cover in the early and middle stages of the event and laid in, in the straight.

Over the concluding stages TYCOON QUEEN (J. Maund) was obliged to race in restricted room between CARO KANN (E. Finnegan), which rolled in, and THE GEE TRAIN (T. Pannell), which rolled out and away from BAKER BOY (J. Bowditch).

LOQUETEUX (C. Jones) was held up for clear running over the concluding stages when improving onto the heels of ONE MORE DAISY (P. Gatt).

FLIRTY GERTY (J. Toeroek) became awkward on the heels of MANHATTAN PRINCE (C. Lindop) over the concluding stages.

E. Finnegan, the rider of CARO KANN, reported her mount hung out throughout the event.

LOQUETEUX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: TASTE FURNITURE ADELAIDE HANDICAP - 1000 metres

NORTHERN ZHAR (J. Holder) was slow to begin.

TOM'S LUCK (S. Carr) became awkward in its stride for a short distance in the vicinity of the 600 metres and shortly after the entrance to the straight again shortened its stride and was eased out of the event approaching the 200 metres. TOM'S LUCK was examined by the Club's Veterinary Surgeon who reported the gelding had suffered a bi-lateral bleeding attack. First Aid was administered. Mr. G. Young, the Trainer of TOM'S LUCK, was advised as this was the gelding's second bleeding attack, it is now banned from racing for life in accordance with AR53A.

RACE 5: TASTE FURNITURE ADELAIDE HANDICAP - 1000 metres (Cont'd)

At the entrance to the straight CAPTAIN PUNCH (P. Gatt) shifted out to improve and contacted IMPULSE BUY (R. Hurdle) on a number of occasions.

In the vicinity of the 100 metres NORTHERN ZHAR (J. Holder) shifted out to improve and contacted KRAFTWERK (C. Lindop), which was inconvenienced when taken out.

J. Cartwright, the rider of CASHED, accidentally dropped his whip shortly after the winning post.

BURNRO lost its near hind plate during the event.

IMPULSE BUY lost its off fore plate during the event.

RACE 6: LEADER COMPUTERS HANDICAP - 1250 metres

RAISE A DREAM (J. Bowditch) jumped away awkwardly, shifted out and inconvenienced MUCHOS RESPECTOS (NZ) (S. Carr), which was slow to begin.

A SAUCY SNITZEL (E. Finnegan) raced wide without cover in the early and middle stages of the event.

MUCHOS RESPECTOS (NZ) (S. Carr) was held up for clear running approaching the 400 metres and shortly after the entrance to the straight attempted to improve into a run to the inside of RAISE A DREAM (J. Bowditch) but was disappointed shortly thereafter and obliged to alter course to the outside of RAISE A DREAM and THEATREMAN (P. Gatt) to obtain clear running.

Inside the 100 metres A SAUCY SNITZEL (E. Finnegan), which was inclined to lay out, shifted out, taking CON'S GOLD (J. Kah) wider on the track, which crossed the running of MOLLY THE SNIP (J. Holder), which was obliged to alter course to the inside of CON'S GOLD to obtain clear running. E. Finnegan was reminded of her obligations when shifting ground in future.

Correct Weight for this event was delayed to allow J. Holder, the rider of the fourth placegetter MOLLY THE SNIP, to view the official footage in the straight.

RACE 7: WILLIAM HILL PENNY EDITION STAKES - 1400 metres

The start of this race was delayed approximately one minute to avoid a clash with an interstate race.

GO INDY GO (C. Lindop) raced wide without cover throughout the event.

ALPINE EAGLE (M. Neilson) raced greenly in the straight.

C. Lindop, the rider of GO INDY GO, explained her intentions were to settle further back with cover but owing to the manner in which her mount raced in the early stages, she was obliged to settle wide without cover and was unable to obtain cover behind DYLANSON (P. Gatt) in the middle stages of the event and rounding the home turn, was inconvenienced when ALPINE EAGLE (M. Neilson) improved to her inside. She added the mare was disappointing in its performance and did not finish the race off in the manner she expected. GO INDY GO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: WILLIAM HILL PENNY EDITION STAKES - 1400 metres (Cont'd)

M. Neilson, the rider of ALPINE EAGLE, explained he was comfortable with his position in the early stages of the event and when asked for an effort near the 600 metres, the horse responded to his riding and finished the race off very strongly. ALPINE EAGLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GO DREAMING was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. First Aid was administered. Mr. G. Kluske, the Trainer of GO DREAMING, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 8: AKEED MOFEED GOLDIN FARMS HANDICAP - 1400 metres

EDGEWOOD (J. Kah) stood flat-footed and lost many lengths at the start. Mr. J. MacMillan, the Trainer of EDGEWOOD, was advised the gelding would be required to jump on terms with the field in at least one (1) Official Barrier Trial and one (1) Approval to Race Jump Out prior to accepting for a future race.

Shortly after the start YOUBOLT (S. Carr) shifted in and contacted LONCAVA (NZ) (J. Holder), which was hampered when taken in onto LATE NIGHT DRINK (J. Toeroek), resulting in that gelding being inconvenienced.

In the vicinity of the 1300 metres SATURDAY AFFAIR (C. Lindop) became awkward on the heels of BELGIETTO (Z. Spain), which rolled in slightly, got its head up when being restrained and raced ungenerously for a number of strides. Z. Spain was reminded of his obligations when his mounts commence to shift ground in future.

FROST DODGER (M. Neilson) raced wide without cover in the middle stages of the event.

Approaching the 200 metres STREETCAR VALOUR (R. Hurdle) was tightened between BACK ON TARGET (E. Finnegan), which rolled out, and ROCKET COMMANDER (P. Gatt), which rolled in, was obliged to be steadied and was unable to maintain its position.

Correct Weight for this event was delayed to allow Stewards, together with J. Kah, the rider of EDGEWOOD, that gelding's Trainer, Mr. J. MacMillan, and the Official Starter, to review the official footage of the start.

FROST DODGER was examined by the Club's Veterinary Surgeon who reported a laceration to the near hind pastern. First Aid was administered.
