**Report on Race Meeting held at Morphettville Parks Racecourse**

**TRACK:** Good 4 (*Upgraded to Good 3 @ 11.15 am*)

**WEATHER:** Fine

**RAIL:** Out 7 metres 1000 metres to 400 metres, 5 metres remainder. Sectional 608 metres

**RACE 1 : CAMPOLINA STUD TWO-YEAR-OLD PLATE - 1000 metres**

BANGS (J. Toeroek) was inclined to over-race in the early stages of the event.

WHITE FEATHER (P. Gatt) made the turn in the vicinity of the 700 metres awkwardly and shifted out.

MR MARKOU (J. Holder) was held up from approaching the 400 metres until near the 200 metres when racing behind WHITE FEATHER (P. Gatt) and inside DIDONATO (T. Pannell).

In the vicinity of the 200 metres MR MARKOU (J. Holder) attempted a tight run to the inside of WHITE FEATHER (P. Gatt) at the same time as DIDONATO (T. Pannell) rolled in under pressure, resulting in WHITE FEATHER becoming awkwardly placed between these two runners and losing its position.

M. Neilson, the rider of NORTHERN LASS, explained the filly had been a touch awkward getting into stride after jumping away and was off the bit throughout the event. He added when placed under pressure in the vicinity of the 500 metres NORTHERN LASS had finished the event off fairly. NORTHERN LASS was examined by the Club's Veterinary Surgeon who reported abrasions to both hocks.

WHITE FEATHER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : QUAYCLEAN THREE-YEAR-OLD MAIDEN PLATE - 1300 metres**

EXALTED KANGA (Z. Spain) was slow to begin.

WINDSOR CUP (R. Hurdle) shifted in on jumping away onto OTHERWISE OKAY (M. Neilson), which was hampered.

In the vicinity of the 1000 metres TAMBLYN (J. Holder) shifted in when insufficiently clear of OTHERWISE OKAY (M. Neilson), which was forced to check to avoid the heels of that gelding. J. Holder pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 10 October and to conclude at midnight on Saturday 17 October 2015: a period of four (4) meetings.

## **RACE 2 : QUAYCLEAN THREE-YEAR-OLD MAIDEN PLATE - 1300 metres (cont'd)**

M. Neilson was found guilty of a charge under AR175(g) in that during this inquiry he gave evidence which in the opinion of the Stewards was false and misleading and was reprimanded.

GHOST RIDER (J. Kah) laid in, in the straight and in the vicinity of the 200 metres, became momentarily held up when racing behind SCHIZLE (T. Pannell) and inside OTHERWISE OKAY (M. Neilson), which had improved quickly to its outside.

In the vicinity of the 800 metres R. Hurdle, the rider of WINDSOR CUP, was accidentally struck in the face by the head of WINDSOR CUP as his saddle shifted, resulting in R. Hurdle becoming unbalanced for a short distance.

DEFENCE WITNESS, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GHOST RIDER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 3 : THE MARTIAN HANDICAP - 1000 metres**

## **RACE 4 : AKEED MOFEED AT GOLDIN FARMS HANDICAP - 2400 metres**

Mr J. Croucher, the Trainer of REMORSE advised Stewards, he would instruct J. Toeroek to attempt to settle forward of midfield in this event if possible.

STORMY BILL (D. Tourneur) raced keenly in the early and middle stages of the event.

On pulling up P. Gatt, the rider of PACKING EMPIRE (NZ) became concerned with that gelding's action and dismounted. PACKING EMPIRE (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 5 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1250 metres**

TRY YOUR BEST (NZ) (D. Tourneur) reared on jumping away and missed the start several lengths. Trainer, Mr P. Stokes was advised the mare was now suspended until such time as it could jump away with the field in an Approval Jump Out or Official barrier Trial.

QUICK LOVER (C. Jones) was slow to begin.

At the entrance to the straight QUICK LOVER (C. Jones) became held up when racing behind SCHADUW (R. Hurdle) and inside WARRIOR LADY (C. Lindop) and was unable to obtain clear ground until the vicinity of the 200 metres when able to ease out.

PURE REALITY (J. Holder) became held up in the vicinity of the 200 metres until inside the 100 metres when awkwardly placed between the heels of DEANNA JEAN (J. Potter) and SHEEZ ON TOP (E. Boyd).

Correct weight for this event was delayed to allow Stewards to view the start in relation to TRY YOUR BEST (NZ) (D. Tourneur).

Following the running of this race D. Tourneur was examined by the First Care Medical Personnel and stood down for further assessment.

## **RACE 6 : JAMES BOAG'S PREMIUM HANDICAP - 1950 metres**

JARRVIS (E. Boyd) reared on jumping away and was slow to begin.

From the entrance to the straight until the vicinity of the 200 metres SET ON STONE (J. Potter) had difficulty in obtaining clear ground when awkwardly placed between the heels of FROST DODGER (Z. Spain) and FIVE TO MIDNIGHT (C. Lindop).

J. Frew, the rider of CRUZ'N NOW, which performed poorly, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 600 metres, had failed to respond to his riding and was reluctant to stretch out. CRUZ'N NOW was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Co-Trainer's Mr K. and Mrs H. Frew were advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

J. Toeroek, the rider of LATE NIGHT DRINK, which performed poorly, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure, had failed to respond to his riding and finished the event off poorly. LATE NIGHT DRINK was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Trainer Mr G. Richards was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

Stewards questioned Z. Spain, the rider of FROST DODGER into his whip use in this event. After doing so Z. Spain pleaded guilty to a charge under AR137A(4)(b) in that he had used his whip in an action that raised his arm above shoulder height and was fined \$200.

## **RACE 7 : MELBOURNE CUP LIVE RACING @ MORPHETTVILLE HANDICAP - 1250 metres**

Prior to the running of this race D. Tourneur was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

WISE JOURNEY (J. Holder) jumped away awkwardly and was slow into stride.

## **RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1400 metres**

The start of this event was delayed approximately two minutes owing to SAGAPUSS (D. Tourneur) losing its off hind plate en route to the barrier and requiring Farrier attention.

GRAND ARMADA (J. Kah) and BURNRO (P. Gatt) were slow to begin.

In the vicinity of the 1000 metres RIB EYE (J. Holder) rolled out slightly onto INCANDESCENT (C. Lindop), which was hampered. INCANDESCENT (C. Lindop) then raced fiercely for a short distance.

BESTIHAVEEVERHAD (S. Price) laid out over the concluding 600 metres. BESTIHAVEEVERHAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BURNRO (P. Gatt) had difficulty obtain clear ground at the entrance to the straight when racing behind BRINKLEY BREEZE (R. Hurdle) and inside SAGAPUSS (D. Tourneur).
