## THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

# Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 24 October 2015

#### RACE 1: HUGHES CHAUFFEURED LIMOUSINES 3YO MAIDEN PLATE - 1250 metres

**BUTTERBEER** (J. Toeroek) – rider reported the gelding laid out throughout. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**RUFUS** (C. Lindop) – near the 900m raced in restricted room and taken in.

SHIZLE (T. Pannell) – near the 900m had to be steadied off the heels of RUFUS.

THE ENGINEER (K. Bishop) – slow to begin

**WINDSOR CUP** (R. Hurdle) was issued with a severe reprimand for not being fully clear of RUFUS when shifting ground near the 900m. Apprentice R. Hurdle pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100m and was fined \$100.

**PORTO SANTO** – rider J. Holder was reprimanded under AR137(b) in relation to riding his mount out to the end of the race.

**SHEANNA** (J. Kah) – resaddled at barriers (start delayed one minute).

#### RACE 2: ADELAIDE GALVANISING HANDICAP - 1400 metres

**OPTIMIZE** – withdrawn by Stewards at 9.25 am on Veterinary advice – respiratory infection.

**BEAU RIVAGE** (J. Holder) – jumped awkwardly.

WICKED PROMISE (C. Lindop) – slow to begin.

**SPIRITED MATCH** (E. Finnegan) – raced keenly in early and middle stages. A post-race veterinary examination revealed the gelding had bled from one nostril. Required to gallop 1000m in presence of a Steward.

#### RACE 3: MELBOURNE CUP LIVE RACING AT MORPHETTVILLE HANDICAP - 1400 metres

**LADY SILHOUETTE** (S. Price) – held up 500m to 200m when racing behind MACCY FIELDS and inside BEAU'S MY BOY. Shifted out in vicinity of 50m onto MACCY FIELDS. S. Price was issued with a reprimand under AR137(a).

**BURGUNDY BLAST** (C. Lindop) – keen in the early and middle stages. A post-race veterinary examination revealed no visible abnormalities.

**COACHELLA (NZ)** (M. Neilson) – restless in barriers (start delayed one minute). A pre-race veterinary examination ruled the mare fit to race. Warning issued.

**MISS JOOLIA** (E. Boyd) – slow to begin. Laid out throughout. A post-race veterinary examination revealed no visible abnormalities.

**MACCY FIELDS** (J. Kah) – Steadied in vicinity of 50m to avoid heels of LADY SILHOUETTE. Lost near hind plate during event.

**MUMBLE BEE** (W. Kerford) – Slow to begin.

## RACE 4: MASTER BUILDERS HANDICAP - 2250 metres

**CRUZ'N NOW** – rider J. Frew was reprimanded under AR137A(4)(b) for using his whip in an action that raised his arm above shoulder height.

**ALLEZ TARA** (M. Neilson) – rider explained the gelding had raced keener than at its most recent start and when placed under pressure in the straight he had become concerned with its action. A post-race veterinary examination of ALLEZ TARA revealed no visible abnormalities.

**FIVE TO MIDNIGHT** (C. Lindop) – performed poorly – a post-race veterinary examination revealed a lower than expected heart rate.

**TUNES** (S. Carr) – held up from the vicinity of the 300m until inside the 200m when racing behind ALLEZ TARA and inside LONCAVA (NZ). S. Carr pleaded guilty to a charge of Careless Riding under AR137(a) in that she shifted out in the vicinity of the 150m when insufficiently clear of UNCLE BUCK, which was forced to be checked to avoid the heels of TUNES. S. Carr was suspended from riding in races for a period to commence at midnight on Saturday, 31 October and to conclude at midnight on Thursday, 5 November 2015; a period of three (3) meetings.

**UNCLE BUCK** (J. Holder) – jumped away awkwardly and raced keenly in the early stages of the event. Held up from the vicinity of the 400m until approaching the 300m when awkwardly placed between the heels of SURGING WAVE and FIVE TO MIDNIGHT. Inconvenienced approaching the 200m when TUNES shifted out. Had to be checked in the vicinity of the 150m to avoid the heels of TUNES.

Correct Weight delayed. J. Holder (UNCLE BUCK) placed third, lodged an objection against TUNES (S. Carr) being declared the winner on the grounds of alleged interference from in the vicinity of the 200m. Protest *dismissed*.

#### RACE 5: AUSTRALIAN INTERNATIONAL 3 DAY EVENT HANDICAP - 1000 metres

**PISTOLIER** (J. Toeroek) – raced wide without cover throughout.

**JENNYFROMTHEBLOCK** (D. Caboche) – slow to begin. Laid out under pressure over the concluding 200m.

**READY SUNSHINE** (T. Pannell) – slow to begin.

#### RACE 6: BRIDGE OF SPIES HANDICAP - 1250 metres

**CAVALOCE** (C. Lindop) – jumped away awkwardly. Lost both fore plates during the event.

#### RACE 6: BRIDGE OF SPIES HANDICAP - 1250 metres (Cont'd)

**SHEEZ ON TOP** (S. Price) – inside the 100m had to be steadied and altered course to avoid the heels of SCANTY, which laid out under pressure.

**ROUSSANNE** (M. Neilson) – rider reported his mount was very short in its action over the concluding 200m. A post-race veterinary examination of ROUSSANNE revealed an elevate heart rate and slow recovery.

**SHISO** (E. Finnegan) – lost off fore plate during event.

**KOODA DUCHESS** (T. Pannell) – inclined to rear on jumping away.

**SAGABELLA** (J. Kah) – Examined by Veterinary Surgeon on arrival at start and ruled fit to race. Jumped away awkwardly. Raced keenly in the early and middle stages of the event. Rider J. Kah explained the mare over-raced in the early and middle stages and when placed under pressure in the straight, failed to respond to her riding and she had become concerned with its action. A post-race veterinary examination of SAGABELLA revealed mild signs of heat stress.

**SCANTY** (S. Carr) – laid out under pressure over the concluding 200m.

CRIMSON CASH (J. Holder) – jumped away awkwardly and slow to begin.

**TRIMENSA** (K. Bishop) – rider reported her saddle shifted back on jumping away placing her at a disadvantage throughout the event.

Correct Weight delayed. S. Price (SHEEZ ON TOP) placed third, wished to view official footage in the straight.

## RACE 7: AKEED MOFEED AT GOLDIN FARMS HANDICAP - 1400 metres

MAGIC BOY (J. Holder) – raced keenly in the early and middle stages.

**OCTOBER DATE** (M. Neilson) – rider explained the gelding raced keenly in the early stages of the event and improved into the race behind MAGIC BOY, however, when placed under pressure in the vicinity of the 400m, failed to respond to his riding and felt short in its action over the concluding 200m. A post-race veterinary examination of OCTOBER DATE revealed no visible abnormalities.

**HELD HOSTAGE** (E. Finnegan) – had difficulty obtaining clear ground in the vicinity of the 600m when unable to shift out to obtain clear ground due to the positioning of MAGIC BOY.

**TILDY LAD** (J. Maund) – jumped away awkwardly.

**COUNTER SPIN** (C. Lindop) – hampered on jumping away when tightened onto YOU ROCK.

#### RACE 8: MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres

**REWIND TIME** (E. Finnegan) – jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**AMICONI ORIGINALE** (M. Neilson) – slow to begin. Rider reported the gelding felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

**IMPULSE DIAVOLO** (J. Holder) – contacted on jumping away. Lost near fore plate during event.

MERRY CHRISTMAS (S. Carr) – lost off hind plate during the event.

**ATOMIC HERO** (K. Bishop) – jumped away awkwardly. Near the 250 metres became awkward and had to be steadied when tightened by IMPULSE DIAVOLO, which rolled in.

**SOUND ALIBI** (T. Pannell) – raced wide without cover throughout.

Correct Weight delayed. C. Lindop (PEPPER THE PIN) placed second wished to view official footage in the straight.
