Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 5 December 2015

RACE 1 : GORDON ORMANDY BRIAN LEAHY HANDICAP - 2006 metres

LUNAYIR (FR) (J. Allen) – in the vicinity of the 300 metres had to be steadied when disappointed attempting a tight run between the heels of MARTIAN (IRE) and HELD HOSTAGE, which rolled in.

DIAMOND DUKE (H. McKechnie) - Raced keenly in the early and middle stages of the event. Rider reported the gelding felt flat. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : GARY RADFORD FAMILY BROKEN HILL HANDICAP - 1800 metres

EASY DRAMA (E. Finnegan) - awkward to begin and raced wide without cover in the early stages of the event.

BOYS GETAROUND HIM (J. Toeroek) – rider reported the gelding hung out during the event.

TINTAGLIA (J. Holder) – rider reported the mare was under pressure from in the vicinity of the 500 metres, failed to respond to his riding, thereafter raced flat and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

HILL TOP HOOLIGAN (K. Bishop) – slow to begin. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms K. Byrnes advised, in view of poor performance, the gelding must trial to the Stewards satisfaction prior to presenting for a future race. Ms Byrnes advised the gelding will be retired.

INTOSSICARE (Z. Spain) - rider reported the mare hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SEPTEMBER STORM (C. Lindop) - a post-race veterinary examination revealed the mare to be lame in the off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 3 : WOLF BLASS WINES MAIDEN PLATE - 1050 metres

BOW NOCULARS (R. Maloney) – taken out on jumping away inconveniencing ZIP STRYKER. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BRIMARVI EQUIADA (M. Neilson) – shifted out on jumping away contacting BOW NOCULARS.

DAREBEN HALARO (S. Cahill) - jumped away awkwardly. Sprung its off fore plate on return to scale.

DYLAN JACK (J. Potter) - jumped away awkwardly and slow to begin.

RACE 3 : WOLF BLASS WINES MAIDEN PLATE - 1050 metres (Cont'd)

FINKE (T. Pannell) – knuckled on jumping away.

MAYBE THIS TIME (E. Finnegan) – wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SENECA'S PRIDE (D. Caboche) - A post-race veterinary examination revealed an upper respiratory noise and an elevated heart rate. Veterinary Certificate of Fitness required prior to trial or race.

WINGARD'S MARK (J. Kah) - jumped away awkwardly.

ALASKAN JADE (J. Maund) – difficulty in obtaining clear ground in the vicinity of the 300 metres when racing behind BOW NOCULARS and inside ZIP STRYKER. Rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

ZIP STRYKER (Z. Spain) – inconvenienced on jumping away. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : PENNA MICHAEL CHARTERED ACCOUNTANTS HANDICAP - 1506 metres

QUICK LOVER (E. Finnegan) – slow to begin.

MISS MARGARITA (E. Boyd) - jumped away awkwardly. Rider explained her instructions were to attempt to follow COACHELLA (NZ) in the early and middle stages. After initially obtaining a position behind this mare, MISS MARGARITA was then off the bridle for a short distance and as a consequence she was a little further back than intended. She added the mare was again off the bridle for a short distance in the vicinity of the 700 metres but thereafter finished the race off strongly over the concluding stages. Trainer confirmed the instructions. A post-race veterinary examination revealed no visible abnormalities.

MACCY FIELDS (J. Kah) – had to be eased and altered course to the outside of HAZY LANE near the 1200 metres. Rider reported her mount hung out during the event. A post-race veterinary examination revealed no visible abnormalities.

HAZY LANE (J. Toeroek) – shifted in near the 1200 metres across the running of MACCY FIELDS when insufficiently clear. Rider reminded of his obligations. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : CONSOLIDATED PAINT & QUARRIES HANDICAP - 1050 metres

The start of this event was delayed approximately two minutes owing to D. Gauci, the rider of MAASAI JUSTICE, being stuck in the face by his mount en route to the barriers and having to be attended to by the First Care Medical Personnel. MAASAI JUSTICE underwent a pre-race veterinary examination which revealed the gelding to be lame in the off foreleg. Acting on this advice MAASAI JUSTICE was declared a late scratching by order of Stewards at 3.28 pm.

LUCKY SYMBOL (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

WHAT'S IN A NAME (J. Kah) – as the gelding had not raced since November 2014 it underwent a pre-race veterinary examination and was passed fit to race. Slow to begin.

NORDIC ECLIPSE (Z. Spain) – lost its off fore plate during the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

D. Gauci was again examined by First Care Medical Personnel and the Club Doctor and declared unfit to fulfil his remaining engagements.

RACE 6 : HAIGH WYLIE MEMORIAL HANDICAP - 1600 metres

CHESTNUT CHARLIE (S. Carr) - dislodged rider en route to the barriers. Underwent a pre-race veterinary examination ruled fit to race. Rider examined by First Care Medical Personnel and passed fit to ride. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

RIVERS'S LANE (D. Caboche) – lost its position on jumping away when tightened onto CHESTNUT CHARLIE. Lost its near fore plate during the event.

FLOW METER (Z. Spain) – shifted out on jumping away tightening RIVER'S LANE. Hung out in the straight.

IT AND A BIT (J. Holder) – difficulty obtaining clear ground shortly after the entrance to the straight.

ST GABRIEL (W. Kerford) - A post-race veterinary examination revealed no visible abnormalities.

IZENASHARK (J. Toeroek) - A post-race veterinary examination revealed no visible abnormalities.

RACE 7 : QUAYCLEAN STAKES - 1200 metres

ESSAY RAIDER (C. Lindop) – dipped on jumping away. Rolled in near the 200 metres onto WHITLAM. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

KUSHADASI (J. Toeroek) – as the gelding had not raced since December 2014 it underwent a pre-race veterinary examination and was passed fit to race. Slow to begin.

WHITLAM (S. Cahill) – in the vicinity of the 200 metres was inconvenienced and had to be steadied when ESSAY RAIDER rolled in. Had difficulty obtaining clear running thereafter and was untested to the line.

KARACATIS (C. Jones) – rolled out near the 800 metres and bumped MOSS'N TIME. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

COUNTRYMAN (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

DUBAWI GOLD (R. Maloney) - a post-race veterinary examination revealed no visible abnormalities.

MOSS'N TIME (J. Potter) - contacted near the 800 metres.

DOUBLE POCKETS (W. Kerford) – slow to begin.

HANK'S NEPHEW (J. Kah) – held up from the entrance to the straight until approaching the 200 metres.

JENNYFROMTHEBLOCK (Z. Spain) – shifted in on jumping away contacting BRIMARVI PRINCE.

BRIMARVI PRINCE (E. Finnegan) – contacted on jumping away.

SILENT WHISPER (J. Maund) – raced keenly in the early and middle stages of the event.

RACE 8 : ZONTE'S FOOTSTEP HANDICAP - 1200 metres

MARCO POLO (D. Caboche) – raced in restricted room for a short distance approaching the 100 metres between OUR EXCHANGE and LIVING LARGE (NZ).

TIPPERARY LIL (S. Cahill) – slow to begin. Was held up from the entrance to the straight until the vicinity of the 200 metres.

RACE 8 : ZONTE'S FOOTSTEP HANDICAP - 1200 metres (Cont'd)

LIVING LARGE (NZ) (J. Holder) – wide without cover throughout the event. Was tightened in the vicinity of the 100 metres when racing between MARCO POLO, which shifted out and TIPPERARY LIL, which rolled in.

HOUSE OF WAX (T. Pannell) – was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

TUSCAN RANGER - was a late scratching at 12.55 pm due to transport difficulties.

BIG MAN (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SWINGING SOLDIER (J. Kah) – lost its near fore plate during the event.

PENDLEBURY (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

ROUSSANNE (S. Carr) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

DANOULI (Z. Spain) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.
