<u>Report on Race Meeting held at Morphettville Parks Racecourse</u> by the South Australian Jockey Club on Saturday, 12 December 2015

RACE 1 : BOOK FIESTA ON THE GREEN 18/12 HANDICAP - 2400 metres

LUCKZAT (NZ) (K. Walters) – obliged to alter course approaching the 400m.

TUNES (C. Lindop) – inside the 500m rolled in and away from TRIPLE GOLD, which shifted in. inconveniencing GRAND ARMADA. Rider reminded of her obligations when her mounts commence to shift ground in future.

TRIPLE GOLD (D. Tourneur) – shifted in inside the 500m, inconveniencing TUNES, which was taken in onto GRAMD ARMADA, which had to be steadied. Rider issued with a reprimand. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100m and was reprimanded. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr. P. Moody, advised Veterinary Certificate of Fitness required

GRAND ARMADA (T. Pannell) – inside the 500m, obliged to take hold to avoid the heels of TUNES, which rolled in and away from TRIPLE GOLD, which shifted in. Shortly thereafter approaching the 400m became awkward when buffeted between MONS ABILA, which rolled out, and SIR DYLAN, which maintained its line, and lost its position. As a consequence LUCKZAT (NZ), which was following, was obliged to alter course to the outside of SIR DYLAN. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. First Aid was administered. Trainer, Mr. T. McEvoy, advised Veterinary Certificate of Fitness required.

RACE 2 : CAMPOLINA STUD HANDICAP - 1950 metres

MASTER OF MONEY (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

GUILTY AS CHARGED (Z. Spain) – rider pleaded guilty to a charge under AR137A(5)(ii) for using his whip on more than five occasions prior to the 100m and was fined \$200. A post-race veterinary examination revealed no visible abnormalities.

UNICAJA (NZ) (K. Walters) – rider pleaded guilty to a charge under AR137A(5)(a)(i) for using her whip on consecutive occasions prior to the 100m and was issued with a reprimand. Rider pleaded guilty to a charge under AR137A(5)(a)(i) for using her whip on more than five occasions prior to the 100m and was fined \$100.

RACE 3 : ADELAIDE GALVANISING HANDICAP - 1250 metres

SCHIZLE (D. Caboche) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100m and was reprimanded. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr. R. Balfour, advised Veterinary Certificate of Fitness required.

CHOSEN ANGEL (J. Holder) – held up from the entrance to the straight until in the vicinity of the 150m.

ENCHANTING BEAUTY (C. Lindop) – a post-race veterinary examination revealed no visible abnormalities.

COBBER (T. Pannell) – held up for a short distance approaching the 400m. At the entrance to the straight, shifted out to improve and contacted TZAREVNA, which was hampered. Shifted out under pressure over the concluding stages, inconveniencing TZAREVNA.

TZAREVNA (E. Boyd) – hampered at the entrance to the straight. Inconvenienced over the concluding stages. Rider pleaded guilty to charges under AR137A(5)(a)(i) for using her whip on consecutive occasions prior to the 100m and AR137A(5)(a)(i) for using her whip on more than five occasions prior to the 100m and was reprimanded.

RACE 4 : HOLDFAST INSURANCE HANDICAP - 1550 metres

GRAVITATIONAL (E. Finnegan) – shifted in under pressure in the vicinity of the 300m, tightening HEIDI STAR. Rider issued with a severe reprimand and advised to take greater care when shifting ground in future.

YOU ROCK (D. Caboche) – raced wide without cover in the early and middle stages.

GOLDEN BUCKLEBOO (J. Toeroek) – laid out throughout the event. Rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MARYORE (D. Tourneur) – improved into a tight run between GOLDEN BUCKLEBOO and HEIDI STAR in the vicinity of the 300m. Rider issued with a severe reprimand and advised to take greater care when shifting ground in future. A post-race veterinary examination revealed the mare to be lame in the off foreleg. First Aid administered. Trainer, Mr. P. Blanch, advised Veterinary Certificate of Fitness required.

HEIDI STAR (Z. Spain) – in the vicinity of the 300m, tightened for running between GRAVITATIONAL, which shifted in under pressure, and MARYORE, which improved into a tight run between GOLDEN BUCKLEBOO and HEIDI STAR. As a consequence was buffeted between GRAVITATIONAL and BUCKLEBOO, became unbalanced, had to be steadied and lost its position.

RACE 5 : TED DIXON FAREWELL TOUR HANDICAP - 1400 metres

HIOCTDANE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

DEFIANT ANGEL (E. Finnegan) – raced in restricted room over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

DOUBLE POCKETS (M. Neilson) – raced keenly and wide without cover in the middle stages of the event.

SWIFT SHADOW (D. Tourneur) – a post-race veterinary examination revealed the gelding had suffered a bi-lateral bleeding attack. Trainer, Mr. G. Searle, advised the gelding now suspended from racing for a period of three months in accordance with AR53A.

RACE 6 : ROSS YOUNG MEMORIAL HANDICAP - 1250 metres

MOSS'N TIME (A. Doyle) – rider explained his instructions were to take up a forward position and he intended to attempt to obtain a position one out, one back. He added that in the circumstances, he would have preferred to settle slightly further back to the outside of the leader but owing to the manner in which the gelding raced, he was unable to bring the horse back and was obliged to race more forward than intended. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : ROSS YOUNG MEMORIAL HANDICAP - 1250 metres (Cont'd)

KING'S PARDON (C. Jones) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$100.

RACE 7 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1000 metres

Correct Weight for this event delayed to allow Stewards to review the official footage of the start.

SHIP'S CAPTAIN (D. Caboche) – contacted rail in mounting enclosure. A pre-race veterinary examination ruled the gelding fit to race.

DAUNTING DANCER (E. Boyd) – in the vicinity of the 400m raced in restricted room when racing behind JUST KAPPY and inside REGAL SPUR and was obliged to steady for a number of strides. Had difficulty obtaining clear running from in the vicinity of the 200m until approaching the 50m.

MISS ADELE (C. Jones) – failed to muster early speed and was unable to maintain contact with the field in the early and middle stages despite the efforts of its rider. Rider reported the mare was tardy to begin, but finished the race off strongly. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer, Mr. J. Hyam, advised a Veterinary Certificate of Fitness required.

GO'EN HOFF (J. Cartwright) – became very awkward in the vicinity of the 700m, brushed the running rail and unbalanced rider for a number of strides. Rider reported his mount may have been struck by a clod of dirt during the event. A post-race veterinary examination revealed no visible abnormalities.

TINTAGEL ROCKER (D. Tourneur) – held up for clear running from inside the 600m until in the vicinity of the 200m.

ROCK OUT (E. Finnegan) – fractious in its barrier stall and as a consequence was slow to begin, losing three to four lengths.

RACE 8 : SCHWEPPES HANDICAP - 1300 metres

COOL MAVERICK (D. Caboche) – shifted ground over the concluding stages taking PEPPER THE PIN wider on the track. Rider was reminded of his obligations when shifting ground in future.

PRIMITIVE MAN (A. Doyle) – slow to begin. Raced wide without cover throughout the event.

KINETIC ENERGY (E. Finnegan) – contacted with RATIONALITY on jumping away. Became very awkward in its action, brushed the running rail in the vicinity of the 700m and thereafter lost contact with the field and was eased out of the event from in the vicinity of the 300m. Rider reported the gelding did not stride out in its normal manner and she became concerned with its action and for that reason eased it out of the event. A post-race veterinary examination revealed no visible abnormalities.

MR LIBERTY (C. Jones) – Trainer Mr. N. Smart advised he would instruct rider to attempt to obtain a position on pace with cover if possible.

 $\ensuremath{\text{PRESIDIUM}}$ (J. Toeroek) – got its head up and raced ungenerously for a short distance inside the 1000m.

CON'S GOLD (J. Kah) – Trainer, Mr. J. MacMillan, advised he would instruct rider to attempt to obtain a position with cover. Tongue tie had to be replaced on arrival at the barriers.

PEPPER THE PIN (Z. Spain) – shifted ground over the concluding stages and shortly after passing the winning post REDENTES EDGE, which was following, became awkward on the heels of PEPPER THE PIN. Rider reminded of his obligations when shifting ground in future.

REDENTES EDGE (E. Boyd) – approaching the 1000m taken out by COOL MAVERICK, which rolled out, and raced awkwardly inside the heels of PEPPER THE PIN for a number of strides. Held up for a short distance approaching the 400m and thereafter had difficulty obtaining clear running for a short distance after the entrance to the straight.

RATIONALITY (D. Tourneur) – contacted with KINETIC ENERGY on jumping away.
