Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 6 February 2016

RACE 1: EXELSUPER THREE-YEAR-OLD MAIDEN PLATE - 1200 metres

ALBERDINI (C. Jones) – jumped away awkwardly.

BATTLE BREWING (C. Lindop) – raced keenly in the middle stages.

CARSON (NZ) (D. Tourneur) – jumped away awkwardly.

GOODBYE GOOD LUCK (J. Maund) – slow to begin.

SIMON THE LIKEABLE (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SUPER BAG (J. Childs) - a post-race veterinary examination revealed a higher than expected heart rate otherwise no visible abnormalities. Trainer, Mr. D. Dodson, advised Stewards the gelding will now be spelled.

DARK ELIXIR (D. Caboche) – over-raced in the early and middle stages.

RACE 2: UBET ADELAIDE CUP 14 MARCH HANDICAP - 1600 metres

HAZY LANE (E. Boyd) – laid out under pressure over the concluding 200m. Rider reminded of her obligations when her mounts commence to shift ground. A post-race veterinary examination revealed no visible abnormalities.

TIMES PAST (R. Hurdle) – jumped away awkwardly and shortly after inconvenienced by ASK ME HOW I KNOW, which shifted out.

DAREBEN HALARO (S. Cahill) – raced keenly in the early and middle stages.

MAIL IT IN (C. Lindop) - inconvenienced over the concluding 100m when HAZY LANE shifted out.

DIVINE WEAVER (J. Holder) – raced keenly and wide without cover in the early and middle stages.

MAXALICIOUS (J. Potter) raced keenly in the early and middle stages.

Correct Weight for this event was delayed to allow C. Lindop (MAIL IT IN), placed third, to view the official footage in the straight.

RACE 3: CYCLING FOR SIMONE SPRINT - 1000 metres

DYLANSON (D. Tourneur) - shifted in and away from SWINGING ARMS inside the 100m onto STRATUMSPHERE.

SWINGING ARMS (P. Gatt) – laid in under pressure in the straight and approaching the 100m, shifted in towards DYLANSON. A post-race veterinary examination revealed no visible abnormalities.

RED ECLIPSE (C. Lindop) – slow into stride.

STRATUMSPHERE (C. Jones) – inside the 100m had to be steadied when tightened onto SANDHILL FLASH by DYLANSON.

SANDHILL FLASH (J. Maund) – dipped on jumping away. Inconvenienced inside the 100m.

Correct Weight for this event was delayed to allow D. Tourneur (DYLANSON), placed second, to view the official footage in the straight.

RACE 4: QUAYCLEAN HANDICAP - 1540 metres

BOYS GETAROUND HIM (E. Finnegan) – held up from the vicinity of the 600m until near the 150m when racing behind PRESIDIUM and inside SPIRITOF ENDEAVOUR (USA).

FORCE OF THREE (R. Hurdle) – raced keenly in the early and middle stages.

ANURADHA (J. Potter) – jumped away awkwardly and slow to begin.

RACE 5: FARMERS UNION ICED COFFEE HANDICAP - 2500 metres

GRAVITATIONAL (E. Finnegan) – near the 500m taken out onto SPYING ON YOU (NZ). Rider explained she got further back than anticipated due to the barrier draw and the tempo of the race. She added when the field quickened in the vicinity of the 800m, the gelding had not quickened as she had hoped and had finished the event off only moderately. She added, in her opinion, GRAVITATIONAL is better suited in races that have a faster tempo. A post-race veterinary examination revealed a very poor recovery.

BELLA SPOSA (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

SPYING ON YOU (NZ) (D. Caboche) – slow to begin. Near the 500m had to be eased across the heels of BELLA SPOSA when taken out by GRAVITATIONAL. A post-race veterinary examination revealed an abraded skin area behind the girth area.

READY ME FEIN (E. Boyd) – slow to begin. Raced keenly in the early and middle stages. Held up throughout and near the 500m shifted out onto GRAVITATIONAL. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: WWW.CYCLINGFORSIMONE.COM BM70 - 1000 metres

The start of this race was delayed approximately two minutes.

EL PRADO GOLD (A. Doyle) – slow into stride. Had difficulty obtaining clear ground from the 400m until near the 200m. A post-race veterinary examination revealed a puncture wound to the near fore pastern. Frist Aid administered.

SHIP'S CAPTAIN (D. Caboche) - shifted out on jumping away and bumped IMPULSE BUY.

OUR SNIPPY (C. Jones) – rolled out marginally near the 200m onto BLONDE MISSILE.

NORDIC ECLIPSE (Z. Spain) – fractious in barriers after being loaded. A pre-race veterinary examination ruled the gelding fit to race.

RACE 6: WWW.CYCLINGFORSIMONE.COM BM70 - 1000 metres (Cont'd)

MISTER ROCKSTAR (J. Childs) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr. D. Jolly, was advised a Veterinary Certificate would be required prior to trial or race.

IMPULSE BUY (J. Kah) – contacted on jumping away. Held up in the vicinity of the 500m until near the 200m when racing behind ARDERE and inside WILANDER PRINCESS. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Ms. P. Trenwith, was advised a Veterinary Certificate of Fitness would be required prior to trial or race.

BLONDE MISSILE (J. Bowditch) – near the 200m attempted a tight run between OUR SNIPPY, which rolled out marginally, and MANHATTAN PRINCE, which was forced to steady momentarily as it commenced to give ground. J. Bowditch issued a severe reprimand. Lost near fore plate during the event.

ARDERE (T. Pannell) – raced wide without cover throughout.

MANHATTAN PRINCE (D. Tourneur) – near the 200m had to be momentarily steadied off the heels of BLONDE MISSILE as it commenced to give ground. A post-race veterinary examination revealed no visible abnormalities.

Correct Weight for this event was delayed to allow A. Doyle (EL PRADO GOLD) placed third and Trainer Mr. R. Balfour, to view the official footage in the straight.

RACE 7: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1800 metres

GAMBLIN' GURU (J. Holder) - tightened on jumping away.

KUSHADASI (P. Gatt) – jumped away awkwardly.

JIM'S JOURNEY (D. Tourneur) – had difficulty obtaining clear ground over the concluding 100m. A post-race veterinary examination revealed no visible abnormalities.

LUCKY LUCKY LUCKY (T. Pannell) – unable to obtain clear ground over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

WHAT'S IN A NAME (J. Bowditch) – slow to begin. Had difficulty obtaining clear ground in the straight. Taken in near the 50m onto SATURDAY SORCERER by HIOCTDANE.

HOYLAKE (NZ) (Z. Spain) – inconvenienced on jumping away.

USTINOV'S FURY (J. Potter) – shifted out on jumping away onto GAMBLIN' GURU, which was taken out onto HOYLAKE (NZ). Raced fiercely in the early and middle stages of the event and extended its lead on the field despite the efforts of its rider.

SATURDAY SORCERER (C. Lindop) – raced keenly in the early stages. Raced in restricted room over the concluding 50 metres when tightened by WHAT'S IN A NAME.

Correct Weight for this event was delayed to allow C. Lindop (SATURDAY SORCERER) placed sixth, to view the official footage in the straight.

RACE 8: UBET HANDICAP - 1200 metres

DEBEERSONUS (C. Jones) – jumped away awkwardly. Raced wide without cover throughout the event.

DUCKWORTH (R. Hurdle) – lost significant ground approaching the 900m when severely checked off the heels of ON A DREAM, which lost ground and shifted out abruptly. A post-race veterinary examination revealed the gelding to be lame in the off fore and near hind legs. Trainer Mr. J. O'Connor was advised a Veterinary Certificate of Fitness would be required prior to trial or race.

PRONTO PRONTO (S. Cahill) - jumped away awkwardly.

RACE 8: UBET HANDICAP - 1200 metres (Cont'd)

SET FOR A BUNDLE (K. Brooks) - jumped away awkwardly. A post-race veterinary examination revealed minor laceration to the off hind leg, consistent with the gelding having been galloped on, and signs of "thumps". First Aid was administered.

ALCOBRO (J. Toeroek) – raced wide without cover throughout the event.

BEAU'S MY BOY (J. Kah) - slow to begin. Raced fiercely in the early and middle stages. Near the 1000m shifted in and brushed with ON A DREAM and shifted out, contacting the hindguarters of CARASHAN GIRL, turning that mare in slightly. Shortly after BEAU'S MY BOY shifted in abruptly across the running of ON A DREAM. Inside the 800m improved onto the heels of COOL MAVERICK despite the efforts of its rider and had to be steadied for a number of strides. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr. J. O'Connor, was advised the gelding would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race.

COOL MAVERICK (T. Pannell) - had to be steadied momentarily near the 700m and in doing so shifted out and brushed CARASHAN GIRL. A post-race veterinary examination revealed an abrasion just above the point of the near hind hock. First Aid was administered.

ON A DREAM (C. Lindop) - in the vicinity of the 1000m had to be checked severely to avoid the heels of BEAU'S MY BOY and in doing so lost its action, became unbalanced and lost several lengths. A post-race veterinary examination revealed an abrasion to the inside near hind fetlock.

PEPPER THE PIN (Z. Spain) - approaching the 1000m shifted in onto SET FOR A BUNDLE, which was taken in, brushing CARASHAN GIRL. Z. Spain was reminded of his obligations when his mounts commence to shift ground. Approaching the 700m shifted in onto COOL MAVERICK. Z. Spain was issued with a reprimand.
