RACE 1 : QUAYCLEAN HANDICAP - 2000 metres

KOURKAM (FR) (D. Dunn) - a post-race veterinary examination revealed no visible abnormalities.

RIVER'S LANE (T. Pannell) – raced keenly in the early stages of the event whilst being restrained.

TIDY PROPHET (C. Williams) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

HAVE PLENTY (J. Bowditch) – raced keenly in the middle stages of the event.

RACE 2 : MAC DRINK DRIVING? GROW UP HANDICAP - 1600 metres

KINGDOMS (NZ) (C. Newitt) – raced keenly in the early and middle stages of the event. Stewards questioned C. Newitt in relation to his riding of the gelding, particularly after entering the straight. He explained he had been instructed to find a position in the field where the gelding would relax, which he was able to achieve. He added that after entering the straight he had elected to follow BURNRO into the race, however, his mount had only been one paced and he had difficulty obtaining clear ground at various stages to the finish. He stated he had considered attempting to improve to the outside of BURNRO, however, due to the composition of the field felt that he would not be able to find clear ground. When questioned as to why he had not elected to improve to the inside of BURNRO approaching the 200m, he explained his mount would not have been able to quicken enough to obtain that position. Stewards noted C. Newitt's explanation but advised him that he had been too single minded after entering the straight and in future he should ride in a manner that does not invite question. A post-race veterinary examination revealed no visible abnormalities.

ZEBRINZ (C. Parnham) - a post-race veterinary examination revealed the gelding had quartered its off hind heel bulb. First Aid was administered.

TONOPAH (USA) (D. Yendall) – held up from the entrance to the straight until the 200m when it shifted out onto ILOVEWHATSEBRINGS, which had to be steadied. D. Yendall was severely reprimanded and advised to take greater care when shifting ground in future.

FLOW METER (J. Bowditch) – inconvenienced approaching the 100m.

RACE 2 : MAC DRINK DRIVING? GROW UP HANDICAP - 1600 metres (Cont'd)

ILOVEWHATSEBRINGS (T. Pannell) – had to be steadied in the vicinity of the 200m when TONOPAH (USA) shifted out.

TENERE (D. Tourneur) – raced keenly in the early and middle stages of the event. Rolled in approaching the 100m onto FLOW METER.

EMMOOKI'S DASH (J. Kah) – approaching the 100m was forced to race in restricted room for a number of strides to the inside of FLOW METER, which had been taken in by TENERE, and behind EXCITES ZELADY.

RACE 3 : SEVEN NEWS QUEEN ADELAIDE STAKES - 1050 metres

VICTORY EIGHT (NZ) (L. Nolan) – in the vicinity of the 400m rolled out slightly away from ONE BLINK.

HE'S GOT SPUNK (C. Robertson) – in the vicinity of the 400m became awkward in its action and lost ground of its own accord when racing in restricted room between VICTORY EIGHT (NZ) and TRIS. A post-race veterinary examination revealed a minor laceration to the off hind leg.

ONE BLINK (I. Gundogdu) – rolled out in the vicinity of the 400m.

TRIS (M. Neilson) – fractious in barriers after being loaded and reared. A post-race veterinary examination revealed the filly had bled from the off side nostril. After reviewing the start, in conjunction with the Veterinary Surgeon, Stewards were comfortable that the presence of blood was attributable to external trauma.

SYLPHEED (K. McEvoy) – in the vicinity of the 400m became unbalanced when contacted by POSH JOURNEY.

EXILIA MISS (NZ) (S. Baster) – in the vicinity of the 300m had to take hold and lost its position when INVISIBLE GIRL shifted in under riding. A post-race veterinary examination revealed no visible abnormalities.

POSH JOURNEY (R. Hurdle) – approaching the 400m was forced to steady off the heels of HE'S GOT SPUNK, which lost ground, and in being steadied, shifted out abruptly, making heavy contact with SYLPHEED. Laid in under pressure in the straight and inside the 200m shifted in onto TRIS, which was inconvenienced. R. Hurdle was reminded of his obligations when shifting ground in future.

INVISIBLE GIRL (J. Bowditch) – shifted in under riding in the vicinity of the 300m onto EXILIA MISS (NZ), which was forced to take hold and lost its position. J. Bowditch pleaded guilty to a charge of Careless Riding in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 8 May and to conclude at midnight on Friday, 13 May 2016; a period of three (3) meetings. Rider reported he became concerned with the filly's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : DC MCKAY STAKES - 1100 metres

NOSTRADAMUS (D. Tourneur) – shifted in abruptly on jumping away and bumped THERMAL CURRENT.

THERMAL CURRENT (D. Lane) – bumped by NOSTRADAMUS on jumping away and taken in onto DAYTONA GREY.

THE MESSINA NYMPH (K. McEvoy) - a post-race veterinary examination revealed a higher than expected heart rate.

I AM GYPSY (R. Hurdle) – jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

DAYTONA GREY (C. Lindop) – contacted on jumping away. Raced keenly in the early and middle stages.

SCRATCHY LASS (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5 : UBET STAKES - 1200 metres

SOOBOOG (B. Rawiller) – slipped behind on jumping away and was slow into stride. Raced keenly in the early and middle stages of the race. In the vicinity of the 200m shifted out and away from MISS GUNPOWDER onto ALMIGHTY GIRL.

BROCKHOFF (L. Nolen) – rolled out in the vicinity of the 200m onto MISS GUNPOWDER.

COUNTER PULSE (C. Lindop) – obliged to alter course in the vicinity of the 50m to the inside of FAATINAH, which laid out.

MR INDIVIDUAL (M. Zahra) - a post-race veterinary examination revealed the colt to be lame in the near foreleg. Co-Trainers Messrs L. & T. Corstens were advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

FAATINAH (M. Neilson) – laid out under pressure over the concluding 100m.

BEAU RIVAGE (J. Toeroek) – in the vicinity of the 200m had to be steadied off the heels of ALMIGHTY GIRL, which shifted out and away from SOOBOOG.

MISS GUNPOWDER (D. Tourneur) – jumped away awkwardly. In the vicinity of the 200m shifted out and away from BROCKHOFF.

ALMIGHTY GIRL (G. Boss) – rider reported the filly had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight, failed to respond to his riding and in his opinion may have come to the end of its preparation. A post-race veterinary examination revealed an elevated heart rate.

SUPER CASH (K. McEvoy) – slow to begin. Shifted out slightly at the entrance to the straight onto JALAN JALAN. K. McEvoy was reminded of his obligations when shifting ground in future.

JALAN JALAN (M. Payne) – laid in, in the straight. At the entrance to the straight laid in across the heels of SUPER CASH, which shifted out slightly, and had to be momentarily steadied. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : SCHWEPPE OAKS - 2000 metres

The start of this race was delayed approximately two minutes.

PASADENA GIRL (NZ) (D. Lane) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SACRED EYE (D. Dunn) – contacted near the 300m.

FIRST IMPRESSIONS (NZ) (G. Smith) – reared on jumping away and slow into stride.

ASINARA (G. Boss) – slow to begin. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

BELUGA BLUE (C. Lindop) – raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

JACQUI'S JOY (NZ) (M. Zahra) – Co-Trainer Mr. M. Beer advised Stewards, with the addition of blinkers for the first time today, he would instruct M. Zahra to attempt to ride the filly more forward. Shifted in on jumping away onto RIVERINA BELLA.

ABBEY MARIE (L. Nolen) – hampered on jumping away. Held up from the vicinity of the 500m until approaching the 200m. In the vicinity of the 300m shifted out in an attempt to improve and bumped SACRED EYE.

THE GREY FLASH (J. Bowditch) – shifted out on jumping away onto ABBEY MARIE.

RIVERINA BELLA (C. Newitt) – hampered on jumping away. Raced keenly in the early and middle stages of the event.

RACE 7 : UBET CLASSIC - 1200 metres

The start of this race was delayed approximately one minute.

GRIANTE (C. Williams) – slipped behind on jumping away and was slow to begin.

MISS PROMISCUITY (L. Nolen) – in the vicinity of the 700m clipped the heels of TEMPT ME NOT, knuckled and dislodged L. Nolen. L. Nolen was examined by the First Care Medical personnel and transported to hospital. A post-race veterinary examination revealed no visible abnormalities. Stewards adjourned an inquiry to a date to be fixed to allow L. Nolen to be present.

WAWAIL (D. Lane) – had to be steadied in the vicinity of the 700m to avoid the heels of SCARLET BILLOWS.

PITTSBURGH FLYER (S. Cahill) – made contact with L. Nolen in the vicinity of the 700m. S. Cahill reported his mount was reluctant to stride out after contacting the fallen rider. A post-race veterinary examination revealed no visible abnormalities.

TYCOON TARA (S. Arnold) – slow to begin.

SCARLET BILLOWS (D. Yendall) – had to be steadied in the vicinity of the 700m to avoid the riderless MISS PROMISCUITY. D. Yendall reported his mount didn't stretch out after this incident.

DON'T DOUBT MAMMA (D. Dunn) – lost its off hind plate during the event.

TEMPT ME NOT (G. Schofield) - a post-race veterinary examination revealed a laceration to the off hind cannon. TEMPT ME NOT was transported to the Morphetville Equine Clinic for treatment. Trainer Mr. J. Cummings was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : HUGHES CHAUFFEURS LIMOUSINES QUEEN OF THE SOUTH STAKES – 1600 metres

The start of this race was rescheduled to commence at 5.02 pm.

NO TRICKS (NZ) (S. Baster) – had to be checked approaching the 300m when INTO THE MIST shifted in.

LUCKY LAGO (D. Lane) – slow to begin.

FRENCH EMOTION (C. Williams) – a post-race veterinary examination revealed no visible abnormalities.

INTO THE MIST (J. Holder) – shifted in approaching the 300m into the running line of NO TRICKS (NZ), which had to be checked. J. Holder pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 14 May and to conclude at midnight on Sunday, 22 May 2016; a period of four (4) meetings.

ROCKET COMMANDER (J. Kah) – rolled out at the entrance to the straight onto ZERPRISE JOURNEY.

MEFNOODA (C. Newitt) - a post-race veterinary examination revealed an elevated heart rate.

ZERPRISE JOURNEY (J. Bowditch) – raced keenly in the early and middle stages of the event. Taken out at the entrance to the straight by ROCKET COMMANDER onto JENNIO (M. Payne). A post-race veterinary examination revealed no visible abnormalities.

JENNIO (M. Payne) - had to be steadied at the entrance to the straight when tightened onto METAPHORICAL by ZERPRISE JOURNEY.

RACE 5 : UBET STAKES - 1200 metres

TEMPT ME NOT was withdrawn from this race by Stewards on Wednesday, 4 May 2016 acting under LR14.4.
