Report on Race Meeting held at Morphettville Parks Racecourse by the Balaklava Racing Club on Thursday, 28 July 2016

TRACK: Soft 7 (Downgraded to a Heavy 8 @ 2.02 pm retrospective to Race 3)

WEATHER: Overcast

RAIL: Out 9 metres 1000 metres to winning post, 6 metres to remainder, sectional 612 metres.

RACE 1 : CLASSIC HITS 5CS & MAGIC 1059 / SABOIS MAIDEN PLATE - 1550 metres

GOODBYE GOOD LUCK (J Maund) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

KALAMATA MISS (M Poon) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2 : PLAINS PRODUCER NEWSPAPER / ATKINS PHOTOGRAPHY BENCHMARK 64 HANDICAP - 2250 metres

NO DOUBTFIRE (M Neilson) – rider reported the gelding may not have handled today's underfoot conditions. A post-race veterinary examination revealed no visible abnormalities.

KING CADEL (J Mamat) – inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SPYING ON YOU (NZ) (C Lindop) – shortly after the start rolled out onto KIWI COLLEEN (NZ), which was tightened onto KING CADEL. Lost both hind plates during the running of the event.

KIWI COLLEEN (NZ) (M Poon) – on jumping away tightened onto KING CADEL as SPYING ON YOU (NZ) rolled out.

MAWBY (D Tourneur) – jumped away awkwardly and shifted out.

RACE 3 : MCCRACKEN FORD / SABOIS MAIDEN PLATE - 1250 metres

The start of this event was delayed approximately three minutes.

DOUBTFUL BILLY (J Holder) – approaching the entrance to the straight contacted by JIMMY ROYALE, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : MCCRACKEN FORD / SABOIS MAIDEN PLATE - 1250 metres (Cont'd)

TASKMASTER (P Gatt) – Approaching the entrance to the straight was momentarily inconvenienced as DOUBTFUL BILLY was taken out by JIMMY ROYALE. A post-race veterinary examination revealed no visible abnormalities.

DELIVERY DAY (C Lindop) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Held up for a short distance shortly after the entrance to the straight and thereafter had difficulty in obtaining clear ground inside the 200 metres for several strides.

STRONG PLAY (B. Claridge) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

YA CAN'T TELL 'EM (M Neilson) – Slow to begin.

FINNTUITION (J Kah) - underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

HAYAKU MISS (J Maund) – raced keenly in the early and middle stages of the event.

FROZEN HONOR (K Bishop) – over-raced in the early and middle stages of the event.

JIMMY ROYALE (D Tourneur) – shifted out approaching the entrance to the straight and contacted DOUBTFUL BILLY, which was inconvenienced and taken out. As a result TASKMASTER was momentarily inconvenienced. Rider reprimanded. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : BALAKLAVA TRANSPORT / MID NORTH PARTY HIRE MAIDEN PLATE - 1400 metres

LONDOSTAR (J Kah) - A post-race veterinary examination revealed no visible abnormalities.

NEED PRAGMATISM (J Holder) - jumped away awkwardly. Raced greenly throughout the event. Inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

PARENTIVE - underwent a pre-race veterinary examination in the mounting yard and was reported to be lame in the off hind leg. Acting on this advice Stewards withdrew PARENTIVE at 2.18 pm.

TOTALLY WICKED (Z Spain) - jumped away awkwardly, shifted out and contacted NOT SO LADY LIKE (NZ), which lost its position when tightened onto AUGUSTA BELLE.

AUGUSTA BELLE (D Caboche) - jumped away awkwardly and shifted in contacting NOT SO LADY LIKE (NZ), which lost its position when tightened onto TOTALLY WICKED.

NOT SO LADY LIKE (NZ) (M Poon) – on jumping away lost its position as AUGUSTA BELLE jumped away awkwardly and shifted in and TOTALLY WICKED jumped away awkwardly and shifted out.

RACE 5 : HYLAND RACE COLOURS / BRERETON JEWELLERS / SABOIS F&M MARES BM 64 HCP - 1250 metres

NICCELE (C Lindop) – rider reported the mare may not have handled today's underfoot conditions. A post-race veterinary examination revealed no visible abnormalities.

ANOTHER TWISTER (T Pannell) - A post-race veterinary examination revealed no visible abnormalities.

SHA LA LA (K Bishop) – rider pleaded guilty to a charge under AR137A(5)(a)(i) in that she used her whip in consecutive strides prior to the 100 metres and was reprimanded. She also pleaded guilty to a charge under AR137A(5)(a)(i) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

RACE 5 : HYLAND RACE COLOURS / BRERETON JEWELLERS / SABOIS F&M MARES BM 64 HCP - 1250 metres (Cont'd)

BAIKAL (Z Spain) – laid out rounding the home turn for a short distance.

RACE 6 : EVANS FAEHRMANN PTY LTD CLASS ONE HANDICAP - 1400 metres

PUBLICANS PROMISE (J Kah) - a post-race veterinary examination revealed no visible abnormalities.

BASSONS (P Gatt) - a post-race veterinary examination revealed no visible abnormalities.

CAPITOLINE (Z Spain) – inclined to hang in under pressure in the straight.

BAND PRACTICE (E Finnegan) – rider reported the gelding may not have handled today's underfoot conditions. A post-race veterinary examination revealed no visible abnormalities.

YOUDINI (D Tourneur) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

SWEET SATURDAY – a late scratching by order of Stewards on veterinary advice at 1.10 pm as the mare was lame in the near foreleg.

PITCH DARK (M Poon) – slow to begin losing two to three lengths. Rider reported the mare made an abnormal respiratory noise during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 7 : TADS'S EMBROIDERY SERVICE COLTS, GELDINGS & ENTIRES BENCHMARK 60 HANDICAP - 1250 metres

MARCO POLO (D Caboche) – in the vicinity of the 200 metres was momentarily inconvenienced and was obliged to alter course as RAHEEBA shifted out.

CONCENTRATE (M Neilson) – knuckled shortly after the start. Raced keenly in the early and middle stages of the event. Approaching the finish dipped for no apparent reason. Lost its off fore plate during the running of the event.

RAHEEBA (J. Toeroek) – inclined to shift out under pressure in the straight.

COMBAT DANCER (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

EXTREME SHOT (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

ROCHERE (K Bishop) – underwent a pre-race veterinary examination as it had not raced since June 2015, and was ruled fit to race. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow Trainer Mr R. Balfour and D. Caboche (MARCO POLO) placed second to view the vision in the straight.

RACE 8 : THE RIPPER ROAST RACE / KBL SECURITY BENCHMARK 60 HANDICAP - 1550 metres

TANZEN (C Lindop) - contacted at the start. Over-raced in the early stages of the event. Rider reported that the gelding may not have handled today's underfoot conditions. A post-race veterinary examination revealed no visible abnormalities.

TRICKY AFFAIR (D Caboche) – jumped away awkwardly, shifted out and contacted SILENT MAN.

CATCH ME LATAR (J Toeroek) - contacted at the start by BELLE OF THE SOUTH and was taken out onto ASTRO DAMUS. A post-race veterinary examination revealed an elevated heart rate.

<u>RACE 8 : THE RIPPER ROAST RACE / KBL SECURITY BENCHMARK 60 HANDICAP</u> - 1550 metres (Cont'd)

SILENT MAN (Z Spain) – jumped away awkwardly and shifted in contacting TRICKY AFFAIR, which was taken out onto TANZEN.

CENTRE DIVIDER (D. Tourneur) – rider explained that he had no specific instructions; however, on his own assessment the gelding has previously settled forward when racing over longer distances. On that basis he was content to allow the gelding to settle where comfortable and after beginning well from a wide gate found himself on pace.

IN TAIPEI (M Neilson) - contacted at the start as ASTRO DAMUS was taken out. Rider reported that the gelding may not have handled the underfoot conditions. A post-race veterinary examination revealed no visible abnormalities.

ULTIMATE THRILL (J. Holder) - slow into stride. Rider reported the mare dipped on a number of occasions and never felt comfortable in it's action during the event. He added that after encouraging the mare in the early stages with no response he elected to not ride ULTIMATE THRILL out in his normal manner. A post-race veterinary examination revealed no visible abnormalities. Trainer advised that a warning had been placed on the mare in relation to it being uncompetitive.

ASTRO DAMUS (B Claridge) - inconvenienced at the start when tightened onto IN TAIPEI by CATCH ME LATAR which was taken out by BELLE OF THE SOUTH.

BELLE OF THE SOUTH (M Poon) - jumped away awkwardly and shifted out contacting CATCH ME LATAR.

Correct weight for this event was delayed to allow P. Gatt (MATERIALISED) placed fifth to view the official image.
