Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Sunday, 23 October 2016

RACE 1 : PT LINCOLN BLUE SEAS MOTEL /SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

KLUNKER (J. Mamat) – jumped away awkwardly and was slow to begin.

RACE 2: THANK YOU JUDITH JONES / SABOIS MAIDEN PLATE - 1700 metres

EXALTED TYSON (C. Lindop) – performed poorly, unable to maintain contact with the field. A post-race veterinary examination revealed no visible abnormalities.

INNUENDO (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

SWEET SCHILLY (D. Caboche) – rider shown the vision in relation to the use of his whip in the vicinity of the 200 metres, with particular reference to him using his whip with his arm raised above shoulder height.

RACE 3: GOLDIN FARMS / SABOIS MAIDEN PLATE - 1200 metres

ALL JAZZED UP (J. Holder) - contacted at the start.

BRUNETTE DOWNS (B. Claridge) – taken out approaching the 1000 metres, contacted with AMERITAR and thereafter brushed with AMERITAR for a short distance and approaching the 800 metres shifted in slightly resulting in WANTED BY ALL shifting in and away from that horse onto MOTHERVINE, which was taken across the running of TROOPER JIM, which was inconvenienced.

JIMMYTOWN JEWEL (P. Gatt) - jumped away awkwardly, shifted in and contacted ALL JAZZED UP.

MY FRIEND RILEY (B. Griffiths) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

AMERITAR (J. Huxtable) – contacted and inconvenienced approaching the 1000 metres and thereafter brushed with BRUNETTE DOWNS for a short distance.

RACE 3: GOLDIN FARMS / SABOIS MAIDEN PLATE - 1200 metres (cont'd)

MOTHERVINE (J. Toeroek) – jumped away awkwardly and contacted SAVANETA and approaching the 1000 metres shifted out slightly taking WANTED BY ALL out onto BRUNETTE DOWNS, which was taken out onto AMERITAR resulting in contact between BRUNETTE DOWNS and AMERITAR. Rider reported the mare may have injured its off hind leg during the event. A post-race veterinary examination revealed the mare had an injury to an old wound on its off hind leg.

ONEWOOD (J. Maund) – raced keenly inside the 900 metres.

SAVANETA (A. Jordsjo) - jumped away awkwardly, shifted in and contacted MOTHERVINE.

TROOPER JIM (M. Poon) – inconvenienced approaching the 800 metres.

WANTED BY ALL (D. Caboche) – taken wider approaching the 1000 metres and thereafter approaching the 800 metres was taken in by BRUNETTE DOWNS, which shifted in slightly. Held up for clear running from in the vicinity of the 500 metres until near the entrance to the straight.

RACE 4: COOPERS CLASS TWO HANDICAP - 1200 metres

MIDNIGHT MOON (J. Huxtable) – approaching the 100 metres laid in, shifted in slightly and had to be steadied off the heels of SALTARELLO, which rolled out. Thereafter raced in restricted room to the outside of SALTARELLO for a number of strides.

ANYPORTINASTORM (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

MISS MURRA (A. Jordsjo) – taken in at the start and as a consequence contacted PARTING SHOT. Laid in over the concluding stages resulting in A. Jordsjo having to stop riding and straighten her mount.

PARTING SHOT (D. Tootell) – contacted at the start and taken in across the heels of WHITE JADE, clipped the heels of that gelding and stumbled.

SALTARELLO (M. Poon) – shifted in shortly after the start onto MISS MURRA, taking that horse in onto PARTING SHOT. Rolled out approaching the 100 metres.

RACE 5 : CRABB SHELLGRIT GAWLER SPRINT - 1100 metres

I AM GYPSY (J. Kah) - raced wide without cover in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

MAASAI JUSTICE (Z. Spain) - jumped away awkwardly.

LAST DAY (NZ) (J. Bowditch) – slow to begin losing two to three lengths.

PISTOLIER (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

SUPER FLYER (NZ) (J. Huxtable) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 6: ADELAIDE GALVANISING INDUSTRIES BENCHMARK 60 HCP - 1700 metres

ALDOLPHIN (K. Brooks) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

MIGHTY MAHER (S. Price) – held up for clear ground for a number of strides inside the 500 metres when racing on the heels of GRAND ARROW, which commenced to weaken.

RACE 6: ADELAIDE GALVANISING INDUSTRIES BENCHMARK 60 HCP - 1700 metres (cont'd)

DAREBEN HALARO (B. Claridge) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. Momentarily inconvenienced near the entrance to the straight. Rider reported, in his opinion, the gelding felt sore in front particularly in the near foreleg. A post-race veterinary examination revealed no visible abnormalities.

BETTY BUTTERSCOTCH (P. Gatt) – commenced to buck shortly after the start, lost ground and was eased out by its rider and took no further part in the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms R. Day was advised that in view of the mare's racing manners it would now be required to race in a tractable manner in an Official Trial prior to accepting for a future race.

SISTER ANGEL (J. Holder) – tightened at the start.

LYDIARD (E. Boyd) – shifted out and away from the whip at the entrance to the straight onto DAREBEN HALARO, which was momentarily inconvenienced. Rider stopped riding and straightened her mount.

GRAND ARROW (K. Bishop) – commenced to weaken from near the 500 metres.

RACE 7: SCHWEPPES GAWLER CUP - 1500 metres

DYLANSON (M. Poon) - Rider reported his mount raced keenly in the early stages and was inclined to hang in throughout the event. Approaching the 600 metres attempted to hold its position and contacted with IT AND A BIT for some distance. M. Poon was shown the vision of this incident and was advised not to persist with making contact with other runners as he did on this occasion. A post-race veterinary examination revealed an elevated heart rate.

LITTLE AKIE (J. Holder) – became held up from in the vicinity of the 500 metres, and thereafter raced in restricted room from in the vicinity of the 200 metres, to the outside of FLOW METER which improved into a tight run between IT AND A BIT and DYLANSON, which was inclined to lay in, and was severely hampered for some distance and taken out onto DYLANSON.

FLOW METER (J. Bowditch) — Approaching the 200 metres attempted a tight run between IT AND A BIT, which rolled in slightly, and LITTLE AKIE and contacted LITTLE AKIE for some distance resulting in FLOW METER being severely hampered racing to the 150 metres. As a consequence, LITTLE AKIE was taken out onto DYLANSON turning that horse's hindquarters in the vicinity of the 100 metres resulting in LITTLE AKIE being severely hampered. As a result, DYLANSON shifted out in the vicinity of the 100 metres onto REDEEM BOUNTY, which was hampered and taken out onto EXCITES ZELADY, which in turn was hampered and taken out onto EIGELSTEIN (GB), which was inconvenienced. As a consequence, DOUBLE POCKETS, which was racing behind REDEEM BOUNTY and EXCITES ZELADY became held up for clear running for some distance in the vicinity of the 100 metres and was obliged to shift out to obtain clear running. Lost its near hind plate during the event. J. Bowditch was reminded of his obligations when attempting to improve into restricted room.

EXCITES ZELADY (P. Gatt) – hampered near the 100 metres.

ROYAL RUMBLE (C. Lindop) - slow to begin and thereafter had to be steadied and lost its position when inconvenienced by IT AND A BIT, which shifted in. Shortly after the entrance to the straight became held up between SPARTAN EAGLE and SANDHILL CHIEF and in the vicinity of the 300 metres shifted to the outside of SANDHILL CHIEF to obtain clear running, inconveniencing FLOW METER. C. Lindop was reminded of her obligations when shifting ground.

IT AND A BIT (Z. Spain) – approaching the 700 metres shifted out in an attempt to improve and contacted with DYLANSON for some distance and inside the 600 metres again attempted to shift out and contacted DYLANSON for some distance. Rider reminded of his obligations and to only attempt runs to which he was entitled to.

REDEEM BOUNTY (J. Toeroek) – hampered near the 100 metres.

DOUBLE POCKETS (E. Boyd) – raced wide without cover throughout the event. Held up over the concluding stages and obliged to shift out to obtain clear ground. Rider reported the gelding over-raced during the event.

RACE 7 : SCHWEPPES GAWLER CUP - 1500 metres (cont'd)

EIGELSTEIN (GB) (B. Griffiths) – inconvenienced near the 100 metres when taken wider.

RACE 8: JIM MARSHALL LIFE MEMBER TRIBUTE BENCHMARK 60 HCP - 1500 metres

The start of this event was delayed approximately two minutes.

BEL STREAK (M. Poon) – slow to begin and thereafter raced in restricted room approaching the 600 metres when racing behind MEADOW'S JOURNEY and to the inside of PIERREMONT and was unable to maintain its position and was obliged to shift in to obtain clear running.

NEW BALLS PLEASE (B. Claridge) – raced wide without cover throughout the event.

KINGSTONIAN (D. Tootell) – over-raced in the early stages of the event.

PIERREMONT (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

RAISE A DREAM (A. Jordsjo) – raced wide without cover in the early stages of the event. Rolled out in the vicinity of the 300 metres and brushed with SPRINGFIELD LEW and became unbalanced and thereafter shifted ground outwards gradually over the concluding stages.

LOQUETEUX (J. Holder) – required the attention of the Farrier at the barriers as the gelding lost its off fore plate en route to the start. Underwent a pre-race veterinary examination and passed fit to race.

SPRINGFIELD LEW (J. Cartwright) – rolled in, in the vicinity of the 300 metres and brushed with RAISE A DREAM, became unbalanced and thereafter shifted ground gradually outwards over the concluding stages.

BAIKAL (Z. Spain) – raced in restricted room over the concluding stages.

MEADOW'S JOURNEY (J. Huxtable) – rider reported the mare was very disappointing and failed to let down during the event. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow Stewards to view the vision in the straight.
