THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 19 November 2016

RACE 1 : JAMES BOAGS PREMIUM TWO-YEAR-OLD PLATE - 1000 metres

ECLAIR SUNSHINE (D. Tourneur) – rider explained he had no specific instructions but to allow the gelding to settle where comfortable. He added he was able to settle outside the leader and was comfortable with his position in running in the early stages but stated that at the entrance to the straight, the gelding appeared off the bit and he had to encourage his mount to pick up the bridle and thereafter the gelding, in a strong sprint home with the winner, finished the race off very well. He also added that despite being taken out approximately half a horse approaching the 100 metres by CARUSMATIC as that filly rolled out slightly, the gelding had every opportunity to finish the event off. He also stated in his opinion the gelding may be better suited to racing over more ground, having regard for the manner in which it finished the event off. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: WOLF BLASS & ASSOCIATES HANDICAP - 1250 metres

POSH JOURNEY (E. Boyd) – laid in, in the straight and shifted in inside the 200 metres and inconvenienced MISS IDENTIFIED. A post-race veterinary examination revealed no visible abnormalities.

NORTH SKY (M. Neilson) – held up for clear running from in the vicinity of the 500 metres until inside the 300 metres. Rider explained he was unable to obtain a position one out, one back in the early stages owing to the position of JET EXPRESS and SKALARM and as a consequence was obliged to settle a little bit further back than intended. He added approaching the home turn he became held up for running and was unable to improve his position until shortly after the entrance to the straight. He further added the gelding only finished the race off fairly and did not finish off in a manner he had expected. A post-race veterinary examination revealed no visible abnormalities.

MISS IDENTIFIED (J. Bowditch) – shortly after the entrance to the straight, shifted out to improve its position and contacted JET EXPRESS, which was taken wider. Was inconvenienced inside the 200 metres.

SKALARM (M. Poon) – rider explained his instructions were to obtain a forward position and attempt to sit outside JET EXPRESS if that gelding was able to take up a forward position. He stated after beginning a little slow, he encouraged his mount owing to the fact there was no apparent pace to his inside, attempted to take up a position outside JET EXPRESS but was then conscious of the fact that ALMADRAM had improved to the inside of JET EXPRESS and as a consequence he was trapped three wide without cover. As a consequence, he attempted to come back and take cover behind JET EXPRESS but was unable to do so, owing to the position of NORTH SKY and was obliged to race wide without cover for some distance.

RACE 2: WOLF BLASS & ASSOCIATES HANDICAP - 1250 metres (Cont'd)

JET EXPRESS (D. Caboche) – awkward to begin. Taken wider near the entrance to the straight. Laid out in the straight.

Correct weight for this event was delayed to allow J. Bowditch (MISS IDENTIFIED) and Trainer Mr T Doudle placed second to view the vision in the straight.

RACE 3: GARY RADFORD FAMILY (BROKEN HILL) HANDICAP - 1950 metres

The start of this event was delayed approximately two minutes owing to an interstate delay.

ROYAL RUMBLE (D. Caboche) – laid in for a number of strides in the vicinity of the 600 metres and shifted in across the heels of HAVE PLENTY and had to be restrained and shifted out to improve its position. Thereafter ROYAL RUMBLE laid in at various stages in the straight and was taken wider over the concluding stages and was inconvenienced slightly. A post-race veterinary examination revealed no visible abnormalities.

EMMOOKI'S DASH (Z. Spain) – rider reported the gelding laid out from the 600 metres.

ONE FOR MAX (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

BULLITT COUNTY (M. Poon) – slow to begin. Had difficulty obtaining clear running near the entrance to the straight when racing between the heels of KAZOOM (NZ) and EMMOOKI'S DASH and was obliged to be steadied for several strides. Approaching the 200 metres was accidentally struck over the head by the whip of E. Boyd. Rider explained he had no specific instructions but to allow the gelding to settle where comfortable. He added as the gelding was slow to begin, he elected to allow the gelding to settle into its stride and improve its position accordingly.

KAZOOM (NZ) (E. Boyd) – raced keenly for a short distance near the 1600 metres. Rider reported her mount hung out throughout the event.

HAVE PLENTY (J. Bowditch) – lost its off hind plate during the event.

ANURADHA – a late scratching at 7.48 am by order of Stewards acting on advice from Trainer Mr R. Balfour that the gelding was lame in the near foreleg.

RACE 4: HUGHES CHAUFFEURED LIMOUSINES MAIDEN PLATE - 1400 metres

The start of this event was delayed approximately two minutes owing to an interstate delay.

BILLET DOUX (J. Kah) – raced in restricted room for a number of strides approaching the 1000 metres and was obliged to steady and take cover behind runners.

EVERASREADY (J. Bowditch) – held up from near the entrance to the straight until approaching the 300 metres and was obliged to shift out to obtain clear running.

FUGITIVE (J. Holder) – slow to begin. Raced uncompetitively and finished the race off in a disappointing manner. Rider reported the gelding felt sore in its near foreleg. a post-race veterinary examination revealed no visible abnormalities.

TEQUILA FLYER (T. Pannell) – shifted in, in the vicinity of the 1100 metres and crossed YOU ES MARSHAL, which had to be steadied. Rider reminded of his obligations when shifting ground in future.

UNRELATED (M. Poon) - slow to begin. Held up from near the entrance to the straight until approaching the 300 metres.

WANTED BY ALL (P. Gatt) – raced in restricted room for a short distance near the 1000 metres. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: HUGHES CHAUFFEURED LIMOUSINES MAIDEN PLATE - 1400 metres (Cont'd)

YOU ES MARSHAL (J. Toeroek) – obliged to be steadied in the vicinity of the 1100 metres. Rider reported owing to the gelding beginning well, he was unable to settle further back in the field as intended. A post-race veterinary examination revealed an elevated heart rate.

ZAALADD (K. Bishop) – jumped away awkwardly.

CONTAINMENT (R. Hurdle) – jumped away awkwardly. Approaching the 1000 metres rolled in onto BILLET DOUX, which was tightened onto WANTED BY ALL, where in turn was taken in onto SCARLETT FOX, which was tightened onto the inside running rail making contact with the running rail for a short distance.

SCARLETT FOX (D. Tourneur) – raced in restricted room and was inconvenienced near the 1000 metres, making contact with the running rail for a short distance.

RACE 5 : CONSOLIDATED PLANT & QUARRIES HANDICAP - 1400 metres

THE TEN BOB (J. Bowditch) – weakened over the concluding stages. Rider reported he felt something amiss with the gelding from inside the 600 metres and for that reason did not ride his mount out fully over the concluding stages. A post-race veterinary examination revealed the gelding had suffered a bilateral bleeding attack. Trainer Mr A. Purcell was advised THE TEN BOB was suspended from racing for a period of three months in accordance with AR53A.

RACE 6 : C A HAIGH MEMORIAL HANDICAP - 1250 metres

JUSTIFY THAT (K. Bishop) – raced keenly in the early stages of the event.

BRIMARVI PRINCE (J. Bowditch) - raced keenly in the early stages of the event.

CONIDEL (M. Poon) – awkward and slow to begin.

HANK'S NEPHEW (R. Hurdle) – raced keenly in the early and middle stages of the event.

DOUBLE POCKETS (J. Holder) – raced wide without cover in the early stages and near the 800 metres improved its positon to lead. Rider explained that having regard for the fact that he was trapped four wide without cover and that there was no pace in the event, he elected to push forward near the 800 metres to take up the lead as he considered his mount would be better suited by taking this option rather than remaining four wide without cover in the circumstances.

COUNTER SPIN (C. Lindop) – commenced to race very keenly approaching the 1100 metres and became awkward on the heels of JUSTIFY THAT for several strides, got its head up when being retrained and shifted out and as a consequence CONIDEL, which was following became awkward on the heels of COUTNER SPIN and had to be restrained for several strides. Approaching the 100 metres laid in resulting in C. Lindop having to stop riding and straighten her mount.

RACE 7: SCHWEPPES HANDICAP - 1550 metres

BEAU'S MY BOY (E. Boyd) –raced wide without cover in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

HELL ON EARTH (J. Berriman) – laid out under pressure in the straight.

OUT OF ITALY (D. Thornton) – rider could offer no explanation for the gelding's performance other than to state that the gelding was disappointing and did not finish the race off in the manner he expected. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: PENNA MICHAEL CHARTERED ACCOUNTANTS HANDICAP - 1000 metres

RISEN FROM DOUBT (D. Thornton) - jumped away awkwardly and shifted out at the start.

FEDERAL COURT (J. Bowditch) – inconvenienced shortly after the start. Shifted in over the concluding stages. Rider reminded of his obligations when his mounts commence to shift ground.

ONE MORE DAISY (J. Maund) – rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground near the 300 metres when insufficiently clear of WILANDER PRINCESS, severely hampering this mare when taking it out across the heels of LADY ANDRESS (NZ) and was suspended from riding in races for a period to commence at midnight on Sunday, 20 November, and to conclude at midnight on Saturday, 26 November 2016: a period of three (3) meetings. Approaching the 50 metres raced in restricted room between FEDERAL COURT and SUPER FLYER (NZ), which shifted ground. A post-race veterinary examination revealed the mare showed signs of being in season.

WILANDER PRINCESS (C. Lindop) – sprung its off fore plate in the race day stall and was re-plated. Underwent a pre-race veterinary examination and was passed fit to race. Severely hampered near the 300 metres when taken out by ONE MORE DAISY across the heels of LADY ANDRESS (NZ) and lost its position.

LADY ANDRESS (NZ) (M. Poon) – was inclined to lay in from the 600 metres and was momentarily inconvenienced inside the 100 metres when FEDERAL COURT shifted ground.

STERNO (J. Holder) - Trainer fined \$100 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Became awkward on the heels of ONE MORE DAISY for a number of strides approaching the 400 metres.

SANDHILL RULER (J. Potter) - jumped away awkwardly.

RACE 9: MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres

ALBERDINI (T. Pannell) - jumped away awkwardly and shortly thereafter was tightened between TYCOON SOFIE and WRITTEN ABOVE ALL, when both horses shifted ground slightly. A post-race veterinary examination revealed no visible abnormalities.

TYCOON SOFIE (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

ENCHANTING BEAUTY (C. Lindop) – rider reported the mare had been galloped on, on its off hind leg during the event. A post-race veterinary examination revealed a minor laceration to the off hind cannon. First aid administered.
