RACE 1: KINGSFORD HOTEL/ ULTRA TUNE GAWLER MAIDEN PLATE - 1100 metres

KING GEORGE (J. Potter) – a post-race veterinary examination revealed no visible abnormalities.

AN APPLE A DAY (M. Poon) – contacted a perimeter fence in the mounting yard. Underwent a prerace veterinary examination and was passed fit to start.

MONETRE BAY (Z. Spain) – very slow to begin. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr G. Lesnikowski, was advised that a warning had been placed on the mare in relation to its barrier manners.

RACE 2: ADELAIDE WEIGHING / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 metres

JESSIE'S OWN (J. Huxtable) – bumped at the start as DESIGNER BABY jumped away awkwardly and shifted in. Shortly thereafter was taken out by SOU SOUNI PRINCESS, which jumped away awkwardly and shifted out. Approaching the 200 metres was momentarily inconvenienced as DESIGNER BABY shifted out.

MAZUREK (J. Kah) – jumped away awkwardly and shifted in.

MISS CUOCO (P. Denton) – rider dislodged en route to the start. P. Denton was examined by the First Care Medical personnel and passed fit fulfil his remaining engagements. Marginally slow to being. Raced greenly when placed under pressure in the straight.

SOU SOUNI PRINCESS (M. Neilson) – jumped away awkwardly and shifted out. Inclined to hang in under pressure in the straight.

DESIGNER BABY (D. Tourneur) – jumped away awkwardly, shifted in and bumped JESSIE'S OWN. Shortly thereafter was tightened and lost its position between MAZUREK and JESSIE'S OWN as SOU SOUNI PRINCESS jumped away awkwardly and shifted out. Approaching the 200 metres shifted out and momentarily inconvenienced JESSIE'S OWN. Rider reminded of his obligations when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: COOPERS MARES BENCHMARK 64 HANDICAP - 1500 metres

RAISE A DREAM (A. Jordsjo) – inclined to lay out under pressure in the straight.

PROFOUND WISDOM (R. Hurdle) – rider could offer no explanation for the mare's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

SET TO SURPRISE (D. Caboche) – inclined to hang in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

MUMBLE BEE (J. Potter) – turned its head into an adjoining stall as the start was effected and as a result was slow to begin.

Correct weight for this event was delayed to allow J. Potter (MUMBLE BEE), Stewards and the Official Starter to view the vision of the start.

RACE 4: GOLDIN FARMS / SABOIS MAIDEN PLATE - 1500 metres

BRUNETTE DOWNS (P. Gatt) – raced wide without cover in the early and middle stages of the event.

IMA SPECIAL KID (O. Ridge) – when questioned in relation to his tactics adopted in today's event rider explained that after beginning well, and rather than being caught wide, he elected to be more forward and in his opinion, it would have been detrimental to the horse's chances if he had restrained and come back in the field.

JIMMYTOWN JEWEL (J. Toeroek) inclined to lay in under pressure in the straight.

COOL FONZY (C. Lindop) – raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ALEXIS JET (J. Holder) – held up for clear running from in the vicinity of the 500 metres until shortly after the entrance to the straight when racing between IT'S PRIMROSE and MELI MELO.

IT'S PRIMROSE (J. Potter) – inclined to over-race throughout the event.

MELI MELO (B. Griffiths) – contacted by another horse behind the barriers. Underwent a pre-race veterinary examination and passed fit to start.

RACE 5: AUSBIA ELECTRICAL BENCHMARK 60 HANDICAP - 1500 metres

COMMISSAR (J. Huxtable) – a post-race veterinary examination revealed no visible abnormalities.

BRILLIANT CREATION (E. Boyd) – Trainer, Mr G. Dunn, was advised that a warning had been placed on the gelding in relation to it becoming fractious in its barrier stall after being loaded.

PLEASE RESET (M. Poon) – over-raced throughout the event.

RACE 6: TREASURY WINE ESTATES BENCHMARK 60 HANDICAP - 1100 metres

SHARK MIRAGE (D. Tootell) – inclined to rear on jumping away.

EINSTEIN MAGIC (S. Cahill) – jumped away awkwardly, shifted out and hampering MAGISUE, which lost its position when tightened onto WISE JOURNEY, which jumped away awkwardly and shifted in.

MAGISUE (O. Ridge) – hampered and lost its position on jumping away as EINSTEIN MAGIC jumped away awkwardly and shifted out as WISE JOURNEY jumped away awkwardly and shifted in.

WISE JOURNEY (J. Kah) - jumped away awkwardly and shifted in onto MAGISUE.

NORDIC ECLIPSE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: DENIS 'FATHER' O'MALLEY 2016 BUNG FRITZ CUP - 1700 metres

The start of this event was delayed approximately three minutes.

SOCIAL SET (J. Holder) – rider explained the gelding did not benefit by the slow pace in the race and for this reason he was unable to quicken when he placed the gelding under pressure and was disappointing in his efforts. A post-race veterinary examination revealed no visible abnormalities.

CRYSTAL ICON (B. Griffiths) - jumped away very awkwardly.

DUCHOVNY (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

DUKE OF NULLAH (A. Jordsjo) – dislodged its rider en route to the start and galloped for a considerable distance at a strong pace. Underwent a pre-race veterinary examination and ruled the gelding unfit to race. Acting on this advice DUKE OF NULLAH was a late scratching at 4.43 pm. Rider was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

KIRCHNER (E. Finnegan) – when questioned in relation to her tactics adopted in today's event, rider explained that it was her instructions to be positive in the early stages. She added, in her opinion, after beginning well, there was poor pace and for this reason and due to the fact that her mount was travelling well, she elected to push forward and obtain the lead. Trainer, Mr A. Day confirmed the instructions provided to the rider, however, advised that he had been surprised the mare had led.

RACE 8: 4WAY FRESH PRODUCE/ ELDERS GAWLER BENCHMARK 56 HANDICAP - 1200 metres

WRITTEN ABOVE ALL (J. Huxtable) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr J. Dodgson was advised a Veterinary Certificate of Fitness required prior to a future trial or race.

NUTHERBOTTLEGONSKI (J. Toeroek) – shortly after the start rolled out onto VERNON. Approaching the 100 metres was inclined to lay in and rolled in onto ONWARD, which was momentarily inconvenienced when tightened onto WRITTEN ABOVE ALL. Inclined to lay in under pressure in the straight.

WINDSOR CUP (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

OGUNDE (J. Mamat) – a post-race veterinary examination revealed no visible abnormalities. Trainer, Ms D Wilson was questioned in relation to her leaving the saddling paddock prior to required time of 30 minutes. Ms D. Wilson pleaded guilty to a charge under AR117(3) and was reprimanded.

PERASINO (D. McWhinney) – rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

VERNON (E. Finnegan) –was tightened shortly after the start and lost its position as NUTHERBOTTLEGONSKI rolled out.

ONWARD (D. Caboche) – approaching the 100 metres was momentarily inconvenienced when tightened onto WRITTEN ABOVE ALL by NUTHERBOTTLEGONSKI, which was inclined to lay in and rolled in.
