**RACE 1 : JULIE GIFFORD MAIDEN PLATE - 1050 metres**

The start of this event was delayed approximately two minutes.

**NEVER WITHOUT YOU** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**CREPE VOLANT** (D. Thornton) – underwent a pre-race veterinary examination on arrival on course as the mare had not raced since December 2015 and was passed fit to race. The mare was re-examined by the Clubs Veterinary Surgeon on arrival at the barriers and declared a late scratching at 12.39 pm by order of Stewards acting on veterinary advice that the mare was lame in the near hindleg.

**DAWAA** (M. Neilson) – lost its off fore plate during the event.

**RAMBLER FURY** (D. Tourneur) - slow to begin.

**SICILY** (E. Boyd) – inclined to lay out between the 600 metres and the 400 metres. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100. In determining penalty Stewards had regard for E. Boyd's overall use of the whip in particular with reference to her use over the final 100 metres of the event.

Following the running of the race R. Hurdle was examined by the First Care Medical Personnel and declared unfit to fulfil his remaining engagements.

**RACE 2 : MEDALLION HOMES HANDICAP - 1050 metres**

**PLANET VOYAGE** (P. Denton) – tightened at the entrance to the straight, had to be checked and lost its position. Rider reported the gelding felt short during the event. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 2 : MEDALLION HOMES HANDICAP - 1050 metres (Cont'd)**

**DUCKWORTH** (J. Holder) - jumped away awkwardly and shifted in at the start.

**WILANDER PRINCESS** (C. Lindop) – rider reported the mare hung out during the event.

**BRIMARVI EQUIADA** (M. Poon) - jumped away awkwardly and shifted out at the start.

**MYSTICANO** (J. Maund) – tightened shortly after the start between DUCKWORTH and BRIMARVI EQUIADA, which both shifted ground. Shifted ground to improve at the entrance to the straight and tightened PLANET VOYAGE onto LOCKDOWN JACK resulting in PLANET VOYAGE having to be checked and losing its position. J. Maund pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 28 December 2016, and to conclude at midnight on Wednesday, 4 January 2017: a period of four (4) meetings.

## **RACE 3 : UBET HANDICAP - 2500 metres**

**TUNES** (C. Lindop) – shifted out to improve at the entrance to the straight and tightened NISOS onto SIR LASZLO (NZ), resulting in NISOS being severely hampered. C. Lindop pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 31 December 2016, and to conclude at midnight on Wednesday, 4 January 2017: a period of three (3) meetings.

**FLYING CASINO** (J. Holder) – lost its near fore plate during the event.

**DISTILLATION** (S. Price) - a post-race veterinary examination revealed no visible abnormalities.

**MAJESTIC MOMENT** (P. Gatt) – lost its off fore plate during the event.

**THESPINIS** (M. Poon) – rider reported the mare was inclined to hang out in the straight. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow J. Holder (FLYING CASINO) placed third and J. Kah (NISOS) placed fourth to view the vision in the straight.

## **RACE 4 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1600 metres**

**ANY GIVEN GLASS** (M. Neilson) – raced wide without cover throughout the event. Tightened near the 50 metres and had to be steadied.

**CYCLONE THOMAS** (A. Jordsjo) – slow to begin. Laid in, in the straight, shifted in over the concluding stages and tightened ANY GIVEN GLASS, which had to be steadied. Rider was shown the vision of the incident and reminded of her obligations when her mounts commence to shift ground. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 5 : SCHWEPPES HANDICAP - 1200 metres**

Official start time was amended from 2.58 pm to 2.57 pm following advice from Sky Racing and the TRSA Racing Department.

**ARROW LANE** (M. Poon) – inconvenienced at the start. In the vicinity of the 300 metres laid out and shifted out onto HUSSYBAY resulting in this gelding taking CHAPEL CITY out across the running of I'LL DECIDE. As a consequence I'LL DECIDE had to be checked. M. Poon was reminded of his obligations.

**VIKINGS REWARD** (P. Gatt) – rider pleaded guilty to a charge under AR137A(4)(b) in that he used his arm in an action that raised his whip above shoulder height on five occasions and was fined \$300.

**CHAPEL CITY** (J. Kah) – inconvenienced near the 300 metres.

### **RACE 5 : SCHWEPPE'S HANDICAP - 1200 metres (Cont'd)**

**TIME OUT** (J. Holder) – jumped away awkwardly and shifted out at the start inconveniencing **ARROW LANE**.

**I'LL DECIDE** (D. Thornton) – had to be checked in the vicinity of the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

**PENINSULA LINKS** (M. Neilson) – inconvenienced near the 200 metres and shortly thereafter laid in resulting in M. Neilson having to stop riding and straighten his mount.

**LADY ALCATRAZ** (D. Tourneur) - jumped away awkwardly, shifted in at the start inconveniencing **AMATIVE**. Rolled out near the 200 metres and inconvenienced **PENINSULA LINKS**.

**AMATIVE** (A. Jordsjo) - inconvenienced at the start.

### **RACE 6 : FARMERS UNION ICED COFFEE HANDICAP – 1200 metres**

The start of this event was delayed approximately five minutes.

**RAISE A DREAM** (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

**OPTIMIZE** (M. Poon) – unable to obtain clear running from in the vicinity of the 500 metres until near the entrance to the straight and thereafter had to alter course on several occasions in the straight to obtain clear ground.

**LADY ANDRESS (NZ)** (M. Neilson) – lost its near fore plate en route to the start had to be re-shod, on arrival at the barriers. Underwent a pre-race veterinary examination and was passed fit to race.

**ENCHANTING BEAUTY** (C. Lindop) – laid in, in the straight.

### **RACE 7 : ADELAIDE GALVANISING CHRISTMAS HANDICAP - 1200 metres**

The start of this event was delayed approximately two minutes.

**THE BOWLER** (J. Rule) – rider reported the gelding was disappointing in today's event.

**CASINO WIZARD** (J. Holder) – inconvenienced near the 800 metres.

**TARCO** (C. Lindop) – shifted in near the 800 metres and inconvenienced **CASINO WIZARD**.

**PRINCE HARADA** (D. Thornton) - slow to begin and laid in at the entrance to the straight.

**MUBAKKIR** (P. Gatt) – rider pleaded guilty to a charge under AR137A(4)(b) in that he used his arm in an action that raised his whip above shoulder height on four occasions and was fined \$300. Rider was also reprimanded for using his whip on two occasions past the winning post.

**FINKE** (D. Tourneur) - a post-race veterinary examination revealed a puncture wound to the off hind cannon. First aid was administered.

**READY SUNSHINE** (J. Potter) – rider accidentally dropped his whip over the concluding stages and was fined \$50 under AR137(a) for carelessness.

### **RACE 8: MAC: STOP DRUG DRIVING HANDICAP - 1200 metres**

The start of this event was delayed approximately two minutes.

**EVIL DREAMS** (M. Poon) - slow to begin. Rider explained his intentions were to settle on pace, however, having regard for the manner in which the gelding began he was unable to take up a forward position and was obliged to settle further back.

**RACE 8: MAC: STOP DRUG DRIVING HANDICAP - 1200 metres (Cont'd)**

**THE SHOW GOES ON** (M. Neilson) – rider reported the gelding laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**IMPULSE DIAVOLO** (P. Gatt) – slow into stride.

**STAGHORN** (J. Holder) – had difficulty obtaining clear running, initially in the vicinity of the 200 metres, and thereafter again in the vicinity of the 100 metres and was not fully tested to the line.

Mr N. Smart, Trainer of OCTOBER DATE pleaded guilty to a charge under LR11.4.2(c) the particulars being that he failed to ensure the gelding remained at the stable premises declared on the stable return, being the Morphettville stables, from the time of entry and was fined \$300.
