**RACE 1: NOCELLE HANDICAP - 1300 metres**

The start of this race was re-scheduled from 11.58 am to 11.57 am owing to a request from Sky Channel.

**RED RAIDER** (C. Lindop) - slow to begin. Inclined to lay in under pressure in the straight.

**DON'T DOUBT IT** (T. Pannell) – laid in under pressure in the straight.

**DEXTINY** (J. Holder) - jumped away awkwardly and shifted out. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**EPERDUMENT** (R. Hurdle) – momentarily disappointed when attempting a run in the vicinity of the 150 metres between DEXTINY and DON'T DOUBT IT, which laid in.

**RACE 2: NEIL SACHSE HANDICAP – 2400 metres**

The start of this race was re-scheduled from 12.33 pm to 12.32 pm owing to a request from Sky Channel.

**CABLE BAY (NZ)** (V. Wong) –raced keenly in the middle stages of the event. In the vicinity of the 300 metres shifted out when insufficiently clear into the running line of BOLD ZAMOUR (NZ), which was forced to take hold. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 10 June, and to conclude at midnight on Wednesday 14 June 2017: a period of three (3) meetings.

**SPUR ON GOLD** (J. Bowditch) - slow to begin. Raced keenly in the early and middle stages of the event. Had difficulty in obtaining clear ground from the entrance to the straight until inside the 300 metres.

## **RACE 2: NEIL SACHSE HANDICAP – 2400 metres (Cont'd)**

**BOLD ZAMOUR (NZ)** (A. Jordsjo) – forced to take hold in the vicinity of the 300 metres to avoid the heels of **CABLE BAY (NZ)**, which shifted out.

**SPYING ON YOU (NZ)** – a late scratching by order of Stewards at 12.20 pm as the gelding was not present on course. Trainer Mr G. Young pleaded guilty to a charge under AR117(2) in that he failed to have horse on course prior to the required time and was fined \$500.

**SEEK TO DESTROY (Z. Spain)** - a post-race veterinary examination revealed mild tying up in the hindquarters. First aid administered.

## **RACE 3: ANTHONY SCOPELITIS HANDICAP - 1000 metres**

The start of this race was re-scheduled from 1.08 pm to 1.07 pm owing to a request from Sky Channel.

**ARROW LANE (R. Clark)** – had difficulty in obtaining clear ground for a number of strides between the 300 metres and the 200 metres when awkwardly placed on the heels of **HIDDEN FORTUNE**, which had commenced to give ground.

**NEVER BE DISCREET (D. Caboche)** - a post-race veterinary examination revealed no visible abnormalities.

**TWO DUCKS ARTIE (T. Pannell)** – raced in restricted room from the vicinity of the 150 metres until inside the 100 metres when awkwardly placed between the heels of **GOLD DENARI** and **TIME OUT**.

**BREAKER OF CHAINS (D. Thornton)** – improved onto the heels of **NEVER BE DISCREET**, which had commenced to weaken, in the vicinity of the 200 metres and then again in the vicinity of the 100 metres resulting in the gelding having to be steadied. A post-race veterinary examination revealed no visible abnormalities.

**HIDDEN FORTUNE (J. Toeroek)** - a post-race veterinary examination revealed no visible abnormalities.

**CERRO BLANCO (Z. Spain)** - jumped away awkwardly. Laid out under pressure in the straight resulting in the rider having to stop riding and straighten his mount approaching the finish. Rider reported the filly was inclined to hang out throughout the event.

## **RACE 4: MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres**

**FORCE OF THREE (J. Kah)** - a post-race veterinary examination revealed no visible abnormalities.

**TRUENO (D. Caboche)** - a post-race veterinary examination revealed no visible abnormalities.

**COOL MAVERICK (S. Price)** – contacted on jumping away.

**BEAUTIFUL VOICE (P. Gatt)** – raced keenly in the early and middle stages of the event.

**THE OTHER GUY (S. Cahill)** - jumped away awkwardly and shifted out contacting **COOL MAVERICK**. Unable to obtain clear ground from the entrance of the straight until the vicinity of the 150 metres. In the vicinity of the 50 metres was contacted by **THE GEE TRAIN** and was unbalanced momentarily.

**SUDDEN WEALTH (T. Pannell)** – had difficulty in obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

**COPERNICUS (P. Denton)** – lost its off hind plate during the event.

**CHONDRA (S. Fawke)** – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**THE GEE TRAIN (D. Thornton)** – rolled in, in the vicinity of the 50 metres and bumped **THE OTHER GUY**.

### **RACE 5: QUAYCLEAN HANDICAP - 1550 metres**

**OUR EXCHANGE** (V. Wong) – shifted in, in the vicinity of the 1400 metres onto BELUGA BLUE. Rider severely reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

**WOAKWINE** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**BELUGA BLUE** (C. Lindop) – had to be eased in the vicinity of the 1400 metres when OUR EXCHANGE shifted in. Raced keenly in the early and middle stages of the event.

**DOUBLE POCKETS** (R. Hurdle) – held up for a short distance in the vicinity of the 200 metres when it improved onto the heels of WOAKWINE, which had commenced to weaken.

**SPIRITOF ENDEAVOUR** (USA) (J. Kah) - slow to begin. Had difficulty in obtaining clear ground from the vicinity of the 300 metres until near the 200 metres when it eased across the heels of other runners to obtain clear ground.

### **RACE 6: AUSTRALIAN FLOOR GROUP HANDICAP – 1000 metres**

**TARCO** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**USAIN DANE** (M. Neilson) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**CHAPEL ROAD** (J. Kah) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

**CLASSY JACK** (R. Clark) - jumped away awkwardly.

### **RACE 7: HUGHES LIMOUSINES HANDICAP - 1250 metres**

**SCRATCHY LASS** (A. Jordsjo) – had to take hold in the vicinity of the 100 metres to avoid the heels of SEPTAMORE.

**BATTLE BREWING** (C. Lindop) – inclined to lay in under pressure in the straight. In the vicinity of the 100 metres rolled in onto PEPPER THE PIN. Contacted at the entrance to the straight and brushed with HARBOUR GREY (NZ) for a short distance.

**PEPPER THE PIN** (R. Clark) – inclined to lay out under pressure in the straight and in the vicinity of the 100 metres shifted out slightly at the same time as BATTLE BREWING rolled in, resulting in the rider having to take hold for a number of strides.

**SEPTAMORE** (J. Holder) –in the vicinity of the 100 metres shifted out under riding when insufficiently clear of SCRATCHY LASS, which was forced to take hold. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 10 June, and to conclude at midnight on Wednesday, 14 June 2017: a period of three (3) meetings. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**HAZY LANE** (V. Wong) – reared on jumping away and was slow into stride. Raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$500 and advised he would be required to attend the Riders Advisory Group in relation to the matter.

**HARBOUR GREY (NZ)** (D. Thornton) – at the entrance to the straight shifted out to improve and in doing so contacted BATTLE BREWING, resulting in these two runners brushing for a short distance.

### **RACE 8: UBET HANDICAP - 1400 metres**

The start of this event was delayed approximately six minutes owing to BURIED TREASURE losing its near fore plate on arrival at the barriers and requiring Farrier attention.

**RACE 8: UBET HANDICAP - 1400 metres (Cont'd)**

**GALAXY GAZER** (R. Clark) – shifted in slightly inside the 200 metres onto HALAYR ROTHESTAR. Tightened approaching the 100 metres onto RED MENACE by CHOSEN ANGEL, which shifted out.

**HALAYR ROTHESTAR** (D. Thornton) – inside the 200 metres had to be checked when tightened between CHOSEN ANGEL and GALAXY GAZER. An inquiry into this incident was adjourned to a date and time to be fixed to allow R. Clark who had left the course without permission to be in attendance. Lost its position on jumping away when taken out onto GALAXY GAZER by CHOSEN ANGEL.

**MR LIBERTY** (S. Cahill) - raced keenly in the early and middle stages of the event.

**RAHEEBA** (S. Fawke) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100

**CORRECT CALL** (C. Lindop) - slow to begin. Raced keenly in the early and middle stages of the event. Had difficulty in obtaining clear ground in the straight.

**VINTAGE GROVE** (P. Gatt) – inconvenienced approaching the 100 metres when BURIED TREASURE shifted out.

**BURIED TREASURE** (D. Caboche) – shifted out under pressure in the straight and in the vicinity of the 100 metres rolled out onto VINTAGE GROVE. Rider reminded of his obligation when shifting ground.

**CHOSEN ANGEL** (R. Hurdle) – on jumping away shifted out and away from RED MENACE onto HALAYR ROTHESTAR. Improved into a tight run to the inside of GALAXY GAZER approaching the 100 metres and shortly after shifted out tightening that runner. R. Hurdle was severely reprimanded and advised in future to make a greater effort to straighten his mounts when they commence to shift ground.

**SIMPATICO** (J. Kah) – approaching the 100 metres had to be steadied when taken out by RED MENACE onto the heels of SATURDAY MAGIC.

**RED MENACE** (V. Wong) – Contacted and became unbalanced approaching the 100 metres when GALAXY GAZER was taken out by CHOSEN ANGEL, tightening RED MANCE onto SIMPATICO. Lost its off hind plate during the event.

**GENERAL:**

When Stewards attempted to commence an inquiry into the reason HALAYR ROTHESTAR had to be checked inside the 200 metres, it was evident that Apprentice R. Clark was not on course. Stewards established that immediately following Race 8, she left the course without obtaining permission of the Stewards to catch a flight interstate. Stewards attempted to contact R. Clark without success and therefore D. Thornton was granted permission to leave the course and advised an inquiry into the incident was adjourned to a date and time to be fixed. Approximately 20 minutes later R. Clark contacted Stewards and advised that she had missed her flight and was able to return to the course. Stewards then advised J. Kah, R. Hurdle and V. Wong that they would be required to remain on course for R. Clark to return for an inquiry to be conducted into the incident approaching the 100 metres. Following the conclusion of this inquiry Stewards questioned R. Clark into her reasons for leaving without permission. After considering her explanation, R. Clark was charged under AR91 for leaving the course without the permission of the Stewards. She pleaded guilty and was suspended for a period to commence at midnight Saturday, 10 June and to conclude at midnight Wednesday, 14 June 2017: a period of three (3) meetings. She was informed of her right of appeal.
