STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at the Port Augusta Racecourse
by the Port Augusta Racing Club on Sunday, 25 June 2017

Stewards: C. Deakin (A/Chairman) & A. Hayles (HT) (Stewards), R. Packard (F), S. Allen & C. Edson (Deputy Stewards), Dr D. Anderson (Veterinary Surgeon)

TRACK: Dirt / Good

WEATHER: Fine

RAIL: True

RACE 1: ADELAIDE GALVANISING / SABOIS MAIDEN PLATE - 1498 metres

WAKE UP BRIAN (V. Wong) - jumped away awkwardly.

WHISPERING WILLOW (B. Griffiths) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

LITTLE SWEETHEART (J. Potter) - jumped away awkwardly. A post-race veterinary examination revealed the filly to be shin sore. Veterinary Certificate of Fitness required prior to trial or race.

RACE 2: MACUMBA STATION / SABOIS MAIDEN PLATE - 1100metres

AN APPLE A DAY (D. Caboche) – bumped on jumping away by TORNADO BLUE, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

IT'S PRIMROSE (A. Jordsjo) - underwent a pre-race veterinary examination and passed fit to race. Rider reported the mare was inclined to lay out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TORNADO BLUE (K. Bishop) - jumped away awkwardly, shifted in and bumped AN APPLE A DAY.

RACE 3: NONNING PASTORAL COMPANY BENCHMARK 56 HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes due to the barrier gates being relocated.

MAKO COVE (B. Griffiths) – rider reported the gelding was flat throughout and finished the race off disappointingly. A post-race veterinary examination revealed no visible abnormalities.

VAN PERSIE (S. Fawke) – slow into stride. A post-race veterinary examination revealed bi-lateral swelling around the girth.

RACE 4: MAHANEWO PROPRIETORS BENCHMARK 72 HANDICAP - 1396 metres

PROPSHAFT (K. Crowther) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 5: MCDOUALL PEAK PTY LTD BENCHMARK 56 HANDICAP – 1396 metres

ANOTHER MARTINI (A. Jordsjo) - slow to begin.

TYCOON DEL (J. Toeroek) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

OUTLAW (J. Potter) – raced keenly in the middle stages of the event.

SCROLL (Jemma Frew) – laid in under pressure in the straight.

RACE 6: WIRREALPA STATION BENCHMARK 64 HANDICAP - 1100 metres

IMPULSE BUY (S. Fawke) – laid in, in the early stages of the event. Shifted in, in the vicinity of the 1000 metres and inconvenienced **BETCHER**. Rider reminded of his obligations when his mounts commence to shift ground.

LADY ANDRESS (NZ) (T. Pannell) - a post-race veterinary examination revealed the mare suffered a bi-lateral bleeding attack. Trainer advised the mare was now suspended from racing for a period of three (3) months in accordance with AR53A.

BETCHER (J. Potter) – in the vicinity of the 1000 metres was obliged to be steadied to avoid the heels of **IMPULSE BUY**, which shifted in.

WILD RUN (K. Bishop) – laid out in the home straight. A post-race veterinary examination revealed no visible abnormalities.

I DREAM OF GINA (T. Zanker) – Trainer Mr M. White was advised a warning had been placed on the mare due to being difficult to load and being fractious in the barriers.

RACE 7: BILLA KALINA SQUATTER’S CUP - 1867 metres

CONQUER THE MOMENT (K. Bishop) – inclined to over-race in the early and middle stages of the event.

RACE 8: C K OLDFIELD MEMORIAL BENCHMARK 60 HANDICAP - 1600 metres

COPPER COAST RAIDA (K. Crowther) – inconvenienced shortly after the start as **UMALUKA** rolled out at the same time as **LUCKY NOW** rolled in.

UMALUKA (Jemma Frew) – shortly after the start rolled out and inconvenienced **COPPER COAST RAIDA**.

KAZOOM (NZ) (V. Wong) - jumped away awkwardly and as a result was slow into stride.

LUCKY NOW (B. Griffiths) – shortly after the start rolled in and inconvenienced **COPPER COAST RAIDA**
