**RACE 1: UBET HANDICAP - 2400 metres**

**INSTRUMENTALIST (IRE)** (A. Chan) – improved onto the heels of PAT THE WEAPON at the entrance to the straight and was obliged to alter course to that gelding's outside to obtain clear ground.

**SAGAAB** (C. Lindop) – raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr T. Doudle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**SPYING ON YOU (NZ)** (J. Bowditch) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Stewards questioned J. Bowditch in relation to his riding of this gelding on passing the winning post. After considering his explanation Stewards reminded J. Bowditch of his obligations under AR137A(4)(e). Trainer, Mr G. Young, was directed that in future he should not provide instructions to his rider to continue to pressure his mounts after passing the winning post.

**RACE 2: ADELAIDE FESTIVAL OF RACING 5-19 MAY HANDICAP – 1000 metres**

**BULLPIT** (D. Dunn) – taken out on jumping away onto REMOVAL. A post-race veterinary examination revealed no visible abnormalities.

**TILDY LAD** (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

**FEDERAL COURT** (A. Chan) – shifted out on jumping away onto LIFE'S REWARD.

## **RACE 2: ADELAIDE FESTIVAL OF RACING 5- 19 MAY HANDICAP – 1000 metres (cont'd)**

**AZAZEL** (J. Kah) – laid in under pressure over the final 100 metres. Lost its off fore plate during the running of the event. A post-race veterinary examination revealed no visible abnormalities.

**REMOVAL** (D. Lane) – lost its position on jumping away when BULLPIT was taken out. Raced keenly in the early and middle stages of the event. Held up for clear running from the vicinity of the 400 metres until near the 200 metres.

**ASCENDANCE** (J. Holder) – shifted out and away from LIFE'S REWARD on jumping away onto BULLPIT.

**KABINI** (K. Bishop) – had difficulty obtaining clear ground from the vicinity of the 500 metres until near the 200 metres when awkwardly placed between the heels of TILDY LAD and INVISIBLE GIRL. A post-race veterinary examination revealed no visible abnormalities.

**LIFE'S REWARD** (K. Crowther) – taken out on jumping away by FEDERAL COURT.

## **RACE 3: DOMINANT BREEDERS' STAKES – 1200 metres** **(Main track)**

**HEART CONQUERED** (D. Dunn) – inconvenienced approaching the 800 metres when TEQUILA TIME rolled in and then raced keenly for a short distance.

**MANZALA** (T. Pannell) – shifted in on jumping away and contacted FUNDAMENTALIST. Raced fiercely in the early and middle stages of the event and was inclined to shift about.

**BOLD STAR** (A. Jordsjo) – shifted in abruptly on jumping away onto KRONE. Hung in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**SIR GARFIELD** (H. Coffey) – laid in under pressure in the straight.

**KRONE** (D. Lane) – inconvenienced on jumping away.

**FUNDAMENTALIST** (A. Mallyon) – shifted out on jumping away and contacted MANZALA.

**GOTTA BE GOLD** (R. Clark) –raced keenly in the early stages of the event and in the vicinity of the 800 metres, whilst being restrained, shifted out and became awkwardly placed on the heels of HEART CONQUERED and then raced greenly for a number of strides. A post-race veterinary examination revealed the filly to be lame in the off foreleg. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

## **RACE 4: 13CABS HANDICAP - 1400 metres**

**REINCARNATE** (M. Aitken) – Trainer, Mr S. Mathrick, was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified by records held by Stewards.

**KIRONA** (J. Bowditch) – a post-race veterinary examination revealed no visible abnormalities.

**WASABI BOB** (E. Boyd) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**COUNTER SPIN** (R. Clark) – laid out rounding the home turn.

**TYCOON SOFIE** (J. Potter) – Trainer, Ms K. Mooney, was questioned in relation to the gelding arriving on course inside the required time. After considering her explanation Ms K. Mooney was reprimanded under LR8.9 and advised in similar circumstances in future she would be required to make contact with the Stewards to advise of her circumstances.

**EMMOOKI'S DASH** (D. Caboche) – raced wide without cover throughout the event.

### **RACE 5: H C NITSCHKE STAKES - 1400 metres**

**TIME AWAITS** (A. Mallyon) – shifted out on jumping away onto BETTERMENT. Rider reported that shortly after jumping away the filly had got its tongue over the tongue control bit and commenced to race fiercely and extend its lead on the field despite his efforts. He added that in the vicinity of the 600 metres TIME AWAITS commenced to make an abnormal respiratory noise and weakened from the event. Mr C. McEvoy, representing trainer Mr T. McEvoy, confirmed that the filly had returned to scale with its tongue over the tongue control bit. A post-race veterinary examination revealed a laceration to the right side of TIME AWAITS's mouth and the filly to be showing signs of tying up in its hindquarters.

**PEACEFUL STATE** (J. Allen) – held up for clear running from the vicinity of the 500 metres until approaching the 200 metres.

**VINLAND** (D. Dunn) – examined by the Club's Veterinary Surgeon on arrival on course who reported an elevated temperature. VINLAND was withdrawn at 1.40 pm on veterinary advice.

**DANGER DEAL** (C. Lindop) – raced in restricted room for a number of strides in the vicinity of the 1200 metres. At the entrance to the straight raced in restricted room for a short distance when awkwardly placed between the heels of BROADBAND and OVER EXPOSURE.

**M'LADY** (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities.

**CARIBBEAN PEARL** (J. Turner) – jumped away awkwardly. At the entrance to the straight improved onto the heels of TIME AWAITS, which commenced to weaken, and shifted out onto BETTERMENT. Rider reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

**BETTERMENT** (J. Holder) – inconvenienced on jumping away. At the entrance to the straight had to be steadied when J. Turner shifted out.

### **RACE 6: HOLDFAST INSURANCE CITY OF ADELAIDE HANDICAP - 1400 metres**

**BALF'S CHOICE** (J. Bowditch) – slipped behind on jumping away and was slow into stride. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SCHISM** (D. Lane) – jumped away awkwardly.

**SUDDEN WEALTH** (J. Toeroek) – slow to begin and shortly afterwards was inconvenienced by SCHISM.

### **RACE 7: AAMI CHAIRMAN'S STAKES - 2035 metres**

#### **(Main track)**

**CIVIL DISOBEDIENCE (NZ)** (J. Allen) – a post-race veterinary examination revealed no visible abnormalities.

**SAVAHEAT (NZ)** (P. Gatt) – raced keenly for a short distance in the vicinity of the 800 metres as the pace slackened.

**GREYCLIFFE (NZ)** (D. Dunn) – in the vicinity of the 200 metres rolled out slightly and brushed TURF MAN, which shifted back in tightening GREYCLIFFE (NZ) onto BOX ON COLLINS.

**LEICESTER** (D. Lane) – held up from the entrance to the straight until inside the 300 metres.

**ESHTIRAAK** (J. Bowditch) – raced keenly in the middle stages of the event. Laid in under pressure in the straight.

**AMEROCK** (H. Coffey) – laid in under pressure in the straight.

**BOX ON COLLINS** (J. Kah) – inside the 200 metres was unbalanced by GREYCLIFFE (NZ), which had been taken in, resulting in the gelding having its hindquarters turned.

**RACE 7: AAMI CHAIRMAN'S STAKES - 2035 metres (cont'd)**  
**(Main track)**

**LITTLEBITFUNNY** (C. Lindop) – jumped away awkwardly. Raced keenly in the early and middle stages of the event.

**TURF MAN** (J. Toeroek) – inclined to lay in, in the straight and in the vicinity of the 200 metres was brushed by GREYCLIFFE (NZ), turning the gelding in.

**RACE 8: MURRAY & BARB STEWART 60TH ANNIVERSARY HANDICAP - 1300 metres**

**HUSSYBAY** (A. Chan) – jumped away awkwardly and shifted out onto MAGIC BOY. Raced in restricted room from the vicinity of the 1100 metres until inside the 1000 metres when awkwardly placed between MANUEL and EXCITES ZELADY. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr M. Huxtable, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**MAGIC BOY** (J. Allen) – inconvenienced on jumping away by HUSSYBAY. Shortly after the start had to be steadied off the heels of HUSSYBAY when taken in by MORVADA.

**BEAUTIFUL FLYER** (D. Lane) – slow to begin.

**EXALTED ADAM** (D. Dunn) – slow to begin.

**REDENTES EDGE** (J. Turner) – rider was unable to claim down to his minimum riding weight. As there were no other riders available on course who could ride at the weight he was permitted to ride without claiming down to his minimum riding weight.
