Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 2 June 2018

RACE 1: MICHAEL & CAROLYN CROSATO #HAPPILYEVEAFTER TWO-YEAR-OLD MAIDEN PLATE
- 1000 metres

The start of this event was delayed approximately three minutes.

PAPALET (P. Gatt) - a post-race veterinary examination revealed a post-race distress/colic. First aid administered.

COUNTER DRIVE (C. Lindop) – raced keenly in the early stages and thereafter approaching the 100 metres was unable to improve when awkwardly placed on the heels of PAPALET, which was tiring, and was obliged to shift out to gain clear running.

SUPER (S. Cahill) – proved fractious in its barrier stall and had to be removed. Underwent a pre-race veterinary examination and ruled unfit to race. A late scratching at 11.59 am by order of Stewards acting on veterinary advice. Trainer advised the gelding would be required to perform tractably to the satisfaction of the Stewards in an Approval to Race Jump Out or an Official Barrier Trial prior to accepting for a future race.

VOSOTA (R. Clark) – had difficulty obtaining clear running from near the 100 metres when awkwardly placed between the heels of PAPALET and COUNTER DRIVE.

EXALTED MAXINE (D. Tourneur) – proved fractious in its barrier and had to be removed. Underwent a pre-race veterinary examination and ruled unfit to race. A late scratching at 11.58 am by order of Stewards acting on veterinary advice. Trainer advised the filly would be required to perform tractably to the satisfaction of the Stewards in an Approval to Race Jump Out or an Official Barrier Trial prior to accepting for a future race.

NO JOY (K. Crowther) – began awkwardly, shifted out and contacted SIZZLING AFFAIR.

SIZZLING AFFAIR (J. Kah) – shifted in at the start and contacted NO JOY. Laid in, in the straight.

ICE GHOST (R. Hurdle) – shifted in abruptly shortly after the start. Rider explained the gelding began awkwardly, raced very greenly in the early stages and in his opinion may be better suited if drawn between runners. He added that the gelding finished the race off well but was disappointing in its overall performance. A post-race veterinary examination revealed no visible abnormalities.

RACE 1: MICHAEL & CAROLYN CROSATO #HAPPILYEVEAFTER TWO-YEAR-OLD MAIDEN PLATE - 1000 metres (Cont'd)

ISLAND GAME (A. Chan) – had difficulty obtaining clear running for a short distance shortly after the entrance to the straight, was obliged to shift in to obtain clear running and thereafter was inclined to lay in for the remainder of the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: PANINI CARTEL HANDICAP – 1000 metres

KARLOVASI (P. Gatt) – laid out in the straight.

RACE 3: HUGHES LIMOUSINES HANDICAP – 1000 metres

MOUNT HOREB (J. Kah) – laid in, in the straight. Rider reported the gelding felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

KABINI (K. Bishop) – held up for clear running from near the entrance to the straight until approaching the 100 metres when racing between WALLACE STREET and WHITE KAPS.

CELTIC BLAST (E. Finnegan) – awkward to begin. Rider reported the gelding was wayward in the early part of the event, appeared uncomfortable between runners and over the concluding stages commenced to give ground. A post-race veterinary examination revealed no visible abnormalities.

PURRFECT KISSES (J. Holder) – laid in, in the straight.

TRIPLE DEEZ (S. Fawke) - a post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

RACE 4: MEDALLION HOMES HANDICAP - 2400 metres

RED ALTO (Z. Spain) – laid in, in the straight.

DANCE OF HEROES (GB) (K. Crowther) - raced keenly in the early and middle stages of the event.

GLORIOUS SINNDAR (FR) (J. Bowditch) – had to be re-saddled on arrival at the barriers.

SUPER HAZE (IRE) (J. Kah) - raced keenly in the early and middle stages of the event.

TUNES (C. Lindop) – raced wide without cover in the early and middle stages of the event. Approaching the 400 metres rolled in and away from EXALTED CRAFTSMAN, which improved to its outside and contacted with HIGH ROLLA to its inside for a number of strides and was hampered as a consequence. As a result of this incident HIGH ROLLA was also hampered. A post-race veterinary examination revealed no visible abnormalities.

CAN'T REFUSE (NZ) (S. Tsaiikos) - underwent a pre-race veterinary examination on arrival on course and was passed fit to race.

CHOSEN ANGEL (J. Holder) - slow to begin.

KAZOOM (NZ) (D. Caboche) - slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

EXALTED CRAFTSMAN (P. Gatt) – laid in, in the straight.

HIGH ROLLA (A. Chan) – hampered approaching the 400 metres for several strides by TUNES, which rolled in and made contact with it.

Correct weight was delayed to allow Z. Spain (RED ALTO) and S. Tsaiikos (CAN'T REFUSE) to view the vision in the straight.

RACE 5: TERRY HOWE PRINTING HANDICAP - 1550 metres

ANCIENT ECHOES (J. Allen) – laid in and shifted in approaching the 1000 metres and tightened CHAROSSA, which was hampered. Laid in, in the straight. Lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

I AM DEXTER (K. Crowther) – held up for clear running from shortly after the entrance to the straight when racing inside CANFORD and behind CHAROSSA and was only able to obtain clear running inside the 200 metres.

MITRUST (Z. Spain) – awkward to begin.

CHAROSSA (J. Bowditch) – approaching the 1000 metres was tightened by ANCIENT ECHOES, which laid in and shifted in and clipped the heels of that runner, was hampered and stumbled. Held up for clear running from shortly after the entrance to the straight when racing behind MITRUST and ANCIENT ECHOES and was only able to obtain clear running inside the 200 metres.

DEXELATION (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

HINCHIN MISS (E. Finnegan) – lost its off fore plate during the event.

SUPRE (D. Tourneur) – laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CANFORD (J. Kah) – held up for a number of strides approaching the 200 metres.

TAILGUNNER (J. Potter) – over-raced at various stages in the early and middle stages of the event.

RACE 6: AAMI HANDICAP - 1400 metres

ANCIENT HISTORY (IRE) (E. Finnegan) – Trainer Mr D. Saxon advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle forward of mid-field.

TYCOON SOFIE (J. Potter) – laid out in the straight.

GOING GAGA (J. Kah) – laid in, in the straight.

RACE 7: ANTHONY SCOPELITIS MEMORIAL HANDICAP - 1550 metres

BALF'S CHOICE (R. Sakai) – rider spoken to regarding using his whip in a manner that raised his arm above shoulder height. A post-race veterinary examination revealed no visible abnormalities.

OUR BOTTINO (J. Huxtable) – over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

MORVADA (P. Gatt) – near the 700 metres brushed the running rail and became unbalanced for several strides. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. Rider explained that it was his intention to settle more forward in the event, however, owing to the formation of the field in the early stages and the fact that ROYAL RUMBLE had kicked up to his inside, he was obliged to settle further back than intended. He added the gelding travelled well until brushing the rail near the 700 metres, was then off the bridle, however, picked the bridle up at the entrance to the straight but then failed to finish the event off. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: NOCELLE FOODS HANDICAP - 1250 metres

VIEIRA (A. Chan) – laid in, in the straight.

JET EXPRESS (R. Sakai) – awkward to begin.

RACE 8: NOCELLE FOODS HANDICAP - 1250 metres (Cont'd)

PRECISION STRIKE (E. Finnegan) – slow into stride.

JUST RESTING (J. Bowditch) – held up for a number of strides shortly after the entrance to the straight.

COLESBERG (J. Kah) – shifted in and contacted AUSTRALIAN DESIGN on two separate occasions between the 200 metres and 100 metres.

AUSTRALIAN DESIGN (D. Tourneur) – shifted out and contacted COLESBERG on two separate occasions between the 200 metres and the 100 metres.

PRETIOSA (J. Holder) – reminded of his obligation to ride his mounts out to the finish.
