SECTION 4: CONDITION OF LICENCE

TERMS AND CONDITIONS OF LICENCE:

Farriers must be trade certified with the Certificate III in Farriery (Trade) or equivalent (Applicant to provide copy upon request). This approval shall be governed by the laws of the State of South Australia and the parties agree to submit to the jurisdiction of the courts operating in the State of South Australia. LR56 states, "Horses racing must be attended to by a Licensed Farrier or his or her registered employee unless otherwise authorised by the Stewards".

PRIVACY STATEMENT:

TRSA is the body responsible for and carries out the functions of: determining and issuing occupational licenses, authorising persons to participate in the South Australian thoroughbred racing industry ("Licensed Persons"); supervising Licensed Persons; administering and promoting racing; and such other functions as may be described in its privacy policy published on its website from time to time ("Privacy Policy"). In the course of performing its functions, TRSA may seek personal information from you for the purposes of:

- making determinations in relation to your license application, renewal or continuance;
- meeting supervisory responsibilities in relation to you as a Licensed Person;
- promoting or protecting the integrity of the thoroughbred racing code and ensuring compliance with the Rules of Racing;
- administering and promoting racing operations (including your participation in races and the industry); and
- any other function or activity described in the Privacy Policy.

For these purposes, TRSA may also obtain personal information about you from, or disclose your personal information to, third parties such as enforcement bodies, government authorities, other racing control bodies in the States and Territories of Australia and overseas, wagering service providers such as bookmakers, totalisators, and betting exchanges, educational or training institutions and to other persons for any of the purposes described above or as otherwise provided by law. Unless otherwise advised by you, your image, name and contact details may be published monthly Magazine and also disclosed to and published by TRSA and its associates (including Racing.com, Clubs and Racing Australia Pty Ltd) to facilitate your participation in racing and the promotion of racing. You may make a request to TRSA to gain access to information held by TRSA in relation to you by writing to the Stewards, TRSA, GPO Box 2646, Adelaide, 5001. Should you decline to provide personal information to TRSA when requested by TRSA as part of its licensing and supervisory activities, TRSA may refuse to grant or renew such a license or may revoke or suspend your license.

Important Note:

In making my application to be licensed as a farrier; I hereby:

- Acknowledge and agree to be subject to and bound by:
 - The Rules of Racing of Racing as amended or varied by Racing Australia from time to time: and
 - Such rules and directions as may from time to time be formed, made or given by TRSA, the Directors, the Stewards, or an official of any Club;
- Acknowledge that I have read this application in full, including the Privacy Statement;
- Acknowledge that TRSA may request further information from me in respect of this application;
- Acknowledge that TRSA may request you to provide a sample that will be witnessed in full by stewards or such other person delegated by the stewards;

Consent to TRSA obtaining personal information about me from others and using and disclosing my personal information as noted in the Privacy Statement

PRIVACY AND THE USE, COLLECTION AND DISCLOSURE OF YOUR PERSONAL INFORMATION

The Principal Racing Authority collects information about you when you submit this Application and in the course of related enquiries made of third parties. The Principal Racing Authority will use that information to assess your application and, if registration is approved, your ongoing status as a licensed person. To do that the Principal Racing Authority may disclose your information to other racing bodies.

You do not have to supply the information requested in this application, but if the information (or any part of it) is not provided, your application may be rejected. You can gain access, and request that corrections be made, to information held about you by the Principal Racing Authority. By completing and submitting this application, you authorise the Principal Racing Authority to collect, use and disclose information about you for the purposes described in this notice, including the usual publication of such information in race books, racing calendars and other publications that can include (but are not limited to) websites.

INTELLECTUAL PROPERTY

I agree that Thoroughbred Racing SA Limited will own all intellectual property in the information I submit with and in connection with this application, for the granting and future maintenance of the Licence. I hereby assign to Thoroughbred Racing SA Limited (and warrant that I am authorised to provide and assign) all such intellectual property and information and acknowledge that Thoroughbred Racing SA Limited may use (including by collating, modifying, publishing and distributing) all such intellectual property and information as it sees fit.
