Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Thursday, 8 November 2018

RACE 1: HOLDFAST INSURANCE / SABOIS DISTANCE MAIDEN PLATE – 2118 metres

DOUBLE BURNER (K. Bishop) – laid out under pressure over the concluding 500 metres.

FRANKED (GB) (S. Cahill) – raced keenly in the early stages of the event.

NEED PRAGMATISM (D. Tourneur) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

STALAGMITE (P. Gatt) - slow to begin. Inclined to lay in under pressure throughout the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: CHRISTMAS PARTY AT THE RACES DEC 15 / SABOIS MAIDEN PLATE – 1100 metres

HABANERO (P. Gatt) – hung in throughout the event. In the vicinity of the 300 metres shifted in and became awkwardly placed on the heels of SCARE CAMPAIGN. A post-race veterinary examination revealed no visible abnormalities.

PRINCE MONARCH (R. Clark) – rider reported the gelding laid out over the concluding 500 metres. A post-race veterinary examination revealed no visible abnormalities.

REAL THINKER (S. Cahill) – in the vicinity of the 900 metres had to be checked to avoid the heels of ONE O'CLOCK ROCK, which shifted in.

MISS EBONY ROSE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2: CHRISTMAS PARTY AT THE RACES DEC 15 / SABOIS MAIDEN PLATE – 1100 metres
(cont'd)

ONE O'CLOCK ROCK (K. Bishop) – shifted in, in the vicinity of the 900 metres onto REAL THINKER, which was forced to be checked to avoid the mare's heels. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 17 November 2018 and to conclude at midnight on Friday, 23 November 2018, a period of three meetings.

RACE 3: KINGSFORD HOTEL / SABOIS MARES MAIDEN PLATE - 1200 metres

FREE HAND (P. Gatt) – stepped in slightly inside the 400 metres onto GOOD NIC.

GOOD NIC (E. Boyd) - raced keenly in the early and middle stages of the event and inside the 400 metres rolled out slightly at the same time as FREE HAND stepped in resulting in the mare becoming hampered for a short distance.

NOUVELLOKOVA (S. Cahill) - raced keenly in the early and middle stages of the event. Held up from the vicinity of the 600 metres until approaching the 200 metres.

PATSY (D. Tootell) – inconvenienced from the vicinity of the 800 metres until the entrance to the straight by ZEST IN TIME, which hung out. A post-race veterinary examination revealed no visible abnormalities.

TATTIES (R. Clark) – momentarily inconvenienced in the vicinity of the 400 metres when racing behind FREE HAND. Raced greenly in the straight.

ZAGATO STAR (T. Pannell) - underwent a pre-race veterinary examination on arrival on course which revealed the mare had struck its head in its float en route to the course and would be unfit to race. Acting on this advice, Stewards withdrew ZAGATO STAR at 2.07 pm.

ZEST IN TIME (D. Tourneur) – hung out from the vicinity of the 800 metres inconveniencing PATSY, which was taken wider on the track. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. Trainer Mr D. Jolly was advised a warning had been placed on the mare in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: SCHILD ESTATE WINES BENCHMARK 56 HANDICAP - 1100 metres

EXALTED GOLD (S. Logan) – obliged to be eased and alter course in the vicinity of the 250 metres when awkwardly placed on the heels of LADY LA MANCHA, which had been taken out by ARCTIC BLAZE. A post-race veterinary examination revealed no visible abnormalities.

VIVALDI'S QUEST (P. Gatt) – became awkward in its action over the concluding 100 metres. A post-race veterinary examination revealed a lower than expected heart rate.

LET'S TANGO (T. Pannell) – jumped away awkwardly and shortly after was hampered by ON APPRO, which shifted out. Laid out over the concluding 700 metres of the event.

SHARK MIRAGE (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

EQUAL LOVE (G. Lo) – shortly after the start commenced to buck for a short distance losing ground. Mr T. Stokes, representing trainer Mr P. Stokes, was advised that the filly would be required to trial to the Stewards' satisfaction prior to accepting for a future race. Raced wide without cover throughout the event.

EQUIDAME (A. Chan) – jumped away awkwardly and was slow into stride. Inclined to lay in throughout the event and in the vicinity of the 800 metres shifted in and had to be steadied momentarily when awkwardly placed on the heels of LET'S TANGO.

ARCTIC BLAZE (R. Clark) – in the vicinity of the 300 metres laid out onto LADY LA MANCHA, which was taken wider.

RACE 4: SCHILD ESTATE WINES BENCHMARK 56 HANDICAP - 1100 metres (cont'd)

LADY LA MANCHA (E. Finnegan) – inconvenienced in the vicinity of the 300 metres when taken wider by ARCTIC BLAZE.

RACE 5: GOLDIN FARMS - AKEED MOFEED BENCHMARK 60 HANDICAP - 2118 metres

OLYMPIC ACADEMY (S. Cahill) – held up from the vicinity of the 500 metres until approaching the 200 metres when it was obliged to be eased and alter course to the inside of BARSHONTI to obtain clear ground. Rider explained that after entering the straight he had elected to attempt a run between the heels of HENRY THE DOLPHIN and BARSHONTI, which had then commenced to lay out, resulting in him becoming held up. He added that due to him positioning himself to the outside of BARSHONTI's heels he was unable to alter course to its inside until he was able to come back to ease across safely.

I HAVE ARRIVED (NZ) (D. Tourneur) – slow into stride. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. Rider reported that the horse made abnormal respiratory noise on pulling up. A post-race veterinary examination revealed no visible abnormalities.

BARSHONTI (R. Clark) – hung out from the vicinity of the 500 metres.

CHUMPUNYA (A. Chan) – a post-race veterinary examination revealed no visible abnormalities.

HURRICANES (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

I'M BULLETPROOF (T. Pannell) – raced keenly in the early and middle stages of the event.

LORD GREYSON (S. Logan) – laid out under pressure in the straight.

SAMSTAG (C. Caserta) – raced keenly in the early and middle stages of the event.

RACE 6: BREAST CANCER NETWORK AUSTRALIA CLASS ONE HANDICAP - 1200 metres

KETTERING (J. Holder) – raced fiercely in the early and middle stages of the event. Rider explained that he was given no firm instructions however felt that from the wide gate that he would settle outside the leader. He added that after jumping away well the gelding had raced to the front of its own accord and after finding the lead commenced to race fiercely and extended its lead on the field by a margin greater than he had hoped. He further added that due to this the gelding had not finished off the race as he had anticipated. Trainer, Mr S. Theodore, confirmed that the instructions provided to J. Holder. A post-race veterinary examination revealed the gelding to be lame in the both forelegs. Trainer, Mr S. Theodore, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

REAP THE BENEFIT (D. Tourneur) – rider reported that the gelding had travelled well in the early and middle stages of the event; however, when placed under pressure in the straight had failed to respond to his riding and had been disappointing. A post-race veterinary examination revealed no visible abnormalities.

BIG CALL (C. Lions) – laid out from the vicinity of the 800 metres. Had difficulty obtaining clear ground from the 500 metres as it continued to lay out. In the vicinity of the 100 metres shifted out onto ONE INVINCIBLE CAT, which shifted out and away onto GETOUTTHEWAY. A post-race veterinary examination revealed a minor laceration to the upper gum.

ONE INVINCIBLE CAT (T. Pannell) – had difficulty obtaining clear ground from the 400 metres until the vicinity of the 300 metres.

MAXSAMIA (J. Potter) – jumped away awkwardly.

TATTOO YOU (K. Bishop) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

RACE 7: COOPERS DRY CLASS TWO HANDICAP - 1515 metres

EURO GOLD (S. Logan) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TIME ROGUE (J. Holder) – inconvenienced inside the 600 metres when taken wider by DEVINE TAPESTRY. Laid in under pressure in the straight.

DEVINE TAPESTRY (D. Tourneur) – rider reported that his spur had become caught in his saddle packing in the vicinity of the 600 metres placing him at a disadvantage until his was able to free it at the entrance to the straight. Inside the 600 metres rolled out inconveniencing TIME ROGUE. A post-race veterinary examination revealed no visible abnormalities.

SCOTTISH THREAD (G. Lo) – jumped away awkwardly.

SWIFT JET (E. Finnegan) – dipped shortly after the start and lost ground. Rider reported that the gelding laid in over the concluding 500 metres.

SWEET SCHILLY (K. Bishop) – shortly after the start had to be steadied when tightened between EXALTED LAURETTA, which shifted out at the same time as DEVINE TAPESTRY shifted in.
