RACE 1: EFFIE WILLIAMS MEMORIAL / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres

ALWAYS GUILTY (K. Bishop) - jumped away awkwardly.

GOOD NIC (E. Boyd) - jumped away awkwardly and as a result was slow to begin. Trainer was advised a warning had been placed on the gelding. A post-race veterinary examination revealed no visible abnormalities.

JUST KAUTO (J. Potter) - rider eased the mount when the false light was affected, which was accidentally activated. JUST KAUTO was declared a non-runner under AR134A(d).

KISSABLE EIGHT (R. Hurdle) - laid out severely from the vicinity of the 600 metres and for the remainder of the event. Trainer advised the filly would be required to trail tractably in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow Trainer Mr J. Macmillan to view the vision of the start.

RACE 2: MAGICFM/5CS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

JOHN'S LAST SONG (S. Fawke) - laid out in from the 300 metres.

PHILTON (J. Potter) - underwent a pre-race veterinary examination as the gelding raced on 21 November 2018 and passed fit to race. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: MAGICFM/5CS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres (Cont'd)

BLUE BALLOONS (E. Boyd) - raced keenly in the middle stages of the event.

RESISTA (D. Caboche) - raced wide throughout the event.

RACE 3: ALAN HEINJUS MEMORIAL BENCHMARK 56 HANDICAP - 1800 metres

UNSCOPEABLE (J. Toeroek) - rider explained the mare travelled well throughout the event however, did not let down as well as expected over the concluding stages. He further stated the mare maybe suited over shorter distances. A post-race veterinary examination revealed no visible abnormalities.

TOMMY GUN (S. Fawke) - bumped shortly after the start by **CONQUER THE MOMENT**, which shifted out.

HURRICANES (E. Finnegan) - underwent a pre-race veterinary examination as it had abrasions from travelling in float en route to the course and passed fit to race. Laid in from the vicinity of the 300 metres placing the rider at a disadvantage over the concluding stages.

SWEET KAISER (C. Caserta) - jumped away awkwardly.

CONQUER THE MOMENT (S. Logan) - jumped away awkwardly and shifted out on jumping away and bumped **TOMMY GUN**.

SIR CHARLESTON (NZ) (K. Bishop) - jumped away awkwardly. Rider explained the gelding travelled well during the event however when placed under pressure from in the vicinity of the 400 metres failed to respond to her riding and for that reason she elected not to ride the gelding out in her usual manner. A post-race veterinary examination revealed no visible abnormalities.

HE'S A VALLEYBOY (D. Caboche) - rider explained the gelding travelled well throughout the event until placed under pressure inside the 400 metres where **HE'S A VALLEYBOY** failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: TAYLORS WINES / SABOIS MAIDEN PLATE - 1200 metres

DOUG'S JOURNEY (D. Caboche) - laid in, in the straight.

SCARE CAMPAIGN (T. Pannell) - laid in, in the straight.

EQUIMOORE (E. Boyd) - rider explained the gelding travelled well throughout the event however when placed under pressure in the vicinity of the 500 metres failed to respond to her riding. A post-race veterinary examination revealed no visible abnormalities.

MISS EBONY ROSE (E. Finnegan) - raced keenly in the early and middle stages of the event. Laid in, in the straight.

SIZZKYE (J. Maund) - raced greenly in the early and middle stages of the event.

RACE 5: JIM BARRY WINES BENCHMARK 64 HANDICAP - 1100 metres

GEORDIE'S SECOND (K. Bishop) - raced fiercely in the early and middle stages of the event. In the vicinity of the 1000 metres had to be steadied to avoid the heels of **AMATIVE**, which shifted in. Held up for clear running from the vicinity of the 400 metres until the entrance to the straight and had to alter course to the outside to obtain clear running

RACE 5: JIM BARRY WINES BENCHMARK 64 HANDICAP - 1100 metres (Cont'd)

AMATIVE (C. Caserta) – in the vicinity of the 1000 metres shifted in into the running of **GEORDIE'S SECOND**, which had to be steadied. Rider severely reprimanded and advised to only shift ground when entitled to do so.

PANDEIA (S. Logan) – acting on veterinary advice **PANDEIA** was a late scratching at 8.50 am by order of Stewards.

RACE 6: TAMINGA HOTEL CLARE VALLEY CUP BENCHMARK 80 HANDICAP - 1800 metres

SIZZLING BULLET (J. Holder) – bumped on jumping away. A post-race veterinary examination revealed no visible abnormalities.

EXCITES ZELADY (J. Toeroek) - jumped away awkwardly, shifted out and bumped **SIZZLING BULLET**.

OH SO UNFAIR (D. Caboche) – in the vicinity of the 1200 metres was taken wider by **CHU CHU CHARLIE**, which shifted out.

CHU CHU CHARLIE (G. Cartwright) - underwent a pre-race veterinary examination as it raced on 21 November 2018 and passed fit to race. In the vicinity of the 1200 metres was obliged to shift out and avoid heels, when racing in restricted room to the inside of **BIG BOY BLEV**, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

SPRINGFIELD LEW (J. Potter) - raced keenly in the early and middle stages of the event.

BIG BOY BLEV (K. Crowther) - underwent a pre-race veterinary examination and it raced on 21 November 2018 passed fit to race. In the vicinity of the 1200 metres rolled in. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer MR G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 7: AIRMASTER AUSTRALIA BENCHMARK 54 HANDICAP - 1200 metres

ARCHWAY TO HEAVEN (D. Caboche) – race wide throughout the event.

LET'S TANGO (T. Pannell) – from the vicinity of the 400 metres had difficulty in obtaining clear ground until the vicinity of the 200 metres.

LONBERG (J. Holder) – held up form the 300 metres until inside the 200 metres.

GOLD MAESTRO (J. Maund) – slow to begin.

SOCIAL LANE (K. Lau)- slow into stride.

RIGHTEOUS RULER (J. Potter) – slow to begin.
