

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Port Lincoln Racecourse
by the Port Lincoln Racing Club on Friday, 30 November 2018

RACE 1: PORT LINCOLN CRANE HIRE / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

ARTFUL TEEPA (B. Sweeney) - raced wide without cover throughout the event.

KOODA MISCHIEF (D. Caboche) - hung out rounding the home turn.

CRY OUT LOUD (S. Fawke) - laid in under pressure in the straight. Inside the 200 metres rider had to stop riding and correct his mount. Rider reminded of his obligations under AR137A(5)(a)(i) and AR137A(5)(a)(i)(i) in relation to his use of the whip prior to the 100 metres.

ONYA BOSS (T. Pannell) - shortly after the start commenced to buck for several hundred metres. Trainer Mr W. Clarken was advised the filly would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed a small abrasion to the near hind pastern.

**RACE 2: LINCOLN SAND SUPPLIES - NT & DA DICKSON / SABOIS MAIDEN PLATE
- 1210 metres**

HORIZON WATCH (B. Sweeney) - rider reported the gelding travelled well in the early and middle stages of the event however, when placed under pressure in the vicinity of the 600 metres, failed to respond to his riding and had been disappointing to the finish. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr T Jolly was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

MR TRUMAN (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

NOUVELLOKOVA (K. Bishop) - raced fiercely in the early stages of the event. Raced wide without cover throughout the event. Laid in under pressure in the straight placing its rider at a disadvantage.

RHYTHMICAL GIRL (S. Logan) - jumped away awkwardly.

SHARVANOS (D. Caboche) - laid in under pressure in the straight.

RACE 3: LEADER DISTRIBUTORS BENCHMARK 72 HANDICAP - 1750 metres

NEVA DOUBT US (K. Crowther) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

VINTAGE GROVE (K. Lau) - shifted out on jumping away onto EYE THE WORLD.

EYE THE WORLD (G. Lo) - taken out on jumping away onto DESERT MINTY. Inconvenienced when taken wider in the vicinity of the 100 metres when HEZA GUNN shifted out.

HEZA GUNN (S. Fawke) - attempted to buck momentarily after jumping away. Trainer advised a warning had been placed on the gelding. Laid out under pressure in the straight and in the vicinity of the 100 metres shifted out onto EYE THE WORLD.

DESERT MINTY (D. Caboche) - inconvenienced on jumping away.

RACE 4: IMPACT SIGNS BENCHMARK 56 HANDICAP - 1750 metres

UMALUKA (K. Lau) - in the vicinity of the 1400 metres improved onto the heels of DELAGO EDITION and had to be steadied for a number of strides.

TASSIE (K. Crowther) - raced wide without cover throughout the event.

CRAZY CULPRIT (S. Fawke) - Trainer Mr M. White advised Stewards that he would instruct his rider not to lead if possible and attempt to obtain cover. Stewards questioned the rider in relation to his riding over the concluding 150 metres. Rider explained he had placed the gelding under pressure in the vicinity of the 600 metres, it only responded to his riding for a short distance and he had formed the view in the vicinity of the 200 metres that CRAZY CULPRIT could offer no more. After considering his explanation, Stewards laid a charge under AR137(b) in that S. Fawke failed to ride his mount out to the end of the race. S. Fawke pleaded guilty to the charge and was fined \$200. A post-race veterinary examination revealed no visible abnormalities.

DELAGO EDITION (K. Bishop) - raced keenly in the early and middle stages of the event.

HOW JAMMY'S THAT (E. Boyd) - laid out under pressure in the straight.

PUZZLIST (L. Goomany) - a post-race veterinary examination revealed no visible abnormalities.

AMERICAIN SAPHIRE (G. Lo) - jumped away awkwardly.

RACE 5: VETS ON EYRE BENCHMARK 64 HANDICAP - 1000 metres

KINGSON (K. Crowther) - shifted out on jumping away contacting NIPPY LIPPY.

PHANTOM DATE (S. Fawke) - shifted out on jumping away onto RUBY'S REWARD.

INVINCIBLE ME (D. Caboche) - a post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Mr R. Wilkins, was advised that as this was the gelding's first bi-lateral bleed INVINCIBLE ME would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

RUBY'S REWARD (A. Chan) - inconvenienced on jumping away. Laid out rounding the home turn.

NIPPY LIPPY (E. Boyd) - contacted on jumping away. Raced wide without cover throughout the event.

SOCIAL MEDIA (K. Bishop) - dipped on jumping away. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: VETS ON EYRE BENCHMARK 64 HANDICAP - 1000 metres (Cont'd)

WINE DANCE (G. Lo) - slow to begin.

RACE 6: PORT LINCOLN TIMES BENCHMARK 56 HANDICAP - 1210 metres

CHOUX BACQUAT (NZ) (T. Pannell) - in the vicinity of the 150 metres had to be steadied when **STORM VOYAGER** shifted in. A post-race veterinary examination revealed no visible abnormalities.

SHEZA PROPHET (A. Chan) - jumped away awkwardly. Taken out on the home turn by **WHITWAY** onto **ZAAZOE**.

MACKIE (K. Lau) - jumped away awkwardly and was slow into stride.

STAR MOVER (D. Caboche) - rider reported the mare travelled well in the early and middle stages of the event however, when placed under pressure at the entrance to the straight, had failed to respond to his riding. He added the mare had made excess respiratory noise on pulling up and in his opinion may have chocked down. A post-race veterinary examination revealed no visible abnormalities.

STORM VOYAGER (K. Crowther) - had to be steadied at the entrance to the straight when **ZAAZOE** was taken in and commenced to lay in severely for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning would be placed on the filly.

WHITWAY (S. Fawke) - hung out rounding the home turn and shifted out onto **SHEZA PROPHET**. In the vicinity of the 100 metres had to be steadied momentarily when tightened onto **OBLIQUE LINE** by **LASANTA**, which shifted in.

ZAAZOE (K. Bishop) - taken out on the home turn by **SHEZA PROPHET** into the running line of **STORM VOYAGER**.

LASANTA (L. Goomany) - laid in under pressure in the straight. In the vicinity of the 100 metres shifted in onto **WHITWAY**, which had to be steadied. Rider reprimanded and advised in future to make an effort to straighten his mounts earlier than he had on this occasion.

RACE 7: HANKINS ELECTRICAL BENCHMARK 60 HANDICAP - 1390 metres

HETUKA ZARSHO (D. Caboche) - shifted about under pressure in the straight.

MANZALA (T. Pannell) - rider reported the gelding had travelled well in the early and middle stages of the event, however after shifting out to obtain clear ground in the vicinity of the 400 metres, failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

HARDASHIAN (B. Sweeney) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

HIGHLAND HENRY (K. Bishop) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres got its head up for a number of strides when being restrained.

SCOTTISH THREAD (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

SYNERGY (S. Fawke) - in the vicinity of the 200 metres improved onto the heels of **BEARDED DRAGON** and was unable to obtain clear ground until inside the 100 metres.

RACE 8: M & M GROUP BENCHMARK 80 HANDICAP - 1390 metres

COPPER COAST RAIDA (D. Caboche) - in the vicinity of the 150 metres raced in restricted room for a short distance between the heels of **STONECAST** and **BURNRO**. A post-race veterinary examination revealed no visible abnormalities.

STONECAST (S. Logan) - raced fiercely in the early stages and in the vicinity of the 1000 metres got its head up for a number of strides when being restrained. Continued to race keenly in the middle stages.

EMOJI (K. Bishop) - jumped away awkwardly.
