**RACE 1: CHRISTMAS CHEER / SABOIS MAIDEN PLATE - 1100 metres**

**RAISE A SHOW** (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

**BEIWEN** (S. Fawke) - in the vicinity of the 1000 metres shifted in when insufficiently clear of MINNAMOSA (NZ). Rider found guilty of a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence midnight Sunday, 30 December to conclude midnight Saturday, 5 January 2019, a period of four meetings. In the vicinity of the 900 metres shifted in when insufficiently clear of KISSABLE EIGHT, taking that runner in onto THE PUBLIKIN, which was taken in onto STREETCAR EXPRESS. Rider found guilty of a charge under AR137(a) and was suspended from riding in races for a period to commence midnight Sunday, 30 December 2018 to conclude midnight Sunday, 13 January 2019, a period of seven meetings. To be served concurrently.

**MINNAMOSA (NZ)** (A. Jordsjo) - in the vicinity of the 900 metres had to be restrained to avoid the heels of BEIWEN, which shifted in when insufficiently clear.

**STREETCAR EXPRESS** (J. Toeroek) - in the vicinity of the 900 metres had to be restrained to avoid the heels of KISSABLE EIGHT, which was taken in by BEIWEN, which shifted in insufficiently clear.

**KISSABLE EIGHT** (A. Chan) - in the vicinity of the 900 metres had to be restrained to avoid the heels of BEIWEN, which shifted in when insufficiently clear, and was taken in onto THE PUBLIKIN, which in turn was taken in onto STREETCAR EXPRESS.

**THE PUBLIKIN** (D. Caboche) - in the vicinity of the 900 metres was severely hampered and taken in onto STREETCAR EXPRESS by KISSABLE EIGHT, which was taken in by BEIWAN, which shifted in when insufficiently clear.

**RACE 2: BLEASDALE WINES / SABOIS PLUS BENCHMARK 60 HANDICAP - 2050 metres**

**VONRASANA** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**BARSHONTI** (J. Toeroek) - laid out under pressure in the straight.

**ALL WELL (IRE)** (S. Logan) - rider reported that her mount raced keenly in the early stages of the event and laid out under pressure in the straight.

**FREE THE WIND** (E. Boyd) - slow to begin. Over-raced in the early stages of the event.

**RACE 3: NORTHPOINT FLEURIEU BENCHMARK 56 HANDICAP - 1200 metres**

**FORTIFY** (S. Logan) - stood flat-footed as the start was effected. Mr G. Lynch, representing trainer Mr G. Young, was advised that FORTIFY was now required to perform to the satisfaction of Stewards in an Official Barrier Trial prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.

**BIANCAPTAIN** (K. Lau) - in the vicinity of the 300 metres became awkwardly placed on the heels of TATTOO YOU, which was weakening, and as a result had to shift out contacting ZAGATO STAR.

**LOVE CLUB** (T. Pannell) - began awkwardly. Laid out under pressure in the straight.

**SHARK MIRAGE** (E. Boyd) - began awkwardly.

**ZAGATO STAR** (D. Tourneur) - in the vicinity of the 300 metres was contacted by BIANCAPTAIN, which shifted out.

**HILUMIERE** (K. Bishop) - laid out under pressure in the straight.

**TATTOO YOU** (D. Caboche) - over-raced in the early stages of the event.

**RACE 4: AARON MARTIN CARPENTRY / SABOIS MAIDEN PLATE - 1350 metres**

**TIME RULER** (W. Cave) - laid in under pressure in the straight.

**AIR MAIL** (K. Bishop) - laid out under pressure in the straight. Lost its off hind plate during running.

**MEADOWS LASSIE** (S. Logan) - in the vicinity of the 200 metres laid in and became awkwardly placed on the heels of AIR MAIL, which was laying out.

**ASHBOURNE LASS** (E. Finnegan) - began awkwardly and shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

**ISSARA** (J. Potter) - laid out under pressure in the straight.

**LYRICKIN'S DREAM** (J. Kah) - over-raced in the middle stages of the event. In the vicinity of the 100 metres was momentarily inconvenienced by TIME RULER, which laid out under pressure.

**SIZZKYE** (J. Maund) - over-raced in the middle stages of the event. In the vicinity of the 100 metres had to shift in to avoid the heels of ISSARA, which was weakening.

**TAKE IT UP A GIA** (C. Caserta) - began awkwardly. Laid out rounding the home turn. Rider reported that in his opinion TAKE IT UP A GIA may not have handled the soft track conditions. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5: TOFFISH CLASS TWO HANDICAP - 1600 metres**

**FULTON STREET** (J. Toeroek) - shifted in, in the vicinity of the 1400 metres when insufficiently clear of HIDSATSA, which was taken in onto LOSTARC. Rider reminded of his obligation to be clear when shifting ground.

**LOSTARC** (J. Kah) - over-raced in the early stages of the event. In the vicinity of the 1400 metres raced in restricted room for a short distance to the inside of HIDSATSA, which was taken in by FULTON STREET.

**BIG CALL** (C. Lions) - raced keenly in the early stages of the event.

**CAUSE WE CAN** (S. Fawke) - raced keenly in the early stages of the event.

**HIDSATSA** (D. Tourneur) - in the vicinity of the 1400 metres was taken in onto LOSTARC by FULTON STREET, which shifted in when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: STRATHALBYN SMALL ENGINES BENCHMARK 64 HANDICAP - 1350 metres**

**PICTURE ME ROLLING** (A. Jordsjo) - held up for clear running on entering the straight.

**GRUMPY GURU** (T. Pannell) - held up for clear running on entering the straight. In the vicinity of the 100 metres had to be eased and stopped riding for a number of strides after PARTY SET shifted in when insufficiently clear.

**PARTY SET** (C. Lions) - in the vicinity of the 100 metres allowed her mount to shift in under pressure when insufficiently clear of GRUMPY GURU. Rider was severely reprimanded.

**REGAL EAGLE** (C. Caserta) - a post-race veterinary examination revealed no visible abnormalities.

**REAP THE BENEFIT** (E. Finnegan) - hung out rounding the home turn from the vicinity of the 600 metres to the 300 metres.

**VILLE DE BERNE** (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities. Trainer Mr A. Muhlethaler advised the gelding would now be retired.

**RACE 7: THE HIVE BENCHMARK 54 HANDICAP - 1350 metres**

**EXALTED HONEY** (S. Logan) - held up for clear running on entering the straight.

**SOUND THE TRUMPET (NZ)** (J. Toeroek) - rider lost the use of his off side iron on jumping away placing him at a disadvantage for a number of strides before regaining the use of his iron. Rider reported his mount raced keenly throughout the event and weakened from the vicinity of the 400 metres. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr D. Jolly was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RED DAZZLE** (C. Lions) - inconvenienced on entering the straight becoming awkwardly placed on the heels of SOUND THE TRUMPET (NZ), which was weakening. Held up for clear running on entering the straight to the vicinity of the 100 metres.

**FANDANGO** (E. Boyd) - raced keenly in the early and middle stages of the event.
