Report on Race Meeting held at Strathalbyn Racecourse

RACE 1: NORTHPOINT FLEURIEU / SABOIS DISTANCE MAIDEN PLATE - 2050 metres

HEZ A WOLF (A. Jordsjo) - raced wide without cover throughout the event.

HIERO (J. Kah) - rider accidentally dropped her whip near the 600 metres. Lost its off fore plate during the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. The Veterinary Surgeon advised the lameness was low grade and associated with the gelding losing its off fore plate. Rider explained the gelding laid out during the event.

KHRUSHCHEV (J. Toeroek) - rider reported that the gelding made the turn between the 700 metres and the 400 metres awkwardly.

MANILOW (T. Pannell) - co-trainer, Mr C. Binnie, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle forward of midfield. Near the 400 metres was inconvenienced.

BIG TOP (S. Fawke) - near the 400 metres rolled in onto MANILOW, which was inconvenienced and taken in onto HAPPY ATOM.

BLUE BALLOONS (E. Boyd) - laid out in the straight. Rider reported that the mare felt sore in its near foreleg during the event. A post-race veterinary examination revealed no visible abnormalities.

MEADOWS LASSIE (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 1: NORTHPOINT FLEURIEU / SABOIS DISTANCE MAIDEN PLATE - 2050 metres (Cont'd)

HAPPY ATOM (C. Caserta) - near the 400 metres was inconvenienced when tightened inside MANILOW, which was taken in by BIG TOP, which rolled in. Commenced to weaken from near the 400 metres and was eased down in the straight. Rider explained that whilst the filly travelled well in the early stages of the event it made respiratory noises during the event and failed to respond to his riding and weakened noticeable from near the 400 metres and for that reason he did not persist with his riding in the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr P. Huserot advised Stewards the filly would now be spelled. Mr Huserot was advised the filly would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to future race.

LIBERTY LOVER (R. Clark) - passing the winning post on the first occasion raced in restricted room to the inside of BLUE BALLOONS for several strides.

RACE 2: GOOLWA HOTEL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1350 metres

CHEEKY ATOM (R. Clark) - raced very greenly throughout the event.

CITY BEATS (D. Tourneur) - tightened at the start and buffeted for several strides.

GONE TO PRINT (C. Caserta) - inconvenienced shortly after the start.

SURREAL IMAGE (J. Toeroek) - over-raced in the early stages of the event.

SWANKYTOFF (D. Caboche) - rider explained the gelding commenced to weaken near the 800 metres and made breathing noises on pulling up. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms N. Bruggemann advised the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trail prior to a future race.

AUTUMN'S BEST (A. Jordsjo) - awkward to begin, shifted out and tightened ISSARA onto CITY BEATS. Over-raced in the early stages of the event.

ISSARA (J. Potter) - tightened at the start and buffeted for several strides.

SILVER JEWEL (T. Pannell) - awkward to begin, shifted in and tightened CITY BEATS onto ISSARA. Shortly thereafter was taken out by CITY BEATS and inconvenienced GONE TO PRINT. Over-raced in the early stages of the event.

SMALL SCALE (J. Kah) - raced greenly during the event. Rider explained she was not provided with any specific instructions in this event and on that basis elected to allow the filly to settle where comfortable. She stated that while she would prefer to have settled forward of mid-field, owing to a wider barrier draw and the composition of the field in the early stages of the event, she was unable to take up that position without using the filly in the early part of the event and for that reason settled back with cover. She added the filly raced greenly during the event and was inclined to lay out rounding the turn from inside the 700 metres.

RACE 3: MIDDLETON TAVERN MAIDEN/CLASS ONE PLATE - 1600 metres

FOX BY ZERPRISE (D. Tourneur) - approaching the 50 metres became awkwardly placed when improving onto the heels of HUNGRY FOR LOVE and was obliged to shift in to obtain clear running.

VIKINGS REWARD (C. Caserta) - weakened at the entrance to the straight. Rider explained the gelding travelled well but he became concerned at the entrance to the straight and formed the view that the gelding may have bled during the event and for that reason did not persist with his riding. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr J. Hyam was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 3: MIDDLETON TAVERN MAIDEN/CLASS ONE PLATE - 1600 metres (Cont'd)

YUCATAN (T. Pannell) - jumped the crossing near the 1500 metres. Rider explained that he was comfortable with his position in running in the early stages of the event, however was of the view the gelding was not suited by the solid early tempo, was under pressure and off the bridle near the 700 metres, failed to finish the race off as expected and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

COBBERS MATE (J. Kah) - held up for clear running from near the 400 metres until near the 200 metres.

JOHN'S LAST SONG (S. Fawke) - raced wide without cover throughout the event. Rider reported the gelding hung out during the event. A post-race veterinary examination revealed no visible abnormalities.

TIZA (J. Holder) - raced greenly in the straight. Laid in, in the straight and shifted in near the 200 metres onto PLACE ME RIGHT taking that horse in.

PLACE ME RIGHT (G. Lo) - inside the 200 metres was taken in by TIZA and was inconvenienced.

VOSOTA (D. Caboche) - slow to begin. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr J. Hyam was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 4: MILANG LAKESIDE CARAVAN PARK / SABOIS MAIDEN PLATE - 1200 metres

ECLAIR FLAME (GB) (G. Lo) - which galloped strongly to the barriers, underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Difficult to load. Trainer Mr P. Stokes was advised a warning had been placed on the gelding in relation to its loading manners.

NIC'S SECRET (E. Boyd) - awkward to begin. Raced ungenerously in the early and middle stages of the event.

STRYKE IN STYLE (T. Pannell) - difficult to load. Trainer Mr J MacMillan was advised that a warning had been placed on the gelding in relation to its loading manners.

ELECTRUM (A. Jordsjo) - laid out in the straight. Rider pleaded guilty to a charge under AR137(b) for failing to ride her mount out to the end of the race in particular with reference to her not riding her mount out over the final two strides of the event and was fined \$200.

FUNCKIA (J. Kah) - raced keenly in the early stages of the event.

LUNCH MONEY (K. Lau) - A post-race veterinary examination revealed no visible abnormalities.

THE PUBLIKIN (D. Tourneur) - laid in, in the straight.

RACE 5: TALKING HAIR AND BEAUTY CLASS TWO HANDICAP - 1200 metres

BIANCAPTAIN (K. Lau) - stood flat-footed as the gates were released and lost many lengths at the start. As a consequence, despite its rider's efforts was out of contention. Trainer Mr G Fryer was advised the gelding must jump on terms with the field in an Official Barrier Trial or an Approval to Race Jump Out prior to a future race. A post-race veterinary examination revealed no visible abnormalities.

PANZER PRINCESS (A. Jordsjo) - lost its near fore plate during the event. Near the 1000 metres shifted in and inconvenienced FAY'S JOY. Rider reminded of her obligations when shifting ground in future.

RACE 5: TALKING HAIR AND BEAUTY CLASS TWO HANDICAP - 1200 metres (Cont'd)

FAY'S JOY (S. Logan) - inconvenienced near the 1000 metres when momentarily tightened by PANZER PRINCESS, which shifted in and thereafter was hampered by VOD, which initially shifted in and away from FAY'S JOY and after making contact with the hindquarters of GET IN THE BOWL, rolled out.

VOD (C. Caserta) - near the 1000 metres initially rolled in and away from FAY'S JOY onto GET IN THE BOWL making contact with GET IN THE BOWL'S hindquarters, which was turned resulting in GET IN THE BOWL rolling out and taking VOD out onto FAY'S JOY.

GET IN THE BOWL (J. Potter) - near the 1000 metres was contacted by VOD, which rolled in, had its hindquarters tuned, thereafter rolled out taking VOD onto FAY'S JOY, resulting in both horses being hampered.

Correct weight was delayed to allow Stewards, the Starter and K. Lau to view the vision of the start.

RACE 6: HARRY OF ALL TRADES BENCHMARK 60 HANDICAP - 2050 metres

HAKERAK (J. Holder) - held up for clear running from inside the 500 metres until inside the 400 metres. Approaching the entrance to the straight rolled out slightly and clipped the heels of ANTIPAS, knuckled and lost its momentum. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer Mr G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

AUTMED (J. Maund) - a late scratching by order of Stewards at 2.40 pm acting on confirmed advice from Trainer Mr D. Shepherd that the horse had an abscess in its near fore foot.

ALL WELL (IRE) (S. Logan) - held up for a short distance from inside the 600 metres and inside the 400 metres was hampered for several strides when following HAKERAK after that horse clipped heels and lost momentum.

FREE THE WIND (E. Boyd) - laid in, in the straight.

SWEET KAISER (A. Chan) - awkward and slow to begin. A post-race veterinary examination revealed upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

CASIRAGHI (J. Potter) - laid in, in the straight.

RACE 7: SOUTH COAST REALTY BENCHMARK 56 HANDICAP - 1350 metres

KARADOC KID (J. Holder) - taken wider at the entrance to the straight by SWIFT JET, which shifted out and thereafter laid in, in the straight.

FROSTY GREY (J. Kah) - raced keenly in the early stages of the event.

VEIN CHOICE (K. Bishop) - raced keenly in the early stages of the event.

SWIFT JET (D. Tournour) - shifted out at the entrance to the straight taking KARADOC KID wider on the track.

GENERAL - RACE 3 - VOSOTA:

On Thursday, 3 January 2019 Mr J. Hyam , the Trainer of VOSOTA reported that on return to the stable the gelding was examined by his stable veterinarian who reported that the gelding had strained a ligament in its near fore knee. Mr Hyam advised VOSOTA would now be spelled for three months.
