**RACE 1: ELDERS INSURANCE FLYING HANDICAP - 1210 metres**

**DEBEERSONUS** (J. Holder) - raced keenly throughout the event.

**TOLSTOY** (J. Toeroek) - held up for a short distance rounding the home turn between DEBEERSONUS and HANK'S NEPHEW.

**KINGSON** (R. Clark) - slow into stride.

**MISS INSOMNIA** (J. Potter) - raced wide without cover throughout the event.

**HOST ESPRIT** (S. Fawke) - jumped away awkwardly.

**RACE 2: HARDER TRANSPORT BENCHMARK 60 HANDICAP - 1000 metres**

**RUBY'S REWARD** (R. Clark) - in the vicinity of the 400 metres brushed with NITRO MAGIC, which rolled in.

**MIRTHDALE** (J. Holder) - as the start was affected reared, was awkward and as a result was slow to begin. Rider explained that due to the gelding beginning in the way it did, he was obliged to settle further back than he had anticipated.

**SOCIAL MEDIA** (S. Logan) - in the vicinity of the 800 metres raced keenly for a short distance and got its head up. Approaching the 600 metres shifted out and raced three wide without cover for the remainder of the event. Rider explained it was her instructions to not get into a speed battle early as it appeared a lot of the pace on paper, and if that was to occur, to settle just behind the speed. She added that after beginning only moderately, and the mare not showing her usual gate speed, she was obliged to settle mid-field and attempted to gain cover, however the mare began to race keenly and she elected to shift wider and made her run from the 600 metres. Trainer Mr A. Justice confirmed the instructions.

### **RACE 2: HARDER TRANSPORT BENCHMARK 60 HANDICAP - 1000 metres (Cont'd)**

**NITRO MAGIC** (C. Lions) - in the vicinity of the 400 metres rolled in and brushed RUBY'S REWARD. A post-race veterinary examination revealed no visible abnormalities.

**WILANDER PRINCESS** (G. Lo) - in the vicinity of the 400 metres shifted out contacted TORNADO BLUE and as a result its hindquarters were turned.

**TORNADO BLUE** (S. Fawke) - in the vicinity of the 400 metres had its hindquarters turned as WILANDER PRINCESS shifted out.

### **RACE 3: KIMBA TRANSPORT / SABOIS MAIDEN PLATE - 1210 metres**

**HORIZON WATCH** (R. Hurdle) - underwent a pre-race veterinary examination on arrival on course and passed fit to race. A post-race veterinary examination revealed the gelding to be lame in the off foreleg as this was the fourth occasion the gelding had been lame in the off foreleg. Trainer Mr T. Jolly was advised a detailed veterinary report is to be forwarded to the TRSA Veterinary Surgeon detailing the condition of chronic lameness in the off fore leg.

**TICKET TO TEXAS** (K. Lau) - jumped away awkwardly, shifted out onto AMERICAIN SAPHIRE, which lost its position. Hung in under pressure in the straight. Approaching the 100 metres shifted in onto AMERICAIN SAPHIRE, which was weakening and was obliged to be eased. Rider reprimanded and advised to take greater care in future. A post-race veterinary examination revealed no visible abnormalities.

**WALLAMAN** (S. Fawke) - hung out from the vicinity of the 500 metres until the finish and in the vicinity of the 200 metres bumped with TUNGKETTA.

**AMERICAIN SAPHIRE** (C. Lions) - on jumping away lost its position as TICKET TO TEXAS jumped away awkwardly and shifted out and TOFFEE BELL jumped away awkwardly and shifted in. Approaching the 100 metres was obliged to be eased when tightened onto HUSSLINA as TICKET TO TEXAS, which was hanging in, shifted in.

**TOFFEE BELL** (K. Bishop) - jumped away awkwardly and shifted in onto AMERICAIN SAPHIRE.

**BOTTLE AND BIRD** (S. Logan) - raced wide without cover throughout the event.

**CRY OUT LOUD** (G. Lo) - hung in raced wide without cover throughout the event.

**TUNGKETTA** (E. Boyd) - in the vicinity of the 200 metres bumped with WALLAMAN.

**GREENSBAY** (B. Sweeney) - underwent a pre-race veterinary examination as it had not raced since November 2017 and passed fit to race. Jumped away very awkwardly and as a result was slow to begin.

### **RACE 4: THE MARINA HOTEL BENCHMARK 60 HANDICAP - 1750 metres**

The start of this event was delayed approximately one minute.

**MR LIBERTY** (T. Pannell) - rider explained it was not his intention to settle on pace, however after beginning well and there being no early speed in the event, he found himself further forward. He added the gelding travelled well during the event, however when asked for an effort rounding the home turn, the gelding rolled out slightly, failed to respond to his riding and finished the race off in a disappointed manner. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr D. Carrison was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**SEPTANGO** (J. Holder) - shortly after the start shifted in and bumped WICKED KID. Rider reported the gelding failed to stretch out during the event. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 4: THE MARINA HOTEL BENCHMARK 60 HANDICAP - 1750 metres (Cont'd)**

**CAPITOLINE** (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**AIR MAIL** (K. Bishop) - acting on confirmed advice from Trainer Mr G. Lesnikowski that the mare was unfit to race, Stewards withdrew AIR MAIL at 7.45 am. Trainer was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**HEZA HUSSLER** (C. Lions) - on jumping away lost its position when tightened onto CRAZY CULPRIT as BROOKTON ICE jumped away awkwardly, dipped and shifted out. Over-raced in the early stages of the event and appeared to jump the crossing in the vicinity of the 1400 metres.

**BROOKTON ICE** (S. Fawke) - jumped away awkwardly, dipped and shifted out onto HEZA HUSSLER, which lost its position.

**DESERT MINTY** (G. Lo) - raced keenly in the early stages of the event. Laid in under pressure in the straight.

**WICKED KID** (A. Lindsay) - became fractious in its barrier stall after being loaded. Underwent a pre-race veterinary examination and passed fit to race. Shortly after the start bumped with SEPTANGO, which shifted in.

#### **RACE 5: KIMBA GATEWAY HOTEL & GRANT BURGE CLASS TWO HANDICAP - 1390 metres**

**JOHN'S LAST SONG** (B. Sweeney) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

**RUBY FOR HENRY** (J. Potter) - dipped on jumping away

**HARDASHIAN** (S. Fawke) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mrs A. Harder was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**HOW JAMMY'S THAT** (J. Maund) - had difficulty obtaining clear ground from the 400 metres until the entrance to the straight where it was obliged to shift out to obtain clear running.

**GRACEFUL WOLF** (S. Logan) - in the vicinity of the 400 metres became tight to the inside of HOW JAMMY'S THAT for several strides and was obliged to be restrained.

**STAY SASSY** (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

#### **RACE 6: LIENERT ENGINEERING BUD WOOLFORD MEMORIAL BENCHMARK 64 HANDICAP - 1390 metres**

**VICTOR VICTOR** (J. Toeroek) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ONWARD** (A. Lindsay) - in the vicinity of the 1200 metres shifted in when insufficiently clear of STONECAST, which was obliged to check and lost its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 24 March and to conclude at midnight on Sunday 31 March 2019: a period of three (3) meetings.

**GALAXY FALLS** (T. Pannell) - jumped away awkwardly. In the vicinity of the 300 metres hung in, shifted in and became awkwardly placed on the heels of TURFONIC.

**MAGNUS MAGIC** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6: LIENERT ENGINEERING BUD WOOLFORD MEMORIAL BENCHMARK 64 HANDICAP**  
**- 1390 metres (Cont'd)**

**STONECAST** (B. Sweeney) - in the vicinity of the 1200 metres was obliged to be checked and lost its position as **ONWARD** shifted in when insufficiently clear.

**TURFONIC** (J. Holder) - in the vicinity of the 100 metres rolled in.

**ROSIE LOUISE** (E. Boyd) - held up for clear running from the entrance to the straight until in the vicinity of the 200 metres. In the vicinity of the 100 metres raced tight for a short distance between **MAGNUS MAGIC** and **TURFONIC**, which rolled in.

**RACE 7: DK QUARRIES KIMBA CUP - 1960 metres**

**BRAMFIELD** (T. Pannell) - in the vicinity of the 1000 metres raced keenly for a short distance.

**NEVA DOUBT US** (K. Bishop) - in the vicinity of the 1000 metres raced keenly for a short distance.

**WHAT A SHOCK (NZ)** (J. Maund) - rider reported the gelding may have come to the end of its preparation. A post-race veterinary examination revealed a small speedy cut to the near hind pastern. Lost its near fore plate during the event.

**TOMMY GUN** (S. Fawke) - in the vicinity of the 1100 metres shifted out three wide and was ridden forward aggressively.

**RACE 8: WEST COAST BITUMENT BENCHMARK 56 HANDICAP - 1210 metres**

**SWANKYTOFF** (J. Potter) - jumped away awkwardly and shifted out onto **FIN**, which was taken out.

**GOURMELIN** (J. Toeroek) - shortly after the start lost its position, was obliged to be checked when tightened between **FIN**, which was taken out and **TICKLE ME ERNIE**. A post-race veterinary examination revealed lacerations to the near foreleg. First aid administered.

**LOCKS WELL** (T. Pannell) - in the vicinity of the 1100 metres became tight between **BEARDED DRAGON** and **TICKLE ME ERNIE** and was obliged to be restrained. Shortly after the start was taken out by **SWANKYTOFF** onto **GOURMELIN**.

**SHEZA PROPHET** (K. Bishop) - shortly after the start had its hindquarters turned out and was hampered as **GOURMELIN** was taken out and lost its position as **ARTFUL MONTY** rolled out.

**TICKLE ME ERNIE** (E. Boyd) - jumped away awkwardly.

**SERIOUS MOONLIGHT** (K. Lau) - slow to begin approximately two lengths. Trainer Mr R. Dawson was advised a warning had been placed on the gelding.
