RACE 1: TAYLORS / SABOIS MAIDEN PLATE - 1600 metres

SHIRLEY'S EAGLE (J. Maund) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 300 metres.

COUNTRY COP (J. Toeroek) - raced keenly in the middle stages of the event.

KNEE SLAPPER (J. Huxtable) - inside the 1000 metres became awkwardly placed on the heels of SUN PEAKS for a number of strides. In the vicinity of the 400 metres was momentarily hampered when SUN PEAKS shifted out.

WHITE HEATH (T. Pannell) - contacted on jumping away. Inclined to lay in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

HAVANA DEEJAY (NZ) (J. Holder) - shifted in shortly after the start and bumped WHITE HEATH.

THE BROWN DIVA (J. Potter) - raced keenly in the early and middle stages of the event.

NORMAN PRINCESS (K. Bishop) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres improved onto the heels of COUNTRY COP and had to be steadied for a number of strides.

SUN PEAKS (S. Fawke) - had to be steadied for a short distance inside the 1000 metres when it improved onto the heels of THE BROWN DIVA as the pace eased. Approaching the 400 metres became awkwardly placed on the heels of THE BROWN DIVA, which commenced to weaken and in attempting to obtain clear ground, shifted out onto KNEE SLAPPER, which was hampered. Rider reprimanded.

RACE 2: BALAKLAVA CUP DAY 11TH SEPTEMNER / SABOIS MAIDEN PLATE - 1050 metres

CRIMSON TYCOON (T. Pannell) - raced greenly under pressure in the straight.

RACE 2: BALAKLAVA CUP DAY 11TH SEPTEMBER / SABOIS MAIDEN PLATE - 1050 metres (Cont'd)

LORD VARYS (J. Huxtable) - had difficulty obtaining clear ground from the entrance to the straight. Inside the 100 metres was reluctant to improve to the inside of NASIFA and commenced to lay out onto that mare's hindquarters.

PIVOTAL FORCE (C. Jones) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

TALK DERBY TO ME (K. Bishop) - contacted on jumping away.

DEXTINY (J. Potter) - had difficulty obtaining clear ground in the vicinity of the 400 metres, resulting in the mare shifting out across the heels of a number of runners to obtain clear ground in the vicinity of the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

FOXY AMBITION (L. Goomany) - shifted out on jumping away contacting TALK DERBY TO ME. A post-race veterinary examination revealed no visible abnormalities.

NASIFA (E. Boyd) - jumped away awkwardly and shifted out onto GOODGEE. Raced keenly in the early and middle stages of the event.

GOODGEE (A. Jordsjo) - contacted on jumping away.

WHERE'S THE BOSS (J. Maund) - slow to begin. A post-race veterinary examination revealed minor lacerations to the near hind pastern. First aid administered.

RACE 3: HEINIGER / SABOIS MAIDEN PLATE - 1400 metres

The start of this event was delayed approximately two minutes.

ECLAIR FLAME (GB) (T. Pannell) - was reluctant to proceed to the barriers. Trainer advised the gelding would be required to proceed to the barriers without delay in an Official Barrier Trial prior to accepting for a future race. Raced wide without cover throughout the event.

SIR COEN (J. Maund) - jumped away awkwardly.

CLASSIC WEIWEI (B. Vorster) - raced greenly in the early stages of the event and made the turn in the vicinity of the 900 metres awkwardly, shifting out abruptly. In the vicinity of the 400 metres had to be momentarily steadied when OLIVE GROVE shifted out.

GREAT REBELLION (M. Autier) - a post-race veterinary examination revealed no visible abnormalities.

OLIVE GROVE (J. Holder) - held up from the entrance to the straight until inside the 400 metres when it shifted out to obtain clear ground onto CLASSIC WEIWEI. Rider reprimanded.

GOOD TIME MADAM (S. Fawke) - held up from the vicinity of the 400 metres until near the 300 metres.

RACE 4: MY BUTCHER BENCHMARK 60 HANDICAP - 1050 metres

COCKLES (J. Huxtable) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed speedy cuts to the near hind fetlock. First aid administered.

EQUIETTO (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

OUR WITNESS (J. Potter) - underwent a pre-race veterinary examination on arrival on course which revealed the gelding had lacerated its near side hip in its float en route to the course and would be unfit to race. Acting on this advice, Stewards withdrew OUR WITNESS at 12.10 pm.

RACE 5: METROPOLITAN MACHINERY PTY LTD BENCHMARK 60 HANDICAP - 2200 metres

SHAKOPEE (GB) (S. Logan) - in the vicinity of the 350 metres shifted out onto GO ONE MORE, which was taken out and tightened onto HIERO. Rider reminded of her obligations. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$300.

MARMAN (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

COBBERS MATE (D. Tourneur) - raced keenly in the early and middle stages of the event.

GO ONE MORE (J. Toeroek) - shortly after entering the straight shifted out and away from the whip of S. Logan on two occasions, in the vicinity of 400 metres brushing HIERO. In the vicinity of the 350 metres shifted out and away from SHAKOPEE (GB), which rolled out, again contacting HIERO. A post-race veterinary examination revealed no visible abnormalities.

BURGUNDEE MISS (C. Lions) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

HIERO (J. Potter) - contacted on two occasions in the vicinity of the 400 metres and 350 metres by GO ONE MORE. A post-race veterinary examination revealed lacerations to the off fore pastern. First aid administered.

MANILOW (M. Autier) - held up from the entrance to the straight until inside the 400 metres.

RACE 6: SOUTH AUSTRALIAN LIVESTOCK EXCHANGE BENCHMARK 60 HANDICAP - 1200 metres

EXALTED TRAVELLER (S. Logan) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$200.

IN THE FAST LANE (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

INCUBUS (NZ) (J. Holder) - made the turn in the vicinity of the 800 metres awkwardly and shifted out. Raced wide without cover for the remainder of the event.

BUCK'S ROW (J. Huxtable) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

RUSHWA (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 7: AGFERT CLASS TWO HANDICAP - 1400 metres

JUST ROLLING (B. Vorster) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres had to be steadied when tightened onto FIRST KISS by JUST ROLLING. Lost its off fore plate during the event.

SCARE CAMPAIGN (D. Tourneur) - a post-race veterinary examination revealed a minor laceration to the near hind coronet.

AQUANAUT (T. Pannell) - raced fiercely in the vicinity of the 1000 metres and shifted out of its own accord onto JUST ROLLING. In the vicinity of the 600 metres was forced to take hold when FEVER hung in. In being restrained shifted out onto ART MUSIC. Lost its off hind plate during the event. Rider reported the gelding raced erratically throughout the event. A post-race veterinary examination revealed the gelding to be lame in the off hind and off forelegs. Trainer was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 7: AGFERT CLASS TWO HANDICAP - 1400 metres (Cont'd)

SPLASH SOME CASH (J. Potter) - jumped away awkwardly.

AMBISHOP (J. Chau) - laid in under pressure over the concluding 100 metres.

ART MUSIC (S. Fawke) - hampered on jumping away. Raced fiercely in the early and middle stages of the event. Inside the 600 metres had to be steadied when tightened by AQUANAUT onto JUST ROLLING.

FEVER (E. Boyd) - jumped away awkwardly and shifted out onto ART MUSIC. Hung in severely from the vicinity of the 1000 metres until the entrance to the straight. Rider reported the gelding hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SYLVAN CREST (G. Lo) - shifted in towards the running rail in the vicinity of the 1100 metres and became awkward in its action for a short distance.

RACE 8: LYNDOCK MOTORS BENCHMARK 60 HANDICAP - 1600 metres

MASKING (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

PEARL BANDIT (J. Chau) - hung in, in the early stages of the event. In the vicinity of the 1200 metres shifted in onto LADY YOUNG. In the vicinity of the 1000 metres shifted in onto JUST LIVE ON. A post-race veterinary examination revealed no visible abnormalities.

ZAGATO STAR (S. Price) - jumped away awkwardly. Taken wider on the track over the concluding 50 metres by LADY YOUNG.

LADY YOUNG (B. Vorster) - contacted by STAR MOVER in the vicinity of the 1400 metres. Raced in restricted room from the vicinity of the 1200 metres until near the 1100 metres and obliged to take hold when PEARL BANDIT hung in. In the vicinity of the 50 metres shifted out under pressure onto ZAGATO STAR.

MISS BRIXTON (J. Holder) - was held up from the vicinity of the 500 metres until inside the 300 metres.

SUPERVELOCE (NZ) (J. Huxtable) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

JUST LIVE ON (T. Pannell) - raced keenly in the early and middle stages of the event. Had to be steadied for a number of strides inside the 1000 metres when PEARL BANDIT hung in.

RIGHT AND READY (S. Fawke) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 400 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

STAR MOVER (C. Lions) - in the vicinity of the 1400 metres shifted in and away from PEARL BANDIT contacting LADY YOUNG.
