STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 30 March 2019

TRACK: Soft 5 (Track with a reasonable amount of give in it)

RAIL: Out 5 metres from 1200 metres to Winning Post, out 4 metres remainder.

Sectional 606 metres.

WEATHER: Overcast

RACE 1: MAUGHAN THEIM FORD HANDICAP - 1600 metres

ROYAL RUMBLE (R. Clark) - hampered at the start by TABLE OF WISDOM, which was taken out by KAPAULENKO. A post-race veterinary examination revealed no visible abnormalities.

ALFARRIS (FR) (C. Parish) - from in the vicinity of the 1000 metres raced in restricted room for a short distance between ROYAL RUMBLE and TABLE OF WISDOM. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

KAPAULENKO (F. Kersley) - began awkwardly, shifted out and contacted TABLE OF WISDOM, which was taken out onto ROYAL RUMBLE, resulting in that horse being hampered.

TABLE OF WISDOM (C. MacFarlane) - contacted at the start by KAPAULENKO and taken out onto ROYAL RUMBLE. Raced wide without cover from in the vicinity of the 1000 metres.

RACE 2: KILBURN FOOTBALL CLUB HANDICAP - 1050 metres

VIDUKA (C. Parish) - raced greenly in the straight.

LAKE DISTRICT GIRL (B. Vorster) - raced keenly in the early stages of the event. In the vicinity of the 700 metres was obliged to be steadied when crossed by ILLUMINAIRE.

RACE 2: KILBURN FOOTBALL CLUB HANDICAP - 1050 metres (cont'd)

ILLUMINAIRE (D. Stackhouse) - in the vicinity of the 700 metres shifted in taking the running of LAKE DISTRICT GIRL, which had to be steadied. Rider severely reprimanded under AR131(a) for shifting ground when insufficiently clear.

CHUCKY (T. Pannell) - approaching the 100 metres had difficulty obtaining clear running and was obliged to shift out to improve its position.

RACE 3: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 2027 metres

SIZZLING BULLET (C. Jones) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

ALL HARD WOOD (F. Kersley) - laid in throughout in the straight. Taken wider by LOSTARC over the concluding stages of the event.

SAGAAB (T. Pannell) - trainer, Mr T. Doudle, advised Stewards prior to the event that he would instruct his rider to attempt to be more forward in today's event. Rider explained that after attempting to comply with his instructions he found himself forward but wide without cover and having regard for the runners to his inside showing a reluctance to lead he was obliged to lead in the event, which was not his preferred option.

SUPER SWOOP (R. Clark) - laid out from near the entrance to the straight. Rider reported that the gelding did not back up from its previous start. A post-race veterinary examination revealed no visible abnormalities.

LOSTARC (C. MacFarlane) - shifted out over the concluding stages taking ALL HARD WOOD wider on the track. Rider reminded of her obligations to straighten her mounts when they commence to shift ground in future.

OKIE (G. Cartwright) - raced keenly in the early stages.

Correct weight for this event was delayed to allow Stewards view the vision in the straight in relation to ALL HARD WOOD.

RACE 4: ADELAIDE GALVANISING HANDICAP - 1600 metres

UNFAIR DISMISSAL (T. Pannell) - shifted out at the start and contacted STAR STATUS. Shortly after the start was contacted by ICE GHOST, which shifted in, had its hindquarters turned and became unbalanced. A post-race veterinary examination revealed no visible abnormalities.

TONGSAI BOSS (J. Toeroek) - shifted in near the 1400 metres, crossed the running of START STATUS, which had to be steadied, and thereafter continued to shift in and contacted RESURGE, which was taken in. Rider severely reprimanded for shifting ground when insufficiently clear.

ICE GHOST (D. Tourneur) - shifted in shortly after the start contacted the hindquarters of UNFAIR DISMISSAL, unbalancing that horse. Shortly thereafter, after being steadied, shifted in abruptly. Rider was severely reprimanded for shifting ground when not entitled to.

JUST ROLLING (B. Mertens) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

GALAHAD GURU (J. Holder) - had difficulty obtaining clear running from inside the 300 metres and was only able to obtain clear running inside the 100 metres.

MISS FIALKA (NZ) (F. Kersley) - raced keenly in the early stages of the event.

RACE 4: ADELAIDE GALVANISING HANDICAP - 1600 metres (cont'd)

RESURGE (B. Vorster) - contacted and taken in by TONGSAI BOSS in the vicinity of the 1400 metres when that horse shifted in.

STAR STATUS (R. Clark) - contacted at the start by UNFAIR DISMISSAL. Approaching the 1400 metres was tightened by TONGSAI BOSS, which shifted in and was obliged to be steadied and became ungenerous for several strides thereafter.

WHITE HEATH (G. Cartwright) - raced keenly in the early stages of the event.

ADOZENROSES (C. Parish) - raced keenly in the early stages of the event.

RACE 5: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE HANDICAP - 1200 metres

KNOTTED (J. Holder) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

SNOWBROOK (G. Cartwright) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

OH MO (D. Tourneur) - began awkwardly, shifted in and brushed EXTREME THRILL. Laid in from near the entrance to the straight and near the 200 metres shifted in and hampered LA MAGIQUE. Thereafter continued to lay in for the remainder of the event.

SPARKLING CURRENCY (E. Boyd) - began awkwardly, shifted out and brushed MISS MOSH. A post-race veterinary examination revealed no visible abnormalities.

MISS MOSH (R. Clark) - had difficulty obtaining clear running from shortly after the entrance to the straight and was unable to be fully tested to the line. A post-race veterinary examination revealed no visible abnormalities.

LA MAGIQUE (C. MacFarlane) - near the 200 metres was hampered by OH MO, which shifted in.

RACE 6: FLEURIEU MILK LAELIA STAKES - 1600 metres

KENYAN WONDER (C. Parish) - approaching the 1000 metres when racing in restricted room to the inside of SO WE ARE, which momentarily rolled in, became very awkward in its action for several strides placing C. Parish at a disadvantage. Rider reported that after this incident the filly appeared to lose interest and performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SO WE ARE (R. Clark) - raced keenly in the early and middle stages of the event. Rolled in momentarily near the 1000 metres.

NASAAYIM (F. Kearsley) - a post-race veterinary examination revealed no visible abnormalities.

HAVANA HEAT (J. Toeroek) - approaching the 100 metres was obliged to be steadied when tightened between NASAAYIM and THREEOOD, which rolled in slightly. A post-race veterinary examination revealed no visible abnormalities.

IN HEART'S WAKE (B. Vorster) - raced keenly in the early and middle stages of the event. Approaching the 200 metres commenced to lay in and shifted in and became awkward outside the heels of SO WE ARE. Thereafter was taken in approaching the 100 metres by RAGING QUEEN, which laid in and shifted in.

RACE 6: FLEURIEU MILK LAELIA STAKES - 1600 metres (cont'd)

YULONG METEOR (D. Tourneur) - underwent a pre-race veterinary examination on arrival at the barriers after being kicked by another runner and pass fit to start. Held up for a short distance inside the 400 metres.

MISS FIVE HUNDRED (G. Cartwright) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200. A post-race veterinary examination revealed no visible abnormalities.

GOLDIFOX (D. Stackhouse) - underwent a pre-race veterinary examination on arrival on course after being fractious in the float en route to the course and was passed fit to start. Underwent a further pre-race veterinary at the barriers and was passed fit to start.

RAGING QUEEN (K. Crowther) - laid in, in the straight, shifted in approaching the 100 metres and inconvenienced IN HEART'S WAKE, which was taken in.

RACE 7: HEINEKEN 3 MANIHI CLASSIC - 1100 metres

The start of this event was delayed approximately six minutes.

CASINO WIZARD (J. Holder) -after being loaded into its barrier stall it was discovered that the horse had struck its head against the barrier structure on being loaded and had blood from its offside nostril. Underwent a pre-race veterinary examination and ruled unfit to start. Acting on this advice Stewards declared CASINO WIZARD a late scratching at 5.08 pm. Trainer, Mr L. Creek, was advised that a warning had been placed on the gelding in relation to its barrier manners. A post-race veterinary examination revealed a laceration to the inside of the right nostril.

ZALMONA (C. Parish) - stood flat-footed and was very slow to begin.

DESPATCH (B. Vorster) - after being loaded into its barrier stall became very fractious and reared on several occasions. As a consequence B. Voster was unseated. Shortly thereafter DESPATCH got its off foreleg over the front gate. As a consequence the gates released and the gelding broke free from the barrier attendants and galloped some distance until in the vicinity of the 1800 metres before being captured by the Clerk of the Course. Declared a late scratching by order of the Stewards acting on Veterinary Advice at 5.07 pm. Stable foreman, Mr J. Cornell, was advised that DESPATCH was now required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race start. A post-race veterinary examination revealed a minor laceration to the off fore pastern. First aid administered.

I AM SOMEONE (F. Kersley) - a post-race veterinary examination revealed minor abrasions to the off side nostril, muzzle and upper lip.

CARIBBEAN PEARL (G. Cartwright) - raced keenly in the early stages of the event.

EVERYDAY LADY (B. Mertens) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

Correct weight for this event was delayed to allow Stewards to view the vision of the start in relation to the manner in which ZALMONA began.

RACE 8: SCHWEPPE HANDICAP - 1050 metres

GIRLS GOT SPIRIT (C. MacFarlane) - inconvenienced at the start when VALLIANO began very awkwardly and shifted in. Rider pleaded guilty to a charge under AR184(b)(iii) in that she weighed out without her surcingle requiring her to be re-weighed and was fined \$100. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: SCHWEPPE'S HANDICAP - 1050 metres (cont'd)

TIARA STAR (T. Pannell) - laid in, in the straight.

ALASKAN JADE (C. Jones) - slow to begin.

GOOD LUCK CHUCK (J. Potter) - laid out over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

VALLIANO (J. Huxtable) - very awkward to begin and shifted in and inconvenienced GIRLS GOT SPIRIT.

QUIVERS (J. Holder) - approaching the 200 metres was obliged to be steadied and alter course to the outside of SNIP OF MAGIC, which rolled in.

SNIP OF MAGIC (E. Boyd) - rolled in approaching the 200 metres.
