Limited, and Race Club By-Laws, Regulations and policies in force from time to time during the currency of such licence and such directions as may be given from time to time by the Board or the Stewards of Thoroughbred Racing S.A. Limited or officials of a Race Club.
3. That I shall be bound by the Regulations for the time being in force in respect of any training tracks used by me.
4. TRSA Limited provides no warranty as to the suitability of the training facilities of any race club and that I undertake to satisfy myself as to their adequacy and safety.
5. Not to ride on any licensed racecourse or training track whilst under the influence of alcohol or any drug or substance which may affect my ability, judgement, or behaviour and agree to submit prior to, during or after fulfilling a riding engagement in any race, trial or at riding trackwork, to any tests intended to detect the presence of any alcohol or drug.

I hereby undertake and declare that the ID card issued will not be used by any person, other than the person to whom it is issued.

I understand I may be required to submit, prior to, during, or on completion of trackwork duties, to any tests that are intended to detect the presence of any substance banned by ARR.81B.
