Report on Race Meeting held at Morphettville Racecourse  
by the South Australian Jockey Club on Saturday, 13 April 2019

TRACK: Good 4 (Track with some give in it)

RAIL: Out 8 metres 1200 metres to Winning Post, out 4 metres remainder. Sectional 610 metres.

RACE 1: AAMI DEQUETTEVILLE STAKES - 1050 metres

HEKA EXPRESS (J. Noonan) - laid out in the straight. Rider reported that the filly was inclined to lay out throughout the event.

ROSE TIARA (D. Bates) - a post-race veterinary examination revealed no visible abnormalities.

GENTLEMEN'S WORDS (H. Coffey) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SISSTAR (J. Holder) - raced keenly in the early and middle stages of the event. Hung out from the vicinity of the 800 metres until entering the straight.

YOU HADME AT HELLO (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2: HAPPY 25TH WEDDING ANNIVERSARY LYNNE-MAREE AND NICK HANDICAP - 1050 metres

TILDY LAD (A. Jordsjo) - shifted out on jumping away and bumped WHITE KAPS. Inside the 600 metres had to be steadied momentarily when awkwardly placed on heels.

RACE 2: HAPPY 25TH WEDDING ANNIVERSARY LYNNE-MAREE AND NICK HANDICAP -  
1050 metres (cont'd)

ASCENDANCE (D. Dunn) - raced wide without cover throughout the event. Rider reported the gelding over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

REWARDING LAUGHTER (J. Holder) - had difficulty obtaining clear ground from the vicinity of the 500 metres until the entrance to the straight. Inclined to lay out under pressure in the straight.

SPLIT LIP (T. Pannell) - raced in restricted room for a short distance shortly after the start.

DEBT COLLECTOR (R. Clark) - inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

GYTRASH (D. Tourneur) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200 metres.

WHITE KAPS (Z. Spain)- contacted on jumping away. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

Correct weight for this event was delayed to allow R. Clark (DEBT COLLECTOR), placed third, to view the vision in the straight.

RACE 3: HOLDFAST INSURANCE HANDICAP - 1200 metres

EXALTED ADAM (R. Clark) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

EASY BEAST (NZ) (C. MacFarlane) - inconvenienced on jumping away when its hindquarters were turned by STRAGUN.

STRAGUN (G. Cartwright) - shifted out on jumping away contacting EASY BEAST (NZ).

FANCY RUMBLE (D. Dunn) - raced fiercely in the early and middle stages of the event. Rider reported that the mare was disappointing when placed under pressure in the straight and in his opinion would appreciate a track with more give in it. A post-race veterinary examination revealed no visible abnormalities.

PRIVATE LOUNGE (H. Coffey) - got its head up on a number of occasions during the middle stages of the event whilst being restrained. Had difficulty obtaining clear ground for a short distance in the vicinity of the 200 metres.

BULLET KID (A. Jordsjo) - slow to begin. Raced keenly in the early and middle stages of the event and in the vicinity of the 700 metres had to be steadied momentarily when FANCY RUMBLE rolled in slightly away from EASY BEAST (NZ). Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: RO'S GOLF TRIP HANDICAP - 1600 metres

VON COSTA GLASS (D. Dunn) - slow to begin.

A SHIN ROOK (JPN) (J. Winks) - momentarily inconvenienced when tightened onto PENNY TO SELL (NZ) by GUIZOT (IRE) in the vicinity of the 1100 metres. Held up from the 400 metres until approaching the 200 metres.

BROWN BEN (B. Vorster) - jumped away awkwardly.

RACE 4: RO'S GOLF TRIP HANDICAP - 1600 metres (cont'd)

EMBLEY (T. Pannell) - laid out under pressure in the straight.

GUIZOT (IRE) (F. Kersley) - in the vicinity of the 1100 metres shifted in slightly onto A SHIN ROOK (JPN). Inclined to lay in under pressure in the straight.

PENNY TO SELL (NZ) (C. Robertson) - in the vicinity of the 1100 metres was momentarily steadied when A SHIN ROOK (JPN) was taken in by GUIZOT (IRE). Raced keenly in the middle stages of the event.

FLOW METER (S. Fawke) - raced keenly in the early and middle stages of the event. Held up from the 600 metres until the vicinity of the 300 metres.

RACE 5: DOMINANT PORT ADELAIDE GUINEAS - 1800 metres

SPLASH SOME CASH (J. Potter) - slow to begin. Raced keenly in the early and middle stages of the event. In the vicinity of the 300 metres had to take hold when awkwardly placed between the heels of PIEROPAN, which rolled out slightly, and TATUNKA, which shifted in and away from START STATUS.

STAR STATUS (R. Clark) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

TATUNKA (J. Noonan) - contacted on jumping away. Raced wide without cover throughout the event. Shifted in and away from START STATUS in the vicinity of the 300 metres. Rider reported that the gelding may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

MINT TO BE (C. Jones) - laid out under pressure in the straight.

PIEROPAN (J. McNeil) - rolled out slightly in the vicinity of the 300 metres onto SPLASH SOME CASH.

AWAYTOFF (H. Coffey) - jumped away awkwardly and shifted out onto TATUNKA. Raced wide without cover throughout the event.

RESURGE (J. Holder) - trainer, Mr T. McEvoy, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to be more forward in today's event. Settled forward.

WHITE HEATH (T. Pannell) - inclined to shift about under pressure in the straight.

ELUSIVE ROSE (D. Bates) - jumped away awkwardly.

MEDIEVAL MISS (J. Toeroek) - rider reported that he had to do more work than he had hoped in the early stages of the event; however, it travelled well once finding its position. He added that the filly was disappointing when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

PINA (F. Kersley) - slow to begin.

HEAD NOISES (B. Mertens) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 6: HUGHES LIMOUSINES R N IRWIN STAKES - 1100 metres

CASINO WIZARD (J. Holder) - jumped away awkwardly.

RACE 6: HUGHES LIMOUSINES R N IRWIN STAKES - 1100 metres (cont'd)

I'M WESLEY (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

STEEL FROST (T. Pannell) - rider explained that he had been given no firm instructions; however, after jumping away well and noticing that CASINO WIZARD to his inside had jumped away awkwardly and slower than expected he elected to allow his mount to stride forward to settle outside the leader.

I'LL HAVE A BIT (B. Mertens) - slow to begin. Inside the 400 metres had difficulty for a number of strides when attempting a tight run between the heels of MICA LIL and HUSSYBAY. A post-race veterinary examination revealed a lower than expected heart rate.

ONE MORE DAISY (C. Jones) - a post-race veterinary examination revealed the mare to be exhibiting signs of the thumps. First aid administered

MICA LIL (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: SCHWEPPERVESCENCE STAKES - 1800 metres

The start of this event was delayed approximately two minutes.

COSMIC ALERT (T. Pannell) - in the vicinity of the 1300 metres got its head up when being eased off the heels of HAVANA HEAT. Lost its near hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

MIRETTE (D. Bates) - had difficulty obtaining clear ground from the vicinity of the 400 metres until approaching the 200 metres.

SO WE ARE (R. Clark) - hung in throughout the event.

DUNLANI (F. Kersley) -trainer, Mr M. Cumani, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to be settle more forward in today's event. Settled forward of midfield. Jumped away awkwardly. Held up from the vicinity of the 600 metres until the entrance to the straight and then had difficulty obtaining clear ground.

HAVANA HEAT (J. Toeroek) - jumped away awkwardly. Slowed the pace in the vicinity of the 1300 metres resulting in COSMIC ALERT being inconvenienced. Reminded of his obligations under AR131(d) in relation to excessively slowing the pace. Rider reported that the filly over-raced in the early stages of the event, and for this reason had not finished the event off. A post-race veterinary examination revealed no visible abnormalities.

KENYAN WONDER (D. Dunn) - in the vicinity of the 1400 metres got its head up whilst being restrained. In the vicinity of the 1000 metres improved onto the heels of FRENCH RESPONSE and had to be steadied, and in doing so shifted in inconveniencing MISS FIVE HUNDRED. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ARCTIC SHOCK (NZ) (J. Holder) - jumped away awkwardly and shifted out contacting DREAMED.

LADY YOUNG (B. Vorster) - in the vicinity of the 1400 metres got its head up whilst being restrained. Made the turn in the vicinity of the 1100 metres awkwardly and shifted out.

YULONG METEOR (D. Tourneur) - raced keenly in the middle stages of the event.

DREAMED (C. MacFarlane) - contacted on jumping away and was hampered when taken out onto QUEEN GUINEVERE.

RACE 7: SCHWEPPERVESCENCE STAKES - 1800 metres (cont'd)

SEEWHATSHEBRINGS (H. Coffey) - difficult to load. Mr B. Papazaharoudaki, representing co-trainers Mesrs D. & B. Hayes & T. Daberning, was advised that a warning had been placed on the filly. Raced wide without cover throughout the event.

QUEEN GUINEVERE (S. Fawke) - jumped away awkwardly and contacted MIRETTE and shortly after was hampered when tightened onto DREAMED by MIRETTE. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: TERRY HOWE PRINTING REDELVA STAKES - 1100 metres

MESSERSCHMITT (J. Winks) - had difficulty obtaining clear ground from the entrance to the straight to approaching the 200 metres.

BEHEMOTH (D. Tourneur) - inconvenienced on jumping away when contacted by WHISKEY SHOOTER. In the vicinity of the 300 metres had to be steadied for a short distance when GOTTA BE GOLD rolled in. Laid out under pressure over the concluding 100 metres.

EXALTED TRAIL (S. Fawke) - jumped away awkwardly.

BEAUTY (D. Dunn) - raced wide without cover throughout the event. Rider reported that the filly raced extremely keenly with blinkers and in his opinion would be better suited racing without them. A post-race veterinary examination revealed no visible abnormalities.

HUMMA HUMMA (B. Mertens) - inclined to shift about under pressure in the straight.

LAKE DISTRICT GIRL (B. Vorster) - raced keenly in the early and middle stages of the event whilst being restrained. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BOLD ARIAL (J. McNeil) - laid out under pressure in the straight.

GOTTA BE GOLD (R. Clark) - in the vicinity of the 300 metres rolled in onto BEHEMOTH, which had to be steadied for a short distance. Rider severely reprimanded.

WHISKEY SHOOTER (D. Bates) - shifted out on jumping away contacting BEHEMOTH.
