Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 27 April 2019

RACE 1: TERRY HOWE PRINTING BREEDER'S STAKES - 1200 metres

Run on the main track

SHIFTY SHAMUS (C. Douglas) – raced keenly in the early and middle stages of the event. Near the 500 metres became awkwardly placed on the heels of MEMPHIS ROCK for a number of strides. Raced greenly in the straight and laid in.

SHE SHAO FLY (J. Holder) – held up for clear running from near the 500 metres until the entrance to the straight.

GRAND SCHOLAR (B. Vorster) – rider explained that the filly travelled well early, but was disappointing in the straight. A post-race veterinary examination revealed no visible abnormalities.

ETHICAL SOLUTION (T. Pannell) – after initially laying in, in the early part of the straight, laid out from near the 200 metres.

RACE 1: TERRY HOWE PRINTING BREEDER'S STAKES - 1200 metres (cont'd)
Run on the main track

LADY PAVLI CHENKO (J. Toeroek) - rider reported the filly raced greenly rounding the home turn.

RACE 2: TAB HANDICAP - 1000 metres

GOTTA BE GOLD (R. Clark) - underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame in the off foreleg. Acting on veterinary advice Stewards withdrew GOTTA BE GOLD at 12.55 pm. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

LEGGERO (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3: PAULINE NUTT'S CELEBRATION HANDICAP - 1400 metres

POLAR VORTEX (J. Huxtable) - a pre-race veterinary examination revealed the gelding to be lame in the off foreleg. Acting on veterinary advice Stewards withdrew POLAR VORTEX at 12.35 pm. Trainer, Mr T. Doudle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

VINLAND (R. Clark) - had difficulty obtaining clear running shortly after entering the straight and was obliged to shift out and in doing so improved into a tight run between GELIGNITE JACK (NZ) and ROSELLI STING and made contact with ROSELLI STING approaching the 200 metres. Rider reminded of her obligation when improving into restricted room.

ROSELLI STING (C. Jones) - contacted by VINLAND approaching the 200 metres.

VEGAS BOULEVARD (J. Holder) - inclined to lay out over the concluding stages of the event.

SHROUDED IN MIST (B. Vorster) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

AUSSIE JACK (T. Pannell) - approaching the finish was obliged to be steadied when tightened between GELIGNITE JACK (NZ), which shifted in, and LEFT HAND MAN, which held its line.

GELIGNITE JACK (NZ) (J. McNeil) - contacted at the start. Raced keenly approaching the 900 metres and became awkwardly placed on the heels of LEFT HAND MAN for a number of strides. Shifted in approaching the finish and inconvenienced AUSSIE JACK.

LEFT HAND MAN (K. Crowther) - jumped away awkwardly, shifted out and contacted GELIGNITE JACK (NZ). Raced keenly in the early stages of the event.

Correct weight for this event was delayed to allow Stewards to view the vision in the straight.

RACE 4: JULIE HAYES AND PAT DUFFY HANDICAP - 1300 metres

GO THE JOURNEY (C. Jones) - shifted out at the start and momentarily tightened PRIVATE LOUNGE, which was inconvenienced.

ONE MORE DAISY (K. Crowther) - a post-race veterinary examination revealed the mare to be exhibiting signs of respiratory thumps. First aid administered.

CHAPEL CITY (J. Holder) - laid out under pressure in the straight.

RACE 4: JULIE HAYES AND PAT DUFFY HANDICAP - 1300 metres (cont'd)

ARTIE DEE TWO (C. Douglas) - shifted out near the 100 metres and inconvenienced DEBT COLLECTOR.

SCOTTISH ROGUE (B. Vorster) - jumped away awkwardly, shifted out and contacted LUCKY FISH.

DEBT COLLECTOR (R. Clark) - over-raced in the early stages of the event. Near the 100 metres was inconvenienced by ARTIE DEE TWO, which shifted out. Rider reported that as a consequence of the gelding beginning better than it previously had she was obliged to settle more forward than she had intended.

BEAUTIFUL FLYER (E. Boyd) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.

PRIVATE LOUNGE (J. McNeil) - momentarily inconvenienced at the start.

RACE 5: MURRAY AND BARB STEWART'S 61ST ANNIVERSARY HANDICAP - 1000 metres

MAZUREK (J. Huxtable) - jumped away awkwardly.

EASY BEAST (NZ) (J. Maskiell) - a post-race veterinary examination revealed no visible abnormalities.

MAGNUS KNIGHT (C. MacFarlane) - laid out over the concluding stages of the event.

SPLIT LIP (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

ALL ABOUT NICCI (Z. Spain) - held up for a short distance approaching the 400 metres.

ILLUMICON (B. Vorster) - held up from near the entrance to the straight until near the 100 metres and was obliged to shift out to obtain clear running.

AKKACAN (K. Crowther) - raced keenly in the early stages of the event. Held up for clear running from near the 400 metres until inside the 200 metres.

RACE 6: HOLDFAST INSURANCE CITY OF ADELAIDE HANDICAP - 1400 metres

CASINO WIZARD (J. Holder) - raced keenly in the early stages of the event.

MALAISE (J. Maskiell) - laid out in the straight.

BRING ME ROSES (R. Clark) - contacted and tightened at the start and shortly thereafter was hampered for several strides when buffeted between CALDERON (IRE) and ARKHAM KNIGHT. Rider reported that despite obtaining a good position in running the mare was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

HUSSYBAY (J. Kah) - laid out in the straight.

FLYING KRUIPT (K. Crowther) - laid out over the concluding stages of the event.

SET TO SPARKLE (B. Voster) - a post-race veterinary examination revealed no visible abnormalities.

ARKHAM KNIGHT (P. Gatt) - began awkwardly, shifted out and contacted BRING ME ROSES, which was tightened onto CALDERON (IRE).

RACE 7: H C NITSCHKE STAKES - 1400 metres

CROCKETT (J. Winks) – when improving its position inside the 100 metres became held up for clear running between the heels of COSMIC AWARD and ARAY OF SUNSHINE, and as a consequence was untested to the line from that point.

AIGUILLETTE (J. Holder) – rider reported that he got further back than he had anticipated in today's event and due to the slow tempo he was unable to make up sufficient ground in the straight. A post-race veterinary examination revealed no visible abnormalities.

ICE GHOST (J. Toeroek) – had difficulty obtaining clear running for a short distance shortly after the entrance to the straight.

HE WILL BOOM (P. Gatt) – slow to begin. Approaching the finish shifted out to improve and momentarily hampered LAKE DISTRICT GIRL.

LAKE DISTRICT GIRL (T. Pannell) – momentarily hampered approaching the finish.

ARAY OF SUNSHINE (J. Maund) – raced keenly in the early stages of the event.

LAKHANI ROSE (K. Crowther) – raced very keenly in the early stages of the event and approaching the 900 metres was inclined to lay out and shifted out wider on the track.

RACE 8: HEINEKEN 3 CHAIRMAN'S STAKES - 2032 metres

Run on the main track

The start of this event was delayed approximately two minutes.

DECLARATIONOFHEART (C. Douglas) – shifted out near the 1000 metres. Near the 300 metres, when improving into restricted room, shifted in and brushed with MR GRIZZLE resulting in that horse shifting in and away onto TRUMPSTA, which was taken in onto HIGH HOPES, which contacted the running rail and was hampered for several strides. Rider reminded of his obligations when improving into restricted room.

CLASSIC WEIWEI (B. Vorster) – near the 1900 metres got its head up and raced ungenerously for some distance thereafter.

STAR STATUS (R. Clark) – inside the 1900 metres raced in restricted room for a short distance between DECLARATIONOFHEART and TRUMPSTA. Inside the 1200 metres became awkwardly placed on the heels of DECLARATIONOFHEART and had to be restrained. Held up for clear running from near the 500 metres, and shortly after the entrance to the straight shifted out and contacted OURKHANI on two occasions and thereafter was only able to obtain clear running approaching the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

OURKHANI (J. Toeroek) – awkward and slow to begin. Contacted by STAR STATUS shortly after the entrance to the straight. Laid in over the concluding stages of the event.

SPLASH SOME CASH (J. Potter) – near the 1000 metres was hampered when tightened by DECLARATIONOFHEART, which shifted out, owing to the pace, and as a consequence contacted WHITE HEATH, which was hampered.

HIGH HOPES (J. Maskiell) – awkward to begin. Hampered for several strides and contacted the running rail near the 200 metres.

WHITE HEATH (T. Pannell) – near the 1000 metres was contacted by SPLASH SOME CASH which was tightened by DECLARATIONOFHEART.

RACE 8: HEINEKEN 3 CHAIRMAN'S STAKES - 2032 metres
Run on the main track

TRUMPSTA (S. Cahill) - lost its off fore plate en route to the barrier and was required to be re-shod. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Near the 200 metres was hampered and taken in by MR GRIZZLE.

AMANIKAN (J. Winks) - awkward and slow to begin.
