Report on Race Meeting held at Port Augusta Racecourse
by the Port Augusta Racing Club on Sunday, 9 June 2019

RACE 1: SOUTHERN CROSS AUSTEREO SPENCER GULF / SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately one minute.

BLAZING ROW (C. Lions) - held up momentarily at the entrance to the straight. Laid in under pressure in the straight.

VON LA VOLTA (L. Goomany) - reluctant to proceed to the start. Trainer Mr A. Webster was advised that a warning had been placed on the gelding. Slow into stride. Raced greenly in the middle stages of the event. Rider reported the gelding hung out in the vicinity of the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

TEXAS JACK (NZ) (J. Potter) - underwent a pre-race veterinary examination as the gelding had not raced since May 2018 and passed fit to race.

ONE O'CLOCK ROCK (R. Hurdle) - dislodged rider en route to the barriers and galloped a considerable distance before being captured. A late scratching at 12.46 pm by order of Stewards. Trainer Mr D. Bonetti was advised a warning had been placed on the mare. Rider examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

MENGJUN GLORY (K. Cowan) - raced greenly in the early and middle stages of the event.

RACE 2: PORT AUGUSTA BUS SERVICE / SABOIS MAIDEN PLATE - 1396 metres

DEXTER'S NIBBLE (C. Lions) - jumped away awkwardly and was slow into stride.

HINDLEY STREET (J. Potter) - rider lost the use of his near side iron for a short distance on jumping away.

RONDAFERRO (D. McWhinney) - jumped away awkwardly.

RACE 2: PORT AUGUSTA BUS SERVICE / SABOIS MAIDEN PLATE - 1396 metres (Cont'd)

CHAPPETTE (S. Fawke) - rider reported the filly failed to respond to his riding from the vicinity of the 1000 metres and was disappointed in his mounts performance. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: JB RADIATORS & WINDSCREEN SERVICE BENCHMARK 64 HANDICAP - 1867 metres

SIZZLING BULLET (G. Lo) - laid in under pressure in the straight.

DANCE OF HEROES (GB) (S. Logan) - raced keenly in the middle stages of the event.

FULTON STREET (J. Chau) - laid out under pressure over the concluding stages.

KAZOOM (NZ) (J. Potter) - inconvenienced shortly after the start when contacted by **SETTLE THEN LIFT**, which shifted in. Raced keenly in the early and middle stages of the event.

OVERSTREET (K. Lau) - in the vicinity of the 500 metres was momentarily inconvenienced when **FIN** shifted in.

SETTLE THEN LIFT (D. McWhinney) - shortly after the start, shifted in contacting **KAZOOM (NZ)**. A post-race veterinary examination revealed no visible abnormalities.

FIN (K. Cowan) - weakened from the event from the vicinity of the 600 metres and approaching the 500 metres shifted in onto **OVERSTREET**, which was momentarily inconvenienced. Rider was reminder of her obligations when shifting ground.

RACE 4: MICK FAWCETT MEMORIAL BENCHMARK 64 HANDICAP - 1396 metres

EYE THE WORLD (J. Chau) - lost its position on jumping away when **REGAL EAGLE** shifted out and **REAP THE BENEFIT** shifted in.

STONECAST (R. Hurdle) - raced keenly in the middle stages of the event.

REAP THE BENEFIT (G. Lo) - jumped away awkwardly and shifted in onto **EYE THE WORLD**. A post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Ms K. Huxtable, was advised that as this was the gelding's first bi-lateral bleed **REAP THE BENEFIT** would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

IRISH MAMBO (E. Boyd) - on jumping away was taken out onto **CANIDAE** by **TURFONIC**.

TURFONIC (M. Henderson) - jumped away awkwardly, shifted out taking **IRISH MAMBO** out onto **CANIDAE**.

CANIDAE (S. Fawke) - hampered on jumping away.

REGAL EAGLE (K. Cowan) - jumped away awkwardly, shifted out onto **EYE THE WORLD**.

RACE 5: TRAVELLERS REST HOTEL BENCHMARK 64 HANDICAP - 1100 metres

The start of this event was delayed approximately five minutes.

EVIL MISS (L. Goomany) - reluctant to proceed to the start. Trainer Mr S. Brennan was advised a warning had been placed on the mare.

RACE 5: TRAVELLERS REST HOTEL BENCHMARK 64 HANDICAP - 1100 metres (Cont'd)

COCKLES (C. Lions) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr L. Murray was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RUSTYDUSTYSUNSHINE (J. Chau) - laid in under pressure in the straight and bumped LADY LA MANCHA in the vicinity of the 100 metres.

DOUG'S JOURNEY (R. Hurdle) - became fractious in its barrier stall and broke through the front partition and galloped riderless for a considerable distance before being captured. A late scratching at 3.14 pm by order of Stewards. Following the running of the event underwent a veterinarian examination which revealed the gelding to be lame in the off foreleg. Trainer Mr D. Halliday was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. Mr D. Halliday was also advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

ON APPRO (A. Jordsjo) - laid in under pressure in the straight. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer Mr S. Theodore was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

PANDEIA (S. Logan) - jumped away awkwardly.

LADY LA MANCHA (G. Lo) - laid out under pressure in the straight. In the vicinity of the 100 metres bumped RUSTYDUSTYSINSHINE.

TO BE VAIN (K. Lau) - held up momentarily at the entrance to the straight.

RACE 6: CENTRAL AUGUSTA FOOTBALL & COMMUNITY SPORTING CLUB BENCHMARK 56 HANDICAP - 1600 metres

ART MUSIC (S. Fawke) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. Raced keenly in the early and middle stages of the event. Rider stated that his mount failed to respond to his riding from the vicinity of the 700 metres and inside the 400 metres the gelding changed strides and bounded. He added that he became concerned with the gelding's action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

BANRI DE HERO (R. Hurdle) - slow into stride. Laid in under pressure in the straight.

FISH BONES FRY (K. Lau) - held up from the vicinity of the 400 metres until the entrance to the straight.

STRONG AS (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

KEEP DIGGING (E. Boyd) - raced keenly in the early stages of the event.

WITCH KID (S. Logan) - inside the 400 metres rolled in marginally onto ART MUSIC.

RACE 7: BONNETRY BENCHMARK 56 HANDICAP - 1200 metres

GEORDIE'S SECOND (S. Fawke) - slow to begin. In the vicinity of the 900 metres raced fiercely and improved onto the heels of GET IN THE BOWL and in being restrained shifted out onto UNCLE KENNETH (NZ) despite the efforts of its rider and thereafter continued to race keenly. Laid in under pressure in the straight. Trainer Mr D. Halliday was advised a warning had been placed on the gelding.

SWEET VARDEN (K. Lau) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed minor lacerations to the off hind leg.

RACE 7: BONNETRY BENCHMARK 56 HANDICAP - 1200 metres (Cont'd)

NO PAROLE (J. Potter) - underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame in the near hind leg. A late scratching at 4.19 pm by order of Stewards on veterinary advice.

UNCLE KENNETH (NZ) (K. Cowan) - raced keenly in the early and middle stages of the event. In the vicinity of the 900 metres had to be checked when GEORDIE'S SECOND shifted out and as a result lost her position and became unbalanced for a number of strides.

LEONARDA (E. Boyd) - bumped approaching the finish when ALPHA MINT shifted out abruptly.

ALPHA MINT (J. Chau) - in the vicinity of the 900 metres improved onto the heels of UNCLE KENNETH (NZ) and had to be restrained for a number of strides. Approaching the finish shifted out abruptly bumping LEONARDA.

Race 7 - NO PAROLE - Not to race - Vet Cert of Fitness required prior to future trial or race - Lameness near hind leg.
