TANGARA - The Jumps Review Panel was advised a postrace veterinary examination revealed no visible abnormalities. Trainer, Mr E. Musgrove, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

HERO'S HONOR - The Jumps Review Panel was advised a postrace veterinary examination revealed the gelding to have sustained a neck injury, first aid administered. The gelding was subsequently moved to a nearby stable location for further observation and assessment. Sunday, 14 July 2019, the TRSA Veterinary Surgeon advised that following further examination and assessment and having regard for a neck injury sustained by the gelding in the fall, HERO'S HONOR was humanely euthanased.
