RACE 1: BUSHFIRE AWARE - STAY INFORMED / SABOIS DISTANCE MAIDEN PLATE
- 2100 metres

ELEVENBEE (NZ) (J. Chau) - began awkwardly. In the vicinity of the 1700 metres was eased after becoming awkwardly placed on the heels of MANILOW. Inside the 800 metres shifted out abruptly to avoid the heels of MACSWEEN. Laid out under pressure in the straight.

MACSWEEN (K. Lau) - turned its head to the near side just prior to the start being effected, jumped away awkwardly and lost ground. Raced keenly in the vicinity of the 1700 metres until improving to take up a forward position near the 1200 metres.

CHAPPETTE (P. Gatt) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow the K. Lau (MACSWEEN), Mr Patton, the starter, Mr N. Visallo the barrier attendant and the Stewards to view the vision of the start. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards were of the view that MACSWEEN was not denied a fair start and MACSWEEN was deemed a runner.

RACE 2: BARASTOC CONGRATULATES GRANT YOUNG - TOTY / SABOIS MAIDEN PLATE
- 1200 metres

DYNAMO DARCY (T. Voorham) - underwent a pre-race veterinary examination and passed fit to race. Bumped by HOLY TORMENT on jumping away. Raced keenly in the early stages of the event.

**RACE 2: BARASTOC CONGRATULATES GRANT YOUNG - TOTY / SABOIS MAIDEN PLATE
- 1200 metres (Cont'd)**

LIPPSY SHUFFLE (L. Neindorf) - laid in, in the straight.

SECRET WAR (J. Maund) - shifted out under pressure over the concluding stages.

ULTIMATE VIEW (K. Bishop) - in the vicinity of the 300 metres the gelding fell dislodging its rider. After taking evidence from T. Voorham, which was racing ahead of ULTIMATE VIEW, an inquiry into the incident was adjourned to a date to be fixed. Rider examined by the First Care Medical Personnel and was transported to hospital for further treatment. A post-race veterinary examination revealed trauma to the near side eye region with minor skin abrasions. First aid administered.

AZZUREOUS (P. Gatt) - in the vicinity of the 300 metres was severely hampered after making heavy contact with the fallen horse.

HOLY TORMENT (E. Boyd) - bumped DYNAMO DARCY on jumping away.

RIVER (D. Tourneur) - in the vicinity of the 900 metres eased off the heels of ANGASTON, which shifted out.

RACE 3: ATKINS PHOTOGRAPHY CONGRATULATES MAXSAMIA - HOTY / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately 17 minutes due to the incident in Race 2.

MAGESTIC DIVA (S. Fawke) - held up from the 450 metres until near the 300 metres. Raced greenly in the straight.

STAR PARFAIT - a late scratching at 9.10 am by order of Stewards as in the opinion of the Trainer there was no suitable rider available.

SWIFTY (J. Chau) - a post-race veterinary examination revealed abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

THE IRON LADY (K. Lau) - in the vicinity of the 300 metres was inconvenienced by LIVERPOOL LANE, which shifted out.

IVY EFF (K. Crowther) - raced wide without cover throughout the event.

SHOPSTER (J. Maund) - slow into stride.

TERELLI (J. Potter) - laid in from the 400 metres until near the 300 metres.

RACE 4: HAVE A BUSHFIRE PLAN CLASS ONE HANDICAP - 1200 metres

The start of this event was delayed approximately 7 minutes due to the delay in the previous races.

PIVOTAL FORCE (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

KHANI STAR (J. Holder) - jumped away awkwardly.

SONIC DEED (S. Fawke) - jumped away awkwardly and contacted PANZER PRINCESS. In the vicinity of the 900 metres was eased off the heels of BLUE BALLOONS. A post-race veterinary examination revealed no visible abnormalities.

DEXTER'S NIBBLE (C. Lions) - shortly after the start was checked when crowded between MISS ELEGANCE and PANZER PRINCESS, which was taken out by SONIC DEED.

RACE 4: HAVE A BUSHFIRE PLAN CLASS ONE HANDICAP - 1200 metres (Cont'd)

HABANERO (D. Tourneur) - became unbalanced when bumped on two occasions at the start by **TROJOHNSTAR**.

TROJOHNSTAR (J. Potter) - was eased at the start when tightened onto **HABANERO** by **KHANI STAR**, which jumped away awkwardly. Rider reported he did not ride his mount out in his normal manner, as he was concerned with the mare's action. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the mare performing satisfactorily in an Official Barrier Trial.

RACE 5: BRERETON JEWELLERS CONGRATULATES TODD PANNELL - JO TY BENCHMARK 60 HANDICAP - 1700 metres

BIG CALL (C. Lions) - raced wide without cover throughout the event.

DESIDERO (S. Logan) - raced keenly in the early stages of the event. Near the 50 metres rider dropped her off side reign, which she regained shortly thereafter.

GROOVE WITH ME (L. Neindorf) - when questioned regarding his tactics in the early and middle stages of the event rider explained that after obtaining the lead near the 1500 metres his mount raced keenly and despite his efforts proved difficult to settle when racing to the inside of **DESIDERO**. Explanation was noted.

I'M BULLETPROOF (D. Tourneur) - rider reported that in his opinion his mount resented the tongue-tie throughout the event. Explanation was noted.

TATTIES (T. Voorham) - slow to begin.

DOWNUNDER PRINCE (P. Gatt) - permission granted to ride 0.5 kg overweight. Hung out throughout the event.

RACE 6: APEX STEEL SUPPLIES BENCHMARK 60 HANDICAP - 2100 metres

HAKERAK (R. Hurdle) - slow to begin. Held up for clear running from the vicinity of the 400 metres until approaching the 200 metres.

CLASSY JOE (S. Fawke) - made the crossing near the 1750 metres awkwardly.

AMBISHOP (J. Maund) - a post-race veterinary examination revealed a tendon strain injury to the near fore superficial digital flexor tendon. First aid administered. Trainer Mr G. Searle was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

GO ONE MORE (P. Gatt) - rider reported that his saddle shifted back near the 1400 metres placing him at a disadvantage for the remainder of the event.

RACE 7: BUSHFIRE SEASON - BE PREPARED BENCHMARK 60 HANDICAP - 1500 metres

BWUVA (J. Chau) - raced keenly in the middle stages of the event.

CHUBBY RAIN (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

GETOUTTHEWAY (J. Potter) - momentarily held up for clear running upon entering the home straight.

RACE 7: BUSHFIRE SEASON - BE PREPARED BENCHMARK 60 HANDICAP - 1500 metres
(Cont'd)

BONTAZOLA (J. Maund) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

CLIPAHOLIC (S. Logan) - Stewards granted permission for apprentice S. Logan to ride as there was no other suitable rider available at the weight.

THRONES - a late scratching at 1.47 pm by order of Stewards on veterinary advice as the gelding had swelling to both hind legs. Trainer Mr S. Adams was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 8: CORNERSTONE STUD HEAT 3 - SIR PRANCEALOT SERIES BENCHMARK 60
HANDICAP**
- 1100 metres

READY SUNSHINE (J. Chau) - in the vicinity of the 900 metres was eased when crowded between **GRAVITY** and **TOUCH**, which shifted in.

TOUCH (L. Neindorf) - in the vicinity of the 900 metres shifted in when insufficiently clear of **READY SUNSHINE** resulting in that gelding having to be eased. Rider was severely reprimanded and advised to exercise more care when shifting ground in future. Held up for clear running from the entrance to the straight until near the 200 metres.

HE IS GOLDEN (P. Gatt) - raced keenly in the middle stages of the event.

THE TROOPER (J. Potter) - laid in, in the straight resulting in the rider having to stop riding and straighten the gelding on a number of occasions.

GRAVITY (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

ATOMIC LOKADE (E. Boyd) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.
