**RACE 1: TAB HANDICAP - 1200 metres**

**GOD'S PENNY** (G. Lo) - laid in under pressure in the straight.

**HANKSTAR** (R. Hurdle) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

**THREE LEGS IN** (L. Riordan) - reared on jumping away and was slow into stride.

**OUR AUGUST ROSE** (A. Jordsjo) - hung out rounding the home turn. Rider explained the filly had laid out rounding the home turn and had not felt comfortable in its action in the straight. A post-race veterinary examination revealed the filly was showing signs of mild colic. First aid administered.

**GOLDEN SNITCH** (L. Neindorf) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

**RACE 2: TAB ADELAIDE CUP DAY, MONDAY MARCH 9 HANDICAP - 1600 metres**

**OVER EXPOSURE** (T. Pannell) - laid in throughout the event. A post-race veterinary examination revealed the gelding to be lame in the near hind. Co-Trainer Mr C. McEvoy was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**PICKELHAUBE** (T. Voorham) - inconvenienced approaching the finish when REGALO DI GAETANO shifted out.

**REGALO DI GAETANO** (L. Neindorf) - held up from the entrance to the straight until inside the 300 metres. Laid in under pressure in the straight. Approaching the finish shifted out onto PICKELHAUBE.

**JESTER HALO** (C. Puls) - slow to begin. Raced keenly in the middle stages of the event.

**RACE 2: TAB ADELAIDE CUP DAY, MONDAY MARCH 9 HANDICAP - 1600 metres (Cont'd)**

**FRENCH GIRL** (L. Riordan) - raced keenly in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3: FURPHY HANDICAP - 1050 metres**

**SILVER MELODY** (D. Caboche) - reared on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**LAKHANI ROSE** (K. Crowther) - laid in under pressure in the straight.

**SONIC DEED** (D. Tourneur) - held up from the vicinity of 500 metres until inside the 200 metres.

**RASUMADOLE** (P. Gatt) - underwent a pre-race veterinary examination on arrival at the barriers which found the mare to be lame in the near foreleg and unfit to race. Acting on this advice Stewards withdrew RASUMADOLE at 1.24 pm.

**RACE 4: TAB CINDERELLA STAKES - 1050 metres**

**BRIBERY** (J. Holder) - laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

**MY RUBY** (J. Potter) - hampered on jumping away when contacted by STRIP CLUB. Raced keenly in the early and middle stages of the event.

**KIRINIA** (J. Toeroek) - inclined to shift out and away from other runners throughout the event.

**CINDERELLA** (D. Thornton) - had difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 300 metres.

**CHOSEN BLONDE** (T. Voorham) - inconvenienced on jumping away when taken in onto SHE'S DREAMING. A post-race veterinary examination revealed no visible abnormalities.

**DOTTIE DEE (NZ)** (T. Pannell) - had difficulty in obtaining clear ground from the entrance to the straight until in the vicinity of the 300 metres.

**SHE'S DREAMING** (K. Zechner) - inconvenienced on jumping away when contacted by CHOSEN BLONDE.

**VONDEXTER** (P. Gatt) - shifted in on jumping away contacting CHOSEN BLONDE.

**CARALUE** (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

**STRIP CLUB** (C. Lions) - jumped away awkwardly and contacted MY RUBY. Laid in under pressure in the straight.

**RACE 5: DOMINANT HANDICAP - 1200 metres**

**HARBOUR EXPRESS** (S. Logan) - laid in under pressure in the straight.

**FRENCH ROCK** (K. Crowther) - raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**YIN AND YANG** (P. Gatt) - reared on jumping away and was slow into stride.

**DEXSTRA** (A. Jordsjo) - raced wide without cover throughout the event.

**RACE 5: DOMINANT HANDICAP - 1200 metres (Cont'd)**

**CANIDAE** (S. Fawke) - inclined to lay out under pressure in the straight.

**RED DAZZLE** (J. Chau) - jumped away awkwardly.

**RACE 6: FLEURIEU MILK COMPANY HANDICAP - 1100 metres**

**CHAROSSA** (T. Pannell) - jumped away awkwardly. Raced keenly in the early stages of the event.

**BEAUTIFUL FLYER** (J. Potter) - kicked out at another horse in the race day stall area. Underwent a pre-race veterinary examination and was found to have a laceration and was lame in the off hind leg. First aid administered. Acting on this advice, Stewards withdrew BEAUTIFUL FLYER at 1.18 pm.. Trainer, Mr L. Jarvis was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**STAR OF MONSOON** (S. Logan) - laid in under pressure in the straight.

**ATOMIC LOKADE** (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 7: SCHWEPPE'S HANDICAP - 1050 metres**

**MIDNIGHT STORM** (T. Voorham) - in the vicinity of the 900 metres shifted in onto RIZSKI when insufficiently clear taking that gelding into the running line of TWO ODD SOX, which was forced to be checked to avoid the heels of RIZSKI. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 9 March and to conclude at midnight on Wednesday, 18 March 2020: a period of four meetings. Raced wide without cover throughout the event.

**BOLT I AM** (K. Crowther) - slow to begin.

**RIZSKI** (T. Pannell) - in the vicinity of the 900 metres was inconvenienced when taken in by MIDNIGHT STORM.

**WOULDA THOUGHT SO** (D. Tourneur) - jumped away awkwardly and shifted in onto TRIPLE DEEZ.

**TWO ODD SOX** (P. Gatt) - in the vicinity of the 900 metres had to be checked to avoid the heels of RIZSKI, which was taken in. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres.

**WANDO BEL** (C. Puls) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**TRIPLE DEEZ** (J. Holder) - inconvenienced on jumping away. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

**RACE 8: MEDALLION HOMES LORD REIMS STAKES - 2600 metres**

**SEE THE MASTER (IRE)** (J. Holder) - underwent a pre-race veterinary examination and passed fit to race. In the vicinity of the 800 metres was hampered when SOPHIE'S REVENGE shifted out. A post-race veterinary examination revealed an abrasion to the back of its near fore fetlock.

**HEART OF GRACE (JPN)** (D. Thornton) - jumped away awkwardly.

**RACE 8: MEDALLION HOMES LORD REIMS STAKES - 2600 metres (Cont'd)**

**SOPHIE'S REVENGE** (D. Tourneur) - shifted out in the vicinity of the 800 metres onto SEE THE MASTER (IRE). Rider severely reprimanded.

**LIBERTY LOVER** (J. Chau) - rider accidentally dropped his off side rein in the vicinity of the 200 metres.

**RACE 9: AAMI HANDICAP - 1600 metres**

**BLOW TORCH** (D. Thornton) - a post-race veterinary examination revealed no visible abnormalities.

**BALLAST** (K. Bishop) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed thumps. First aid administered.

**JANE'S ANGEL** (L. Riordan) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**LEORBIT** (P. Gatt) - Stewards permitted P. Gatt to ride the filly 0.5 kg over its declared weight of 54.5 kg. A post-race veterinary examination revealed no visible abnormalities.

**DESIDERO** (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**UNSCOPEABLE** (K. Zechner) - jumped away awkwardly. Raced wide without cover throughout the event.

**GETOUTTHEWAY** (J. Chau) - raced keenly in the early and middle stages of the event.

**LOPE DE WOLF** (J. Potter) - held up for a short distance approaching the 200 metres and had to alter course to obtain clear ground.
