RACE 1: AAMI QUEEN ADELAIDE STAKES (Listed) - 1050 Metres

THERESABEARINTHERE (J. Toeroek) - awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

EXTRA TIME (J. Holder) - laid out from near the 600 metres. Shortly after the entrance to the straight commenced to shift in when racing greenly and brushed with **DISCREPANCY** (NZ) near the 200 metres. Thereafter when being corrected, shifted out to improve and near the 100 metres commenced to lay out, shifted out and hampered **DOTTIE DEE** (NZ). Rider reminded of his obligations when his mounts commence to shift ground.

YULE MY HERO (P. Gatt) - contacted at the start.

HARD ROCK GIRL (D. Holland) - raced keenly in the early stages of the event. Near the 200 metres was inconvenienced by **ZOUSHINE** as that horse momentarily shifted in. Had difficulty obtaining clear running from near the 200 metres until near the 100 metres.

SOUL OBSESSION (D. Thornton) - awkward to begin, shifted out and contacted **YULE MY HERO**, which was taken out onto **TWIST OF FURY** resulting in contact between these two runners. Raced keenly in the early stages of the event and near the 800 metres was inconvenienced when racing inside of **TWIST OF FURY**, which was tightened.

ZOUSHINE (B. Vorster) - near the 200 metres shifted in momentarily and inconvenienced **HARD ROCK GIRL**.

DOTTIE DEE (NZ) (J. Allen) - near the 100 metres was hampered by **EXTRA TIME**, which shifted out to improve. A post-race veterinary examination revealed no visible abnormalities.

RACE 1: AAMI QUEEN ADELAIDE STAKES (Listed) - 1050 Metres (Cont'd)

TWIST OF FURY (Z. Spain) - contacted at the start. Raced keenly in the early stages of the event. Near the 800 metres was hampered by **TRANSPLANT**, which shifted in and away from **ZOUSHINE**. Near the 500 metres shifted out and contacted **GAZE GRISE**, which became unbalanced. Rider was severely reprimanded and advised to take greater care when shifting ground.

GAZE GRISE (D. Tourneur) - near the 500 metres was contacted by **TWIST OF FURY**, which shifted out and as a consequence became unbalanced.

TRANSPLANT (K. Crowther) - near the 800 metres shifted in momentarily, away from **ZOUSHINE** as that horse improved to its outside, and as a consequence tightened **TWIST OF FURY**, which was hampered when taken in onto **SOUL OBSESSION**. As a consequence **SOUL OBSESSION** was inconvenienced. Rider had difficulty obtaining clear running from near the entrance to the straight until near the 200 metres.

DISCREPANCY (NZ) (E. Finnegan) - awkward to begin and as a consequence rider lost her near side iron momentarily. Raced greenly in the straight. Lost its near hind plate during the event.

FEARLESS VISION (E. Boyd) - awkward and slow to begin.

RACE 2: CELEBRATION OF ADELAIDE HILLS #OPENFORBUSINESS HANDICAP - 1200 Metres

The start of this event was delayed approximately four minutes.

STAR OF MONSOON (S. Logan) - held up for clear running for a short distance near the entrance to the straight. Inside the 200 metres was taken in slightly by **HARPUNA**, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

BLOW TORCH (J. Allen) - slow to begin. Held up for clear running from near the 400 metres until shortly after the entrance to the straight.

ROCK HARBOUR (K. Crowther) - on arrival at the barriers was attended to by the Farrier as it had lost its near fore plate en route to the barriers, and was reshod. Underwent a pre-race veterinary examination and was passed fit to race. Unable to obtain clear running from near the entrance to the straight until approaching the 200 metres where it was obliged to shift wider on the track to gain clear ground.

HARPUNA (R. Hurdle) - raced keenly in the early stages of the event. Rider could offer no explanation for the gelding's performance other than it changed stride on a number of occasions in the straight. A post-race veterinary examination revealed no visible abnormalities.

ARAY OF SUNSHINE (E. Boyd) - laid out in the straight.

BRITISH ISLE (E. Brown) - rider explained the gelding did too much work in the early part of the event and failed to finish the event off and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

SHE'S NEVER LATE (K. Bishop) - reared as the gates were released and was very awkward and slow to begin.

ALSVIOR (P. Gatt) - inclined to lay out in the straight.

GUCCI GUY (J. Holder) - awkward to begin. Raced keenly in the early stages of the event.

RACE 3: TERRY HOWE PRINTING HANDICAP - 1600 Metres

NASEEB (B. Vorster) - inside the 1200 metres commenced to over-race and became awkward on the heels of ROSELLI STING and when being restrained, became unbalanced and as a consequence lost a little ground. Thereafter approaching the 700 metres when improving its position, again became awkward on the heels of CHAPEL CITY and when being restrained, lost ground. A post-race veterinary examination revealed no visible abnormalities.

ROSELLI STING (C. Jones) - approaching the 100 metres was obliged to alter course to the outside of MARINA to improve its position. A post-race veterinary examination revealed no visible abnormalities.

GIGGLON (J. Allen) - had its tongue-tie readjusted on arrival at the barriers. A post-race veterinary examination revealed no visible abnormalities.

LIEDER (D. Thornton) - laid in, in the straight.

SKY PUNCH (NZ) (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

TABLE OF WISDOM (S. Fawke) - rider explained his instructions were to make an assessment as to whether to settle forward based on how the gelding began in this event. He stated that as a consequence of the gelding being awkward and slow to begin and having regard for his wide barrier, he elected to shift in to obtain cover as he considered it may best suit his mount.

RACE 4: DOMINANT PORT ADELAIDE CUP (Listed) - 2500 Metres

OCEANEX (NZ) (Z. Spain) - awkward to begin. Rider lost control of his off side rein for a number of strides near the 200 metres.

EPERDUMENT (G. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

FRANKED (GB) (T. Pannell) - rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed signs of the thumps and tying up in both shoulders and hindquarters. First aid administered.

TIGRE ROYALE (NZ) (E. Brown) - rider explained the gelding never travelled during the event and despite his efforts failed to improve its position and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

LOOKING AROUND (NZ) (P. Gatt) - awkward to begin.

HASTA LA BULLET (E. Finnegan) - rider reported the gelding felt uncomfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: FURPHY QUEEN OF THE SOUTH STAKES (Group 2) - 1600 Metres

FIDELIA (D. Thornton) - at the entrance to the straight laid in, shifted in and contacted NIPPERKIN and thereafter laid in for the remainder of the event.

SNOGGING (E. Brown) - near the 1500 metres shifted in to take up a forward position and in doing so tightened DREAMED, which was hampered when taken in and as a consequence tightened MABEL JOSEPHINE, which in turn was tightened onto NOVEMBER DREAMING, resulting in both those runners being hampered. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

NIPPERKIN (J. Holder) - at the entrance to the straight was inconvenienced when contacted by FIDELIA, which laid in and shifted in.

RACE 5: FURPHY QUEEN OF THE SOUTH STAKES (Group 2) - 1600 Metres (Cont'd)

VANUATU (D. Holland) - a post-race veterinary examination revealed no visible abnormalities.

SHROUDED IN MIST (B. Vorster) - Co-Trainer Mr T. McEvoy advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to attempt to lead if possible.

POYSED TO REIN (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

DREAMED (D. Tourneur) - tightened near the 1500 metres by **SNOGGING**, which shifted in and as a consequence had to be steadied to avoid that runners heels.

MABEL JOSEPHINE (S. Logan) - near the 1500 metres was tightened when racing to the inside of **DREAMED** as that horse received pressure from its outside and shifted in. Lost its near hind plate during the event.

NOVEMBER DREAMING (G. Cartwright) - near the 1500 metres, after initially being tightened and hampered to the inside of **MABEL JOSEPHINE**, as that horse received pressure from its outside, commenced to over-race for a short distance thereafter. Near the 400 metres was held up for clear running for a short distance and laid out in the straight. Rider explained the filly travelled well in the early stages of the event however, may have resented racing to the inside of other runners and was disappointing in its finishing effort. She added it was her intention to obtain a better position in running in the early stages but owing to suffering interference shortly after the start, was unable to do so and was obliged to settle further back. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: TAB EUCLASE STAKES (Group 2) - 1200 Metres

GARNER (J. Holder) - raced keenly in the early stages of the event.

FREE OF DEBT (J. Allen) - shifted in shortly after the start onto **CALYPSO REIGN** taking that horse in onto **TENLEY** resulting in **CALYPSO REIGN** and **TENLEY** being inconvenienced. Raced keenly in the early stages of the event. Laid in, in the straight.

ROCCABASCERANA (T. Pannell) - laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

HANKSTAR (C. Jones) - raced wide without cover in the early and middle stages of the event. Raced keenly in the early stages of the event.

CALYPSO REIGN (D. Thornton) - tightened at the start by **FREE OF DEBT**, which shifted in after jumping away and as a consequence was unable to maintain its position when tightened onto **TENLEY**.

TENLEY (J. Toeroek) - shortly after the start was tightened between **LI'L KONTRA**, which rolled out and **CALYPSO REIGN**, which was taken in by **FREE OF DEBT**. As a consequence **TENLEY** was unable to maintain its position shortly after the start. A post-race veterinary examination revealed no visible abnormalities.

LI'L KONTRA (D. Tourneur) - rolled out shortly after the start.

I AM ELOQUENT (E. Brown) - was inclined to lay in, in the early part of the straight, thereafter shifted ground both ways in the straight.

RACE 7: SCHWEPPE OAKS (Group 1) - 2000 Metres

FASCINO (NZ) (S. Cahill) - Stewards permitted S. Cahill to ride the filly 0.5 kg over its declared weight of 56kg. Awkward to begin. Raced wide without cover in the middle stages of the event. Near the 900 metres was taken wider by **SILENT SOVEREIGN**, which shifted out to improve its position. Shortly after the entrance to the straight rolled in at the same time as **SILENT SOVEREIGN** shifted out momentarily and as a consequence, became awkwardly placed on the heels of **SILENT SOVEREIGN** and was obliged to be checked to avoid that horse's heels.

NUDGE (T. Pannell) - approaching the 200 metres had difficulty obtaining clear running, was obliged to shift out near the 200 metres and in doing so brushed with **ZAYYDANI (NZ)** taking that horse a little wider, and thereafter was only able to obtain clear ground near the 100 metres.

MOONLIGHT MAID (Z. Spain) - raced wide without cover for a short distance from inside the 1600 metres before improving its position to lead in the event.

VEGAS JEWEL (NZ) (J. Holder) - had difficulty obtaining clear running from near the 200 metres and inside the 200 metres was obliged to shift in to obtain clear running. Was inclined to lay in at various stages in the straight. A post-race veterinary examination revealed no visible abnormalities.

BETCHA FLYING (D. Tourneur) - for a short distance racing to the 1600 metres was awkwardly placed on the heels of runners owing to the lack of pace in the event.

WINGS OF PASTRAMI (J. Toeroek) - awkward to begin, shifted out contacted **TOFFEE TONGUE (NZ)** and thereafter shifted back in onto **BEAUTY BOLT** contacting that horse. Near the 1800 metres was awkwardly placed on the heels of runners and raced ungenerously for a number of strides when being restrained. For a short distance racing to the 1600 metres was awkwardly placed on the heels of runners owing to the lack of pace in the event.

SILENT SOVEREIGN (B. Vorster) - approaching the 1800 metres, near the crossing, when taken out by **VEGAS JEWEL (NZ)**, which was taken out by **TOFFEE TONGUE (NZ)** as that horse shifted out to afford running room to **WINGS OF PASTRAMI** to its inside, became awkwardly placed on the heels of **BETCHA FLYING**, which shifted in. As a consequence was severely hampered, had to be checked and lost its position.

BEAUTY BOLT (D. Holland) - contacted at the start.

ZAYYDANI (NZ) (P. Gatt) - near the 200 metres was brushed by **NUDGE**, which shifted out and was taken a little wider.

WALKING FLYING (NZ) (R. Hurdle) - when questioned regarding his riding rounding the home turn and into the straight, in particular with reference to him leaving the fence from near the 400 metres, R Hurdle explained that his instructions were to improve away from the fence on entering the straight as the stable had considered that the track conditions were better suited away from the fence. He added that after doing so, the filly was also inclined to lay out in the early part of the straight and thereafter over the concluding stages continued to lay out and shifted wider on the track.

Correct weight was delayed to allow G. Cartwright the rider of **LA FALAISE** and Mr R. Jolly acting on behalf of Trainer Mr H. Dwyer, to view the vision near the entrance to the straight.

RACE 8: TAB CLASSIC (Group 1) - 1200 Metres

SUNLIGHT (B. Vorster) - raced very wide for the first 600 to 700 metres of the event before crossing to take closer order to the field. When questioned, rider explained, earlier in the day, he and Trainer Mr T. McEvoy walked the track in the vicinity of the home turn and near the 600 metres, and formed the view there was ground available wider on the track that had not been galloped on and was fresh and as a consequence, his instructions were to attempt to take up a forward position in running but not to cross to the field and remain wide on the track and only cross to the field near the 500 metres. He added he complied with those instructions however,

RACE 8: TAB CLASSIC (Group 1) - 1200 Metres (Cont'd)

when crossing to take up closer order to the field near the 500 metres, the mare was under pressure, was disappointing and failed to finish the event off as expected. Co-Trainer Mr T. McEvoy confirmed he and jockey B. Vorster had walked that part of the track together earlier in the day, and also confirmed the instructions provided. A post-race veterinary examination revealed no visible abnormalities.

I AM EXCITED (D. Tourneur) - was heavily contacted by **AWAY GAME** at the start as that horse began very awkwardly and shifted out, and as a consequence shifted out onto **BAM'S ON FIRE** inconveniencing that horse.

MADAM ROUGE (K. Crowther) - inside the 1000 metres was inconvenienced for several strides by **BELLA VELLA**, which shifted in.

TELEPLAY (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

BAM'S ON FIRE (J. Toeroek) - inconvenienced at the start when taken out by **I AM EXCITED** as that horse was contacted by **AWAY GAME**. As a consequence was hampered and was unable to maintain its position. Rider reported it was his intention to settle more forward but as a consequence of the interference suffered at the start was unable to do so.

SPANISH WHISPER (E. Brown) - shifted ground slightly over the concluding stages.

HUMMA HUMMA (Z. Spain) - shifted ground slightly over the concluding stages.

EMBRACE ME (NZ) (J. Allen) - a post-race veterinary examination revealed a lower than expected heart rate.

BELLA VELLA (T. Pannell) - inside the 1000 metres shifted in and inconvenienced **MADAM ROUGE** for several strides. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

AMBERDI (P. Gatt) - approaching the 200 metres, when racing between the heels of **MADAM ROUGE** and **I AM EXCITED**, was unable to improve into that run, shifted out to obtain clear running and in doing so took the running of **STREET ICON**, which had improved to its outside, resulting in **STREET ICON** having to be steadied for several strides to avoid that horse's heels. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday 6 May 2020 and to conclude at midnight on Friday 15 May 2020; a period of four meetings.

STREET ICON (R. Hurdle) - approaching the 200 metres was obliged to be steadied for several strides to avoid the heels of **AMBERDI** as that horse shifted out to improve.

BEAUTIFUL FLYER (J. Potter) - tightened near the finishing post between **HUMMA HUMMA** and **SPANISH WHISPER**, which both shifted ground slightly.

AWAY GAME (D. Holland) - very awkward to begin, shifted out and made heavy contact with **I AM EXCITED**.

RACE 9: D C MCKAY STAKES (Group 3) - 1100 Metres

HOME OF THE BRAVE (IRE) (B. Vorster) - awkward to begin, shifted out and inconvenienced **SHAMINO**. A post-race veterinary examination revealed no visible abnormalities.

VIRIDINE (J. Holder) - inconvenienced and taken out at the start by **BEHEMOTH**, which shifted out.

BEHEMOTH (T. Pannell) - shifted out at the start onto **VIRIDINE**, which was taken out and inconvenienced.

RACE 9: D C MCKAY STAKES (Group 3) - 1100 Metres (Cont'd)

PARSIFAL (NZ) (D. Thornton) - a post-race veterinary examination revealed no visible abnormalities.

SHAMINO (K. Crowther) - inconvenienced at the start. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer Mr P. Stokes was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future Approval to Race jump out, trial or race.

KABINI (J. Toeroek) - held up for clear running from near the 400 metres until shortly after the entrance to the straight.
