Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 10 October 2020

TRACK: Soft 5 (Track with a reasonable amount of give in it)
Upgraded to a Good 4 at 10.45 am (Track with some give in it)

RAIL: Out 4 metres entire. Sectional 605 metres.

Owing to a request from Sky Channel, Races 1-8 were all rescheduled to start two minutes later than the original advertised start time.

RACE 1: ROMEO'S LOCALI HANDICAP - 1100 Metres

The start of this event was delayed approximately one minute.

BRIMARVI VEHERO (S. Logan) - laid out under pressure in the straight. Rider reported that the gelding felt uncomfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

JACOBITE PRINCE (J. Toeroek) - raced wide without cover throughout the event.

PORT VALE (S. Cahill) - became fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and passed fit to start. Trainer, Mr S. Gower, was advised that a warning had been placed on the gelding in relation to its barrier manners.

MYSTICANO (J. Holder) - inclined to lay in under pressure in the straight.

KAYSERI (NZ) (J. Eaton) - jumped away awkwardly and was slow to begin. Raced fiercely in the early and middle stages of the event.

RACE 2: FARMER'S UNION HANDICAP - 1200 Metres

EF TROOP (J. Eaton) - jumped away awkwardly.

RACE 3: ENZO'S AT HOME HANDICAP - 1800 Metres

MASTER CHUM (E. Boyd) - rider reported that the gelding had failed to let down when placed under pressure and was disappointing to the finish. A post-race veterinary examination revealed the gelding to be lame in both hind legs. Trainer, Mr R. Wilkinson, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

ZOURKHAN (IRE) (D. Caboche) - raced keenly in the early and middle stages of the event.

DR DEPENDABLE (J. Holder) - laid in under pressure in the straight.

KORODON (NZ) (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: TAB MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately 10 minutes owing to an evacuation alarm sounding, which required the buildings on course to be vacated.

CASHIN' CHEX (NZ) (K. Crowther) - contacted on jumping away and taken out onto TRADEWIND.

BON PEGASUS (J. Maund) - jumped away awkwardly. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr G. Lynch, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DEEP SPEED (B. Vorster) - laid out under pressure in the straight.

MORIALTA (J. Eaton) - contacted on jumping away and taken out onto CASHIN' CHEX (NZ).

MORTY (J. Potter) - slow into stride. Raced greenly throughout the event. From the entrance to the straight until the 200 metres had difficulty obtaining clear ground.

SELLIX (K. Zechner) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

STRUCK BY (P. Gatt) - inclined to lay out under pressure in the straight.

TRADEWIND (D. Tourneur) - hampered on jumping away when contacted by CASHIN' CHEX (NZ). Raced greenly throughout the event. Laid in under pressure in the straight.

VANCOUVER VELVET (J. Holder) - jumped away awkwardly and shifted out onto MORIALTA.

YEELANNA (C. Lions) - jumped away awkwardly and shifted out abruptly. Raced wide without cover throughout the event.

SHE'S ALL SPICE (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

SPARKUP (J. Toeroek) - raced greenly throughout the event and laid out rounding the home turn.

ASTON RAPOVA (S. Logan) - raced keenly in the early and middle stages of the event. At the entrance to the straight became awkwardly placed on the heels of SHE'S ALL SPICE until the vicinity of the 300 metres.

STRIDENT (C. Jones) - slow to begin. Rider reported that the gelding felt uncomfortable in its action in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr B. Papazaharoudakis, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RACE 5: ANTONIO AND ELISABETH HANDICAP - 1100 Metres

EXTRA TIME (J. Holder) - laid out rounding the home turn.

GREAT LEVELLER (P. Gatt) - jumped away awkwardly.

MILEVA (A. Jordsjo) - shifted out on jumping away onto YULE MY HERO.

GOLD DERBY (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

FEARLESS VISION (E. Boyd) - raced wide without cover throughout the event. Rider explained that the filly felt flat when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

KIRINIA (J. Toeroek) - slow to begin.

RICHEDE (J. Maund) - laid in under pressure in the straight.

TWIST OF FURY (K. Crowther) - laid in under pressure over the concluding 200 metres. A post-race veterinary examination revealed no visible abnormalities.

YULE MY HERO (S. Fawke) - taken out on jumping away contacting DANITYAH.

DANITYAH (B. Vorster) - hampered on jumping away when its hindquarters were turned after being contacted by YULE MY HERO. Raced keenly in the early and middle stages of the event. Laid in under pressure over the concluding 200 metres

RACE 6: CRAWFORD LEGAL HANDICAP - 1600 Metres

EXTREME THRILL (S. Logan) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

RITRATTO (R. Hurdle) - shifted out abruptly inside the 100 metres.

STAR STATUS (T. Voorham) - jumped away awkwardly and shifted out onto GETOUTTHEWAY. Raced keenly in the early and middle stages of the event.

ZENDE (J. Eaton) - raced keenly in the middle stages of the event.

CANFORD (D. Tourneur) - raced keenly in the early and middle stages of the event.

MANHATTAN GANGSTER (P. Gatt) - slow to begin.

GETOUTTHEWAY (J. Maund) - inconvenienced on jumping away when STAR STATUS shifted out.

SOWPODS (K. Crowther) - raced keenly in the early and middle stages of the event.

RACE 7: HILL SMITH STAKES - 1800 Metres

SO YOU CAN (J. Holder) - raced keenly in the early and middle stages of the event.

CROWN MINT (K. Crowther) - inclined to lay out under pressure in the straight.

AIN'TNODEELDUN (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty Stewards took into account that this was D. Tourneur's sixth offence in the calendar month, and also that this was a listed race.

RACE 7: HILL SMITH STAKES - 1800 Metres (cont'd)

ZEPPA (J. Toeroek) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Co-trainers, Messrs Tony and Calvin McEvoy, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

THE OLYMPIAN (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

TALAMO (NZ) (J. Eaton) - rider reported that the gelding was under pressure from the vicinity of the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

DALGARNO (NZ) (J. Maund) - rider reported that the colt travelled well, but failed to let down when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: 36° SOUTH BEEF HANDICAP - 1050 Metres

The start of this event was delayed approximately three minutes.

HANKSTAR (J. Holder) - became fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was passed fit to start. Rider explained that he had settled further back than anticipated due to the early speed in the race; however, after placing the gelding under pressure in the vicinity of the 500 metres it failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

EXTRA MILE (C. Jones) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 100 metres. Inclined to lay in under pressure in the straight.

GROOT (K. Crowther) - laid in under pressure in the straight.

AKKACAN (T. Voorham) - laid in under pressure in the straight.

GRINZINGER EXPRESS (NZ) (D. Caboche) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

LIVE FAST (D. Tourneur) - proved difficult to load. Trainer, Mr S. Whittle, was advised that a warning had been placed on the gelding in relation to its barrier manners. In the vicinity of the 500 metres shifted out to improve and in doing so hampered PARTY HACK. Rider was reminded of his obligations to ensure he was sufficiently clear before shifting ground in future.

PARTY HACK (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

GOOD LUCK CHUCK (S. Fawke) - hampered in the vicinity of the 500 metres when LIVE FAST shifted out.

RACE 9: EMPEROR SUSHI HANDICAP - 1200 Metres

ROHLON DRUNK (T. Voorham) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BEEOKAY (S. Logan) - laid in under pressure in the straight.

SUNMATE (D. Tourneur) - inside the 500 metres had to be steadied for a number of strides when HAPPY LAD shifted out.

RACE 9: EMPEROR SUSHI HANDICAP - 1200 Metres (cont'd)

HAPPY LAD (A. Jordsjo) - inside the 500 metres shifted out to improve and in doing so shifted into the running line of **SUNMATE**. Rider was reprimanded and advised in future to ensure she was sufficiently clear prior to shifting ground.

YOU HADME AT HELLO (J. Eaton) - raced wide without cover throughout the event.

THE RAVEN (J. Potter) - raced keenly in the early stages of the event and in the vicinity of the 1000 metres had to be momentarily steadied when **EXALTED QUEEN** shifted in.

EXALTED QUEEN (J. Holder) - inside the 1200 metres shifted in onto **THE RAVEN**. Rider reminded of his obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

MIHANY (J. Maund) - slow to begin. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr D. Saxon, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.
