**RACE 1: WESLO SECURITY 3MW-LY HANDICAP - 1200 Metres**

DEXELATION (C. Jones) - jumped away awkwardly.

FOX HALL (B. Vorster) - jumped away awkwardly and was slow to begin.

JACOBITE PRINCE (J. Eaton) - inclined to lay in under pressure in the straight.

EXALTED LAURETTA (A. Jordsjo) - lost its off fore plate during the event.

**RACE 2: AAMI MAIDEN PLATE - 1200 Metres**

The start of this event was delayed approximately two minutes.

MODRIC (D. Tourneur) - in the vicinity of the 200 metres had to be steadied for a short distance when L'IL PIPER shifted out. A post-race veterinary examination revealed no visible abnormalities.

KRUPTONITE (S. Logan) - laid out under pressure in the straight.

LYRICKIN'S DREAM (C. Lions) - unable to obtain clear ground over the concluding 100 metres.

SELLING CANDY (R. Hurdle) - raced wide without cover throughout the event. Inclined to lay out under pressure in the straight.

L'IL PIPER (D. Caboche) - raced keenly in the early and middle stages of the event. In the vicinity of the 200 metres shifted out onto MODRIC. Rider was severely reprimanded under AR131(a) for careless riding.

**RACE 2: AAMI MAIDEN PLATE - 1200 Metres (Cont'd)**

**TOUGH LASSIE** (J. Maund) - a post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer Mr C. Bieg was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**BETTER** (K. Crowther) - proved difficult to load. Trainer Mr J. O'Connor was advised a warning had been placed on the filly in relation to its barrier manners.

**RACE 3: SOUL GROWERS SABOIS+ BENCHMARK 82 HANDICAP - 2028 Metres**

**CLASSY JOE** (J. Maund) - in the vicinity of the 200 metres was momentarily inconvenienced when RITRATTO rolled in.

**RITRATTO** (R. Hurdle) - in the vicinity of the 200 metres rolled in onto CLASSY JOE. Rider was questioned in relation to his riding to the finish. After considering his explanation, rider was reminded of his obligations under AR131(b) in riding his mounts out to the end of the race.

**DARLAMAX** (J. Holder) - jumped away awkwardly.

**ACE OF CLUBS** (C. Lions) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

**ENRICO PALLAZZO** (J. Eaton) - jumped away awkwardly. Rider explained the gelding travelled well in the early and middle stages of the event, however when placed under pressure, failed to respond to her riding and in her opinion, was not suited by the slow tempo of today's race. A post-race veterinary examination revealed no visible abnormalities.

**RESURGE** (B. Vorster) - had difficulty obtaining clear ground from the vicinity of the 450 metres until the entrance to the straight.

**HAPPY ATOM** (K. Crowther) - slow to begin.

**RACE 4: ADELAIDE GALVANISING REBEL RAIDER SERIES FINAL - 1200 Metres**

**EXTRA TIME** (J. Holder) - raced keenly in the early and middle stages of the event.

**MILEVA** (A. Jordsjo) - a post-race veterinary examination revealed mild tying up in the hindquarters. First aid administered.

**CELESTINE** (B. Vorster) - jumped away awkwardly. Laid in under pressure in the straight.

**ALLEBOOM** (C. Jones) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**GREAT LEVELLER** (P. Gatt) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Rider reported the gelding had not responded to his riding when asked for an effort in the vicinity of the 600 metres. He added that he had become concerned with its action over the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

**QUIETLY DISCREET** (K. Crowther) - a post-race veterinary examination revealed an elevated heart rate and slower than expected recovery.

**GAZE GRISE** (K. Zechner) - inclined to lay out under pressure in the straight.

**RACE 5: HAPPY 50TH BRAD SMART ENTIRES AND GELDINGS BENCHMARK 68 HANDICAP**  
**- 1200 Metres**

**RAISE AN ARMY** (S. Cahill) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RENEGADE** (B. Vorster) - raced wide without cover throughout the event.

**FRIDAY FUNDAY** (J. Holder) - laid out under pressure in the straight. Rider reported he had difficulty in riding his mount out to the finish due to it laying out. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Ms A. Bush was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**BEZAZZALLED** (T. Pannell) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200 metres.

**HE WILL BOOM** (D. Caboche) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: SCHWEPPE'S BENCHMARK 58 HANDICAP - 1600 Metres**

**MR EPIC** (T. Voorham) - laid out under pressure in the straight. In the vicinity of the 300 metres shifted out onto HOLY SANGRIA. Rider was reprimanded and advised to make a greater effort to keep her mounts straight in future, when they commence to shift ground.

**BIG DARRYL** (J. Holder) - jumped away awkwardly and shifted out contacting SOSTENIDO (NZ). Rider reported the gelding travelled well in the early and middle stages of the event, however had not finished off the race as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

**LI'L HANK** (D. Tourneur) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

**ROCK STEADY (NZ)** (J. Toeroek) - rider reported the gelding hung in throughout the event. Inside the 200 metres had to take hold when awkwardly placed on the heels of ACE ATTACK, which rolled out slightly. Rider was advised to ensure there was sufficient room to attempt runs in future. A post-race veterinary examination revealed no visible abnormalities.

**ACE ATTACK** (P. Gatt) - inside the 200 metres shifted out slightly into the running line of ROCK STEADY (NZ).

**YOUNG LARS** (S. Cahill) - slow to begin. In the vicinity of the 200 metres was contacted by ROCK STEADY (NZ), which was attempting to improve into a tight run to its inside.

**FLORIANO** (S. Logan) - raced keenly in the early and middle stages of the event. Difficulty obtaining clear ground from the vicinity of the 300 metres until near the 100 metres. In the vicinity of the 50 metres had to momentarily steady when CITY BEATS shifted out. A post-race veterinary examination revealed no visible abnormalities.

**HOLY SANGRIA** (J. Maund) - raced wide without cover throughout the event. In the vicinity of the 300 metres was inconvenienced when MR EPIC shifted out.

**SOSTENIDO (NZ)** (R. Hurdle) - contacted on jumping away.

**CITY BEATS** (S. Fawke) - laid out over the concluding 200 metres. In the vicinity of the 50 metres shifted out onto FLORIANO. Rider was reprimanded under AR131(a) for careless riding.

**RACE 7: BAROSSA FINE FOODS BENCHMARK 72 HANDICAP - 1100 Metres**

**BE MY STAR** (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

**MESSERSCHMITT** (J. Eaton) - underwent a pre-race veterinary examination and passed fit to race. Rolled out and brushed THOMPSON'S REWARD in the vicinity of the 100 metres.

**STREET LIFE** (T. Pannell) - had to be momentarily steadied in the vicinity of the 600 metres when it became awkwardly placed on the heels of THOMPSON'S REWARD.

**SAORSA** (K. Zechner) - a post-race veterinary examination revealed no visible abnormalities.

**KENYAN WONDER** (C. Jones) - raced keenly in the early and middle stages of the event.

**THOMPSON'S REWARD** (P. Gatt) - rolled in and bumped MESSERSCHMITT in the vicinity of the 100 metres.

**EXALTED MAXINE** (A. Jordsjo) - laid out under pressure in the straight.

**AADELAD** (J. Toeroek) - raced keenly in the early and middle stages of the event.

**LA VITA** (J. Holder) - Stewards permitted J. Holder to ride the filly 0.5 kg over its declared weight of 54kg.

**RIZSKI** (D. Tourneur) - raced keenly in the early and middle stages of the event.

Correct weight was delayed to allow J. Holder (LA VITA), placed third, to view the vision in the straight.

**RACE 8: FURPHY BENCHMARK 58 HANDICAP - 1100 Metres**

**LIKE A HEARTBEAT** (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

**THE PUBLIKIN** - fractious on exiting the mounting yard dislodging its rider. The mare galloped riderless for some time prior to being recaptured. A late scratching at 4.52 pm on veterinary advice. Trainer Mr G. Kluske was advised that a warning had been placed on THE PUBLIKIN.

**OUR BENEVENTO** (J. Holder) - raced wide without cover throughout the event.

**SONIC DEED** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**CIRCUS DANCER** (J. Maund) - jumped away awkwardly. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer, Ms M. Moyle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**SHARPLY ATTIRED** (K. Crowther) - a late scratching at 8.45 am on confirmed advice from Trainer Mr J. MacMillan that the mare was unfit to race. Mr MacMillan was reprimanded under LR19.1.1 for failing to scratch by the require time. Steward took into account that the late scratching had not cost any other horse a start.

**GOOD LUCK CHUCK** (S. Fawke) - raced keenly in the early and middle stages of the event.

**RACE 9: TAB MARES BENCHMARK 72 HANDICAP - 1200 Metres**

**GOLDEN HALO** (J. Eaton) - jumped away awkwardly and shifted out contacting LA RICHESSE.

**PRETTY GLASS** (E. Boyd) - in the vicinity of the 100 metres had to be checked and lost its position when OH PLEASE DIANNA shifted out into its running line.

**RACE 9: TAB MARES BENCHMARK 72 HANDICAP - 1200 Metres (Cont'd)**

**POYSED TO REIN** (J. Toeroek) - approaching the finish had to be steadied when OH PLEASE DIANNA shifted out into its running line.

**HEARTY LASS** (C. Jones) - raced keenly in the early and middle stages of the event.

**LIANNE** (A. Jordsjo) - slow into stride.

**DAZZLING DAMSEL** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**LA RICHESSE** (J. Holder) - contacted on jumping away. Raced wide without cover throughout the event.

**OH PLEASE DIANNA** (B. Vorster) - jumped away awkwardly. Laid out under pressure in the straight. In the vicinity of the 100 metres shifted out under-riding when insufficiently clear of PRETTY GLASS, which was forced to be checked. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 17 October and to conclude at midnight on Saturday, 24 October 2020: a period of three meetings. Continued to shift out under riding approaching the finish and shifted out onto POYSED TO REIN. Rider was severely reprimanded under AR131(a) for careless riding.

Correct weight was delayed to allow J. Toeroek (POYSED TO REIN), placed fourth, to view the vision over the concluding stages.
