STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse  
by the South Australian Jockey Club on Saturday, 5 December 2020

**TRACK:** Good 4 (Track with some give in it)

Downgraded to a Soft 5 at 4.26pm  
Retrospective to Race 7 (Track with a reasonable amount of give in it)

**RAIL:** Out 9 metres 1200 metres to winning post, 6 metres Remainder - Sectional 612 metres

**WEATHER:** Overcast & Showery/Fine

**RACE 1: LECONFIELD HANDICAP - 1200 Metres**

**DESIGNER CHEF** (J. Holder) - was contacted inside the 100 metres by GIGGLON, which rolled in.

**GIGGLON** (C. Lions) -raced wide without cover throughout the event. Inside the 100 metres rolled in and contacted DESIGNER CHEF.

**MISS JANE** (J. Eaton) - in the vicinity of the 200 metres rolled in and inconvenienced FULTON STREET.

**CALL IT A DAY** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**FULTON STREET** (M. Collett) - inclined to rear on jumping away and as a consequence was awkward to begin. Rider reported as a result of the gelding being awkward to begin, she was unable to take up a more forward position as intended. In the vicinity of the 200 metres, when attempting to improve to the inside of MISS JANE, was obliged to be restrained and was unable to improve as that horse rolled in. Thereafter, had difficulty obtaining clear running for the remainder of the event. Rider explained she anticipated she would be able to improve to the inside of MISS JANE after passing the 200 meters as that horse appeared to commence to roll out, however, in her view MISS JANE had not rolled out to an extent that afforded her clear running to improve into. She added the gelding did not respond to her riding in a manner that would have allowed her to obtain the tight run that presented with confidence.

**LIKE A HEARTBEAT** (T. Voorham) - was inclined to shift about under pressure in the straight

**RACE 2: FURPHY THREE-YEARS-OLD MAIDEN PLATE - 1050 Metres**

**HELLO LADIES** (S. Cahill) - was taken wider near the 700 metres by OUTLAWS REVENGE. Thereafter approaching the entrance to the straight was again taken wider by OUTLAWS REVENGE, which shifted out to improve.

### **RACE 2: FURPHY THREE-YEARS-OLD MAIDEN PLATE - 1050 Metres (Cont'd)**

**OUTLAWS REVENGE** (D. Tourneur) - was awkward and slow to begin. Shifted out approaching the 700 metres taking HELLO LADIES wider. Thereafter approaching the entrance to the straight, shifted out to improve taking HELLO LADIES wider on the track.

**SCOTCH ON THE ROCK** (C. Jones) - near the 300 metres was tightened for room by WAR CHEVAL, which shifted in under riding and had to be momentarily checked to avoid that horse's heels and as a consequence, C. Jones became unbalanced. Thereafter racing to the 200 metres was again obliged to race in restricted room to the inside of WAR CHEVAL as that horse was tightened and taken in by DAILY SPIRIT, which shifted in under riding. As a consequence SCOTCH ON THE ROCK became very awkward for a number of strides on the heels of WAR CHEVAL and had to be checked.

**WAR CHEVAL** (S. Fawke) - had its tongue-tie refitted on arrival at the barriers. Near the 300 metres shifted in under riding tightening SCOTCH ON THE ROCK, which had to be checked. Rider was found guilty of a charge of careless riding under AR131(a) in that he allowed his mount to shift ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 13 December and to conclude at midnight on Saturday, 19 December 2020: a period of three meetings.

**DAILY SPIRIT** (J. Holder) - was awkward to begin. Inside the 300 metres shifted in under riding tightening WAR CHEVAL, which was taken in, into the running line of SCOTCH ON THE ROCK, resulting in that horse having to be checked off the heels of WAR CHEVAL. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 12 December and to conclude at midnight on Friday, 18 November 2020: a period of three meetings. In determining penalty, Stewards took into account J. Holder's very good record and his guilty plea.

### **RAC 3: TAB HANDICAP - 1050 Metres**

**EXALTED ZOE** (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

**NEW ROMAN** (D. Tourneur) - was very awkward to begin, shifted in and inconvenienced RUSHWA. Laid in, in the early part of the straight. A post-race veterinary examination revealed no visible abnormalities.

**L'IL PIPER** (J. Eaton) - was very awkward to begin, shifted out and momentarily inconvenienced ANAMNESIS. Inclined to lay in, in the straight. Lost its off fore plate during the event.

**RUSHWA** (J. Toeroek) - was inconvenienced at the start.

**ANAMNESIS** (K. Crowther) - was momentarily inconvenienced at the start.

### **RACE 4: PETER ELBERG FUNERALS HANDICAP - 1528 Metres**

**EXALTED TRAVELLER** (C. Jones) - laid in, in the early part of the straight.

**KYSHAKA** (T. Voorham) - inclined to lay in, in the straight.

**MALVADO** (M. Collett) - was awkward to begin, shifted out and inconvenienced JACKPOT JOHNNY.

**RACE 4: PETER ELBERG FUNERALS HANDICAP - 1528 Metres (Cont'd)**

**NONAME LANE** (T. Pannell) - raced wide without cover until near the 700 metres. On Friday, 4/12/2020 Stewards acceded to a request by Trainer Mr W. Clarken to allow a gear change in respect to the gelding. Mr Clarken requested the gelding be allowed to race equipped with a tongue-tie. Stewards, whilst permitting the late gear change, imposed a fine of \$200 under AR206 for a late gear declaration.

**RIKIBOBBY** (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

**JACKPOT JOHNNY** (J. Holder) - was inconvenienced at the start.

**RACE 5: HAPPY 18TH HANK THE DANK TANK HANDICAP - 1200 Metres**

**PICARGO** (C. Jones) - laid in, in the straight.

**HARPUNA** (B. Vorster) - over-raced and raced wide without cover in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**COTILLION** (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

**PARTY HACK** (J. Maund) - was eased from the event from near the entrance to the straight. A post-race veterinary examination revealed the gelding had bled from both nostrils. Rider reported that he felt something amiss with the gelding prior to straightening and on straightening he elected to not pursue with his normal vigour as a consequence. Trainer, Mrs N. Bruggemann, was advised that as this was the gelding's first bi-lateral bleed, PARTY HACK would now be suspended from being trained, exercised or galloped on any racecourse for a period of two months, and from racing for a period of three months in accordance with AR79(4) and thereafter would be required to complete a satisfactory gallop over 1000 metres, in the presence of a Steward, prior to accepting for a future race.

**RACE 6: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DEC 18 HANDICAP - 1100 Metres**

**TAKEN OFF** (K. Crowther) - was slow to begin.

**BEEOKAY** (C. Jones) - was awkward to begin. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**JUST CHIPPING AWAY** (J. Holder) - from near the entrance to the straight was inclined to lay in and commenced to shift in. Inside the 300 metres continued to shift in under riding and crossed the running of THE PUBLIKIN, resulting in C. Lions having to take hold to avoid the heels of JUST CHIPPING AWAY. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 18 December and to conclude at midnight on Wednesday, 23 December 2020: a period of three meetings. In determining penalty, Stewards took into account J. Holder's very good record and his guilty plea. Stewards ordered that this penalty be served cumulatively to the penalty imposed on J. Holder in Race 2. A post-race veterinary examination revealed no visible abnormalities.

**ROCK HARD** (D. Caboche) - when questioned regarding his instructions and his riding in the early part of the straight, rider explained he was instructed to settle forward. He added after obtaining a forward position the horse travelled well, and prior to entering the straight travelled in a manner which suggested it would finish the race off in a competitive manner, however, after asking the gelding for an effort in the straight it failed to respond in the manner he expected. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DEC 18 HANDICAP**  
**- 1100 Metres (Cont'd)**

**JUST KAPPY** (J. Toeroek) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr B. Mueller was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**STORM VOYAGER** (B. Vorster) - had to be re-saddled on arrival at the barriers. Shortly after the entrance to the straight was obliged to shift out to obtain clear running. Laid in, in the straight.

**THE PUBLIKIN** (C. Lions) - raced wide without cover in the middle stages of the event. Near the 300 metres, when crossed by JUST CHIPPING AWAY, C. Lions was obliged to take hold to avoid that horse's heels.

**RACE 7: ADELAIDE GALVANISING HANDICAP - 2034 Metres**

**VON COSTA GLASS** (C. Jones) - was contacted in the vicinity of the 500 metres by EPERDUMENT, which shifted out in an attempt to improve.

**EPERDUMENT** (J. Toeroek) - near the 500 metres attempted to improve outside the heels of CONFUSION, and in doing so contacted VON COSTA GLASS, which maintained its line. As a consequence, EPERDUMENT was unable to shift VON COSTA GLASS off its line and was obliged to race to the inside of that horse and behind CONFUSION and was unable to obtain a run to the outside of CONFUSION.

**QUAFFANY** (B. Vorster) - performed below expectations. Rider explained in his opinion the gelding appeared not to be suited by the track conditions. A post-race veterinary examination revealed no visible abnormalities.

**RITRATTO** (J. Eaton) - laid out in the straight.

**CONFUSION** (T. Pannell) - raced wide without cover for some distance from near the 1700 metres.

**NEVA DOUBT US** (K. Crowther) - rider explained she had no specific instructions but to allow the gelding to settle where comfortable from its wide barrier. Rider stated that as a consequence of being trapped wide in the early stages, having regard for the formation of the field and the runners to her inside, she elected to allow the gelding to stride forward and take up a forward position in running.

**JOURNICA** (T. Voorham) - which was fractious in its barrier stall, reared as the gates were released and as a consequence, was slow to begin losing three to four lengths. Rider reported it was her instructions and intention to settle in a more forward position but owing to the manner in which the gelding began, she was unable to do so. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow Stewards to view the vision of the start in respect of JOURNICA.

**RACE 8: TERRY HOWE PRINTING HANDICAP - 1050 Metres**

**LI'L KONTRA** (J. Holder) - laid out under pressure over the concluding stages.

**BIG EFFORT** (S. Price) - underwent a pre-race veterinary examination and passed fit to race. Laid out in the straight taking PORT VALE wider on the track from near the 200 metres.

**ARROW LANE** (J. Maund) - had its tongue-tie replaced at the start. Was contacted at the start.

**RACE 8: TERRY HOWE PRINTING HANDICAP - 1050 Metres (Cont'd)**

**THE CRUSHA** (T. Pannell) - was awkward to begin and as a consequence, rider became very unbalanced in the saddle for a number of strides. A post-race veterinary examination revealed speedy cuts to its near hind hock.

**PORT VALE** (O. Ridge) - was awkward to begin, shifted in and tightened LITTLE RICH BOY onto ARROW LANE, resulting in LITTLE RICH BOY being hampered at the start and contacting ARROW LANE. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty, Stewards had regard for the totality of the use of the whip by O. Ridge and noted that he used his whip on six occasions over the last 100 metres.

**ADELAD** (J. Toeroek) - rider reported the gelding travelled well in the early and middle stages, however, when placed under pressure at the entrance to the straight, failed to respond to his riding and in his opinion, had not handled today's track conditions.

**LITTLE RICH BOY** (J. Eaton) - was tightened and hampered at the start. Rider reported the gelding, in her opinion, did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

**RACE 9: DOMINANT HANDICAP - 1600 Metres**

**HERE COMES LENNI (NZ)** (T. Pannell) - raced keenly in the early stages of the event. Inclined to lay out in the straight.

**MASTERATI** (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

**EXTREME THRILL** (M. Collett) - rider reported the gelding never travelled in the run, was disappointing in its effort, however felt fine in its action during the event, but, on pulling up and on return to scale, the gelding felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

**MAGNETIC EDGE** (J. Maund) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HANKSTAR** - was a late scratching by order of Stewards at 4.28pm following a submission by Trainer Mr P. Nolan that the gelding would not be suited to race on a Soft 5 track condition, following the track downgrade at 4.26pm.

**ZOULAH** (B. Vorster) - laid in, in the straight.

**LOVE FROM LUCY** (S. Fawke) - was inclined to lay in, in the straight.

**GENERAL - Additional Report**

**MORPHETTVILLE - 28 NOVEMBER 2020 - Race 6**

Subsequent to permission being granted for BEEOKAY to race equipped with blinkers in this event, Stewards obtained gear declaration records from Racing Australia which indicated that the declaration of blinkers were made subsequent to acceptance time. Consequently, Trainer Mr G. Young was fined \$200 under AR206 for his late declaration of blinkers on BEEOKAY.
