**RACE 1: KINGSFORD HOTEL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1516 metres**

**CITY BEATS** (D. Tourneur) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**PEARL BANDIT** (R. Clark) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SMART ALICK** (E. Boyd) - hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**SAYEDDA** (J. Holder) - slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SILVER JEWEL** (C. Parish) - raced ungenerously in the early and middle stage of the event.

**RACE 2: COOPERS FOUR-YER-OLD & OVER CLASS TWO HANDICAP - 1516 metres**

**TROOPER'S PLOY** (R. Clark) - inclined to lay out under pressure from the entrance to the straight to the winning post

**RACE 3: THANKS FOR SUPPORTING 'GAWLER SUMMER SERIES' SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres**

**TATTIES** (R. Clark) - in the vicinity of the 800 metres had to be steadied and lost its position when LA VITA shifted in when insufficiently clear.

**RACE 3: THANKS FOR SUPPORTING 'GAWLER SUMMER SERIES' SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres (Cont'd)**

**DALAKHANI GIRL** (C. Parish) - slow to begin.

**HOUNSLOW RUNNER** (D. Caboche) - was held up for clear running from the entrance to the straight until until the winning post.

**ISLAND GAME** (A. Chan) - slow to begin.

**LA VITA** (A. Jordsjo) - in the vicinity of the 800 metres shifted in when insufficiently clear. Rider severely reprimanded. On pulling up LA VITA shied and dislodged its rider. A Jordsjo was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements. A post-race veterinary examination revealed no visible abnormalities.

**LAKHANI ROSE** (K. Crowther) - in the vicinity of the 800 metres was inconvenienced when taken wider on the track.

**RACE 4: 4 WAY FRESH PRODUCE / SABOIS PLUS MAIDEN / CLASS ONE PLATE - 2122 metres**

**FRANKED (GB)** (S. Cahill) - jumped away awkwardly and shifted out inconveniencing MANILOW. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**LOWS AND HIGHS** (S. Logan) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. First aid administered. Trainer Mr J. Frew was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**MANILOW** (J. Toeroek) - inconvenienced on jumping away when BIG TOP jumped away awkwardly and shifted in as FRANKED (GB) jumped away awkwardly and shifted out.

**BIG TOP** (R. Clark) - jumped - jumped away awkwardly and shifted in inconveniencing MANILOW.

Correct weight was delayed to allow J. Toeroek (MANILOW) second placegetter and joint Trainer Mr C. Binnie to view the head-on vision of the home straight.

**RACE 5: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1200 metres**

**ECLAIR FLAME (GB)** (T. Pannell) - jumped away awkwardly and shifted out inconveniencing SIR JOHNSON and LUNCH MONEY. Raced keenly in the early and middle stages of the event.

**FUTURE VALUE** (R. Hurdle) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SIR JOHNSON** (E. Finnegan) - on arrival at the barriers was found that the gelding had lost a near fore plate and had to be reshod. Underwent a pre-race veterinary examination and passed fit to race. Inconvenienced shortly after the start when ECLAIR FLAME jumped away awkwardly and shifted out and NOW AND FOREVER jumped away awkwardly and shifted in.

**CERTAIN SUCCESS** (E. Boyd) - inclined to hang out throughout the event. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer Mr J. Hickmott was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**LUNCH MONEY** (J. Toeroek) - inconvenienced shortly after the start when ECLAIR FLAME (GB) jumped away awkwardly and shifted out and NOW AND FOREVER jumped away awkwardly and shifted in.

**RACE 5: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)**

**NOW AND FOREVER** (J. Holder) - jumped away awkwardly and shifted in.

**STREKOZA** (R. Clark) - jumped away awkwardly and shifted in, inconveniencing SIR JOHNSON and LUNCH MONEY.

**RACE 6: 2019 K.I CUP CARNIVAL FEB 14 - 16 BENCHMARK 60 HANDICAP - 1100 metres**

**KNOTTED** (T. Pannell) - underwent a pre-race veterinary examination who reported the gelding to be lame in the off hind leg. Acting on this advice, Stewards withdrew KNOTTED at 2.05 pm.

**RUG RAT** (E. Finnegan) - underwent a pre-race veterinary examination who reported the gelding to be lame in the off foreleg. Acting on this advice, Stewards withdrew RUG RAT at 2.05 pm.

**CRYSTAL MOMENT** (K. Lau) - inclined to lay in throughout the event. Lost an off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7: GOLDIN FARMS - AKEED MOFEED CLASS TWO HANDICAP - 1200 metres**

**BIANCAPTAIN** (K. Lau) - stood flat footed and was very slow to begin. A post-race veterinary examination revealed the gelding to have a quartered inside heel on its near foreleg. First aid administered. Trainer advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. In the vicinity of the 250 metres rider accidentally dropped his whip.

**KEEMON** (E. Finnegan) - dislodged rider en route to the barriers and galloped for a short distance before being recaptured. Underwent a pre-race veterinary examination who ruled the gelding unfit to race. Acting on this advice, Stewards withdrew KEEMON at 4.46 pm.

**AZZURO BIANCO** (T. Pannell) - in the vicinity of the 1100 metres had to shift in and away from FAY'S JOY, which shifted in and as a result bumped CARLALUISA, which had its hindquarters turned.

**CARLALUISA** (R. Clark) - in the vicinity of the 1100 metres was bumped and had its hindquarters turned by AZZURO BIANCO, which shifted in and away from FAY'S JOY. In the vicinity of the 1000 metres had to be steadied and lost its position when FAY'S JOY shifted in when insufficiently clear.

**DATURA** (C. Parish) - from the entrance of the straight until inside the 200 metres was held up for clear running.

**FAY'S JOY** (S. Logan) - in the vicinity of the 1000 metres shifted in when insufficiently clear of CARLALUISA resulting in that filly having to be steadied and losing its position. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 26 January and to conclude at midnight on Wednesday, 30 January 2019: a period of three meetings.
