

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 23 March 2019

TRACK: Good 4

(Track with some give in it)

RAIL: Out 4 metres entire. Sectional 605 metres.

WEATHER: Fine

RACE 1: TAB HANDICAP - 1300 metres

EMBLEY (G. Cartwright) - raced keenly in the early stages of the event. Laid out in the straight.

GO THE JOURNEY (C. Jones) - raced keenly in the early stages of the event.

HANDSOME RETURN (NZ) (J. Holder) - rider reported the gelding travelled well in the early stages, however was disappointing over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: TABLE & CHAIR CO HANDICAP - 1250 metres

The start of this event was delayed approximately two minutes.

EXALTED TRAIL (T. Pannell) - rider was dislodged en route to the barriers. T. Pannell was examined by the First Care Medical Personnel and passed fit to ride. Laid out over the concluding stages of the event.

GOTTA BE GOLD (R. Clark) - a post-race veterinary examination revealed the filly to be lame in both fore feet. Co-Trainer Mr L. Macdonald was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

MAGNETIC ROSE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

HE WILL BOOM (G. Cartwright) - raced keenly in the middle stages of the event. Held up for clear running from approaching the 400 metres until approaching the 200 metres and was obliged to shift to the outside of IN HEART'S WAKE to obtain clear running.

RACE 3: WINNING EDGE PRESENTATIONS HANDICAP - 1000 metres

LI'L KONTRA (C. MacFarlane) - raced wide without cover for a short distance in the early stages of the event.

ANGASTON (R. Hurdle) - awkward to begin.

RACE 3: WINNING EDGE PRESENTATIONS HANDICAP - 1000 metres (Cont'd)

DEFIANT DANCER (T. Pannell) - near the entrance to the straight shifted out to improve taking the running of **CREAM TART**, which had to be steadied when hampered. Rider severely reprimanded for shifting ground when insufficiently clear.

ANEESA (J. Holder) - raced greenly in the straight. Rider reported his mount got its tongue over the bit. A post-race veterinary examination revealed poor respiratory recovery with injected oral mucus membranes. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

CREAM TART (M. Autier) - underwent a pre-race veterinary examination and passed fit to race. Difficult to load. Trainer Mr J. O'Connor was advised a warning would be placed on the filly. At the entrance to the straight had to be steadied when hampered by **DEFIANT DANCER**, which shifted ground when insufficiently clear. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE HANDICAP - 1250 metres

COLESBERG (S. Fawke) - shortly after the start became awkward on the heels of **WITH A BIT OF DASH** for a number of strides. Made the home turn awkwardly and shifted wider on the track.

GIRLS GOT SPIRIT (C. MacFarlane) - over-raced in the early and middle stages of the event.

EXALTED TRAVELLER (A. Jordsjo) - slow to begin. Laid in, in the straight.

APPOLLO JET (J. Potter) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

AMBIBELLA (G. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

BALLISTIC MISSILE (J. Holder) - laid out in the straight.

RACE 5: AAMI HANDICAP - 1000 metres

DOMINATION (J. Holder) - shortly after the start shifted in and inconvenienced **IDATWO**.

IDATWO (S. Price) - inconvenienced shortly after the start.

STREET LIFE (T. Pannell) - unable to obtain clear running from near the entrance to the straight until approaching the 200 metres. When questioned regarding his options in the straight, rider explained that he had been instructed to attempt to improve to the outside of other runners, however due to the formation of the field, he was unable to do so and was obliged to ride for luck. He added that he was reluctant to improve his position in the early part of the straight due to the positioning of **DOMINATION** and **EQUAL LOVE** resulting in **STREET LIFE** racing in restricted room until near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

ATLANTICA (O. Ridge) - over-raced in the early stages of the event and became awkward inside **EQUAL LOVE** approaching the 700 metres, was restrained and took cover behind **EQUAL LOVE**. Laid out throughout the event. Rounding the home turn laid out, shifted out and inconvenienced **WHITE KAPS**, which was taken wider. A post-race veterinary examination revealed no visible abnormalities.

EQUAL LOVE (G. Cartwright) - over-raced in the early stages of the event.

WHITE KAPS (C. MacFarlane) - inconvenienced when taken wider rounding the home turn.

RACE 6: HEINEKEN 3 HANIDCAP - 2250 metres

OLYMPIC ACADEMY (R. Clark) - laid in under pressure in the straight.

CHIVADAHLLI (S. Cahill) - had difficulty in obtaining clear ground for a short distance approaching the 400 metres. Rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and reprimanded. Rider also pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

AAGAS (C. MacFarlane) - jumped away awkwardly and shifted out contacting PRIMA (NZ). Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

PRIMA (NZ) (T. Pannell) - hampered on jumping away when contacted by AAGAS. Raced keenly in the middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr P. Stokes was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

EXALTED LIGHTNING (G. Cartwright) - Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

PAT THE WEAPON (A Jordsjo) - raced fiercely in the early stages and wide without cover throughout the event.

RACE 7: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1550 metres

KIFAHAH (J. Potter) - held up for clear running from the entrance to the straight until inside the 100 metres.

SIZZLING BULLET (D. Tourneur) - began awkwardly, shifted out and hampered MOGHUL EMPIRE.

ALL HARD WOOD (T. Pannell) - Trainer Mr R. Laming was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card for this horse. The horse was permitted to start as it was able to be identified from records held by Stewards. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

MOGHUL EMPIRE (J. Toeroek) - shifted out inside the 200 metres and brushed with FLOP.

ROSELLI STING (R. Hurdle) - over-raced in the early stages of the event. Held up for clear running from near the entrance to the straight until near the 100 metres.

DANOULI (S. Fawke) - difficult to load. Trainer Mr J. Hickmott was advised a warning had been placed on the gelding in relation to its loading manners. Over-raced in the early stages of the event.

PEWTER (J. Maund) - raced wide without cover throughout the event.

RACE 8: SCHWEPPE'S HANDICAP - 1400 metres

The start of this event was delayed approximately three minutes.

CAMPOBASSO (NZ) (J. Huxtable) - in the vicinity of the 800 metres raced ungenerously for a short distance. Laid in, in the straight.

GIGGLON (C. Jones) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Difficult to load. Trainer Mrs S. Jaensch was advised a warning had been placed on the gelding in relation to its loading manners.

RACE 8: SCHWEPPE'S HANDICAP - 1400 metres (Cont'd)

AUTUMN STREET (J. Toeroek) - over-raced in the early stages of the event.

CARLALUISA (R. Clark) - over-raced in the early stages of the event.

NIGHT QUEEN (D. Tourneur) - made the turn near the 1000 metres awkwardly and shifted wider on the track.

COSMIC ALERT (T. Pannell) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Difficult to load. Trainer Mr W. Clarken was advised a warning had been placed on the filly in relation to its loading manners.

ONCE IN A LIFETIME (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.
