### **SECTION 5: CONDITIONS OF LICENCE**

In the event of such Licence being granted, I agree-

- 1. To observe and be bound by the Australian Rules of Racing, the Local Rules and policies of Thoroughbred Racing SA Limited (collectively, the Rules) and the regulations and policies of any Registered Club in force from time to time during the currency of such licence.
- 2. To observe and be bound by such directions as may from time to time be made or given by the Committee, Stewards or officials of the Principal Racing Authority or any Registered Clubs.
- 3. That the Licence may be revoked at any time by the Principal Racing Authority without the giving of any reason in accordance with the Rules.
- 4. That neither the Principal Racing Authority nor any Registered Club gives any warranty as to the suitability and/or safety of the premises, track and training or other facilities owned or occupied by any Registered Club or other entity connected with thoroughbred horse racing, and that I must at all times satisfy myself as to the fact that such premises, track, training or other facilities are appropriate, fit for purpose and without obvious defect.
- 5. Not to make any public statement or comment concerning any matter currently the subject of investigation or hearing by, or before the Board of the Principal Racing Authority, the Stewards, a Committee or Appeals Tribunal or other body authorised by each.
- 6. Not without the permission of the Principal Racing Authority or the Stewards, to write articles about racing for publication or broadcast, nor to grant interviews about racing for publication or broadcast, except in respect of past events.

- 7. To attend tracks regularly for the purpose of riding trackwork and to make myself available at all times to ride in races and official trials under the Rules of Racing unless prevented from doing so upon reasonable and proper grounds.
- 8. Not to ride on any licensed racecourse or training facility whilst under the influence of alcohol or any drug or substance which may affect my ability, judgment or behaviour.
- 9. To provide any sample either prior to or subsequent to fulfilling any riding engagement in any race, official trial or trackwork for the purpose of detecting any substance banned under the Rules if directed to do so by the Stewards or other authorised person.
- 10. To (in the case of a female rider) not ride after the first trimester of a pregnancy and to only continue riding during the first trimester subject to fulfilling the conditions and requirements outlined in the Rules.
- That I shall not be exempted from personal liability arising under the Rules for or by any reason whatsoever.

GST: When the licensee is GST registered, the following agreement is given:

- The recipient may issue tax invoices in respect of the specified supplies
- The supplier will not issue tax invoices in respect to those supplies
- The supplier acknowledges that it is registered when it enters into the agreement and that it will notify
  the recipient if it ceases to be registered

The Principal Racing Authority will use that information to assess your application and, if registration is approved, your ongoing status as a licensed person. To do that the Principal Racing Authority may disclose your information to other racing bodies. You do not have to supply the information requested in this application, but if the information (or any part of it) is not provided, your application may be rejected. You can gain access, and request that corrections be made, to information held about you by the Principal Racing Authority. By completing and submitting this application, you authorise the Principal Racing Authority to collect, use and disclose information about you for the purposes described in this notice, including the usual publication of such information in race books, racing calendars and other publications that can include (but are not limited to) websites.

#### INTELLECTUAL PROPERTY
